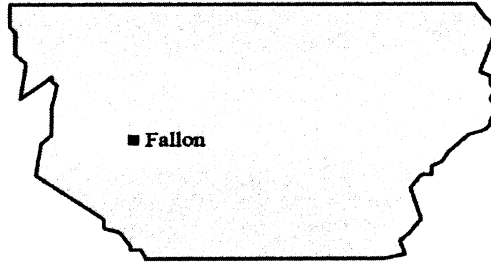

Rape Crisis Center

- Operates 24-hour hotline
- Community education and prevention programs
- Hospital Escort
- Average month seeing 75 rape exams being performed (range of 60-90 in 2007)
- Receive 6,000 hotline calls per year
- Operate support groups
- Referrals for individual counseling

Gaps in Services

- Approximately 30% of VOC application are denied
- Lack of bilingual counselors
- Affordable counseling
- Only two certified SANE nurses
- One SANE unit in operation

FACT (Family and Child Treatment)

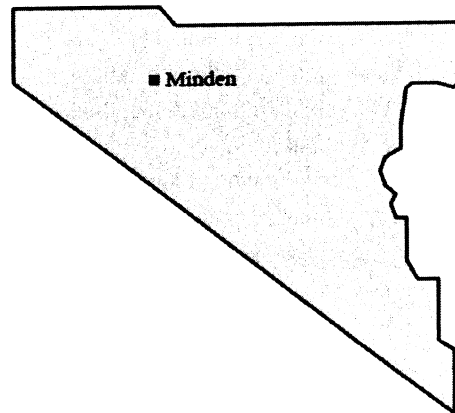
- Provides counseling for survivors of sexual assault and non-offending parents
- Prevention and awareness programs

- Typical waiting list of one month for services
- Lack of bilingual counselors
