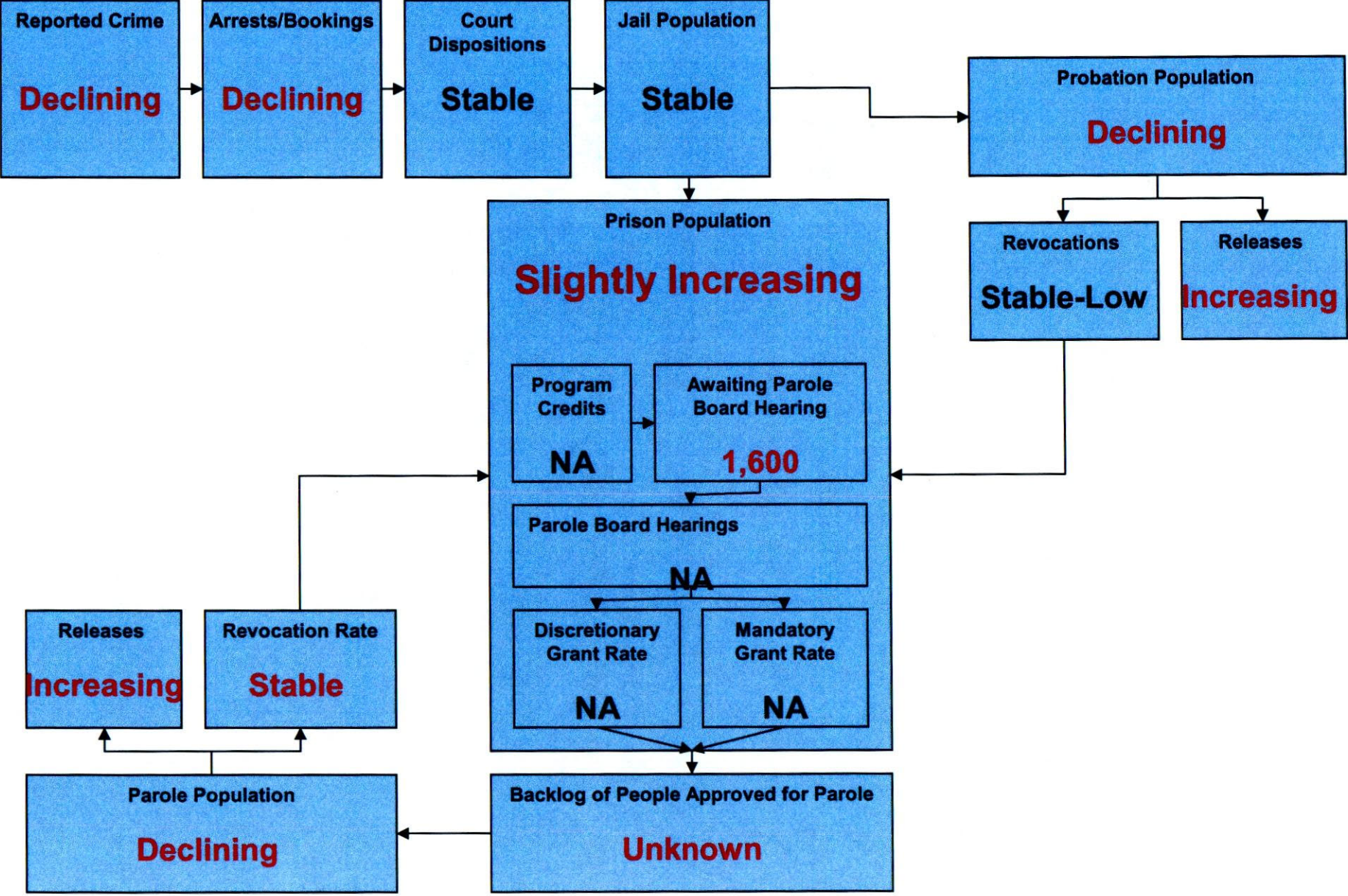

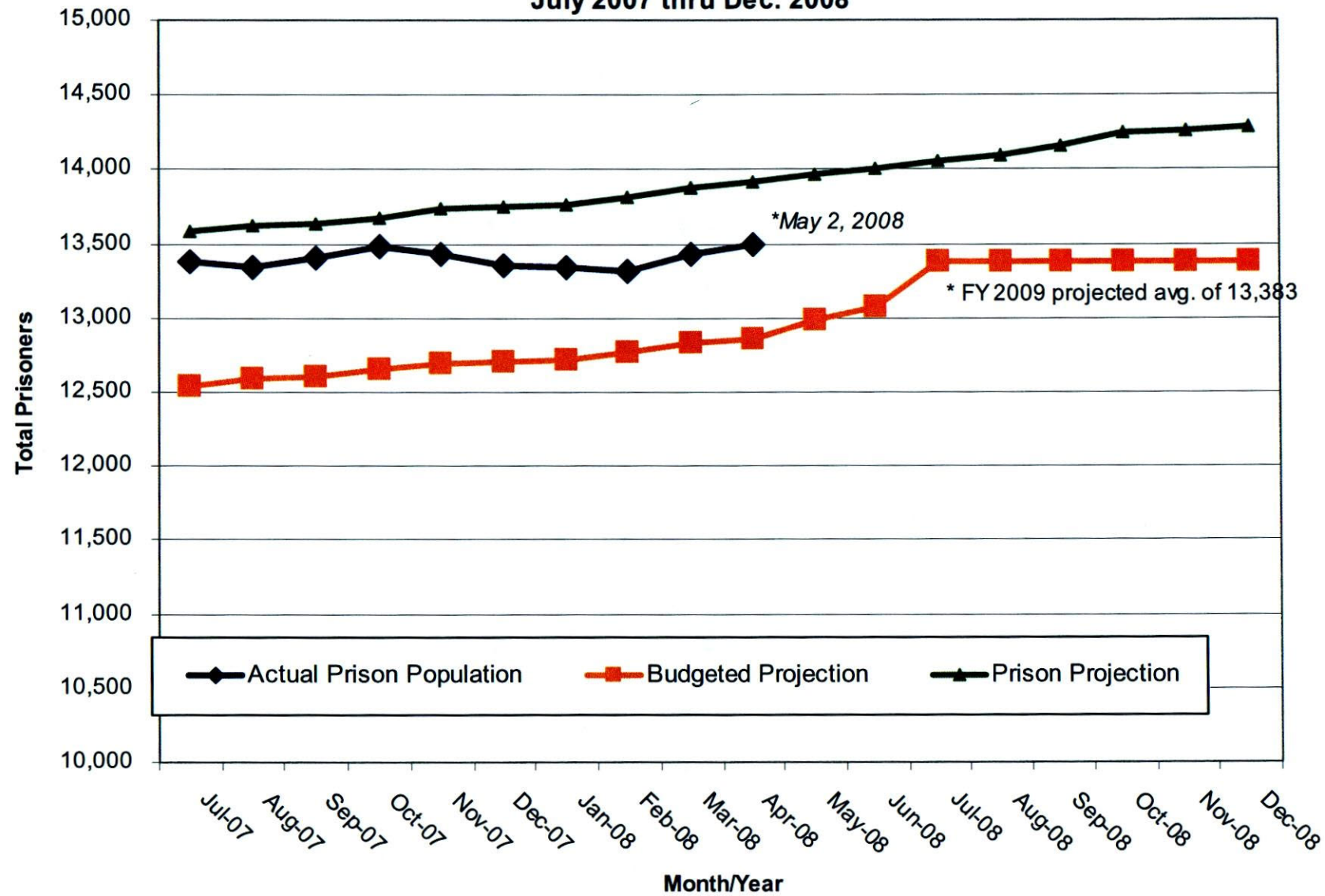
Review: 2007 Legislative and Administrative Reforms

- **AB 510**
 - Accelerates Parole Hearing Dates
 - Accelerates Parole Discharges
 - Accelerates Probation Discharges
 - Awards credits to prisoners completing risk reduction programs
- **Parole Risk Based Guidelines**
 - Increases grant rates for low risk prisoners
 - Increase grant rates for prisoners completing risk reduction programs
- **Probation and Parole Revocation Matrix**
 - Reduces returns to prison for technical violations
 - Reduces length of stay for technical violations

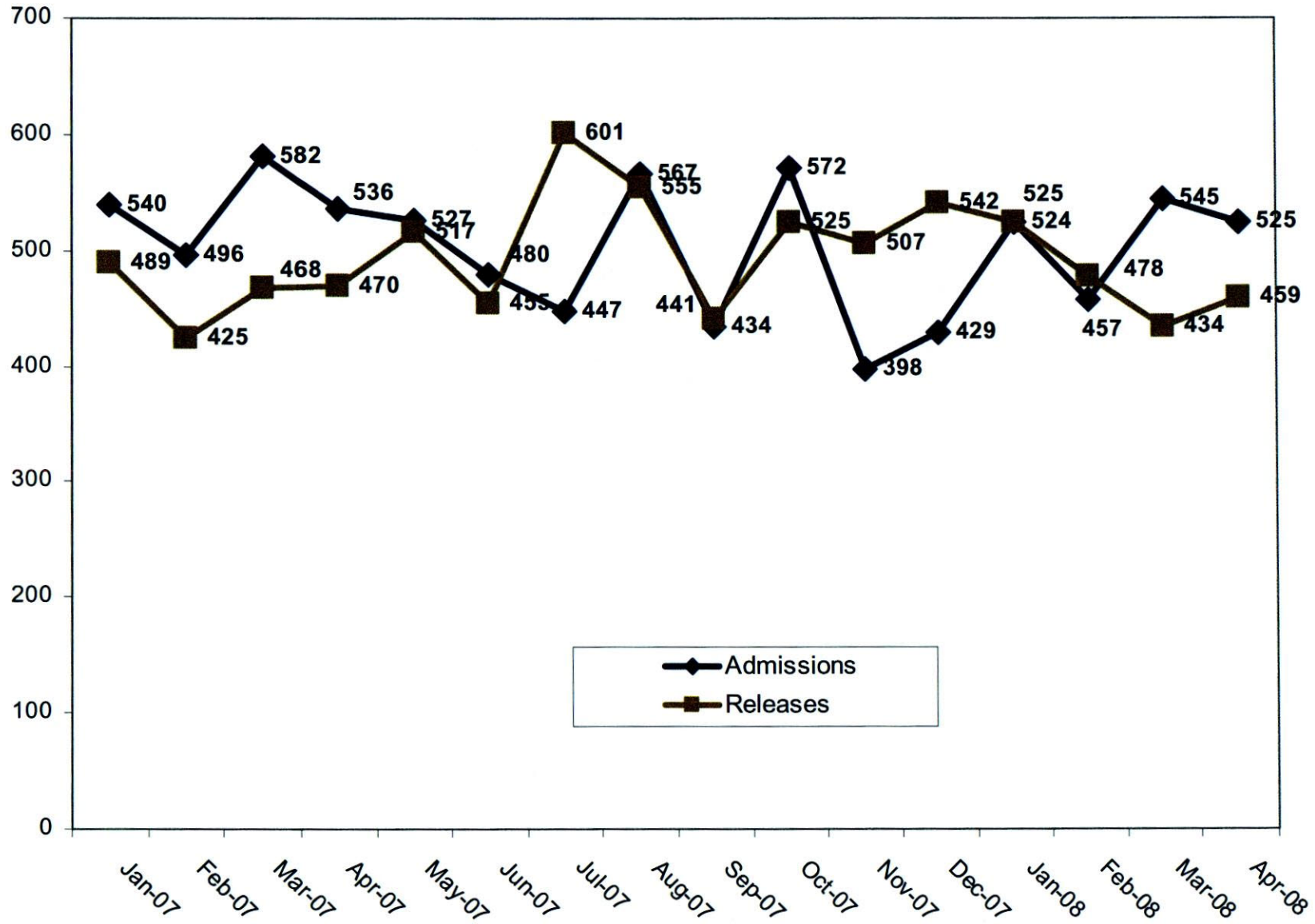
Nevada Key CJS Trends 2008



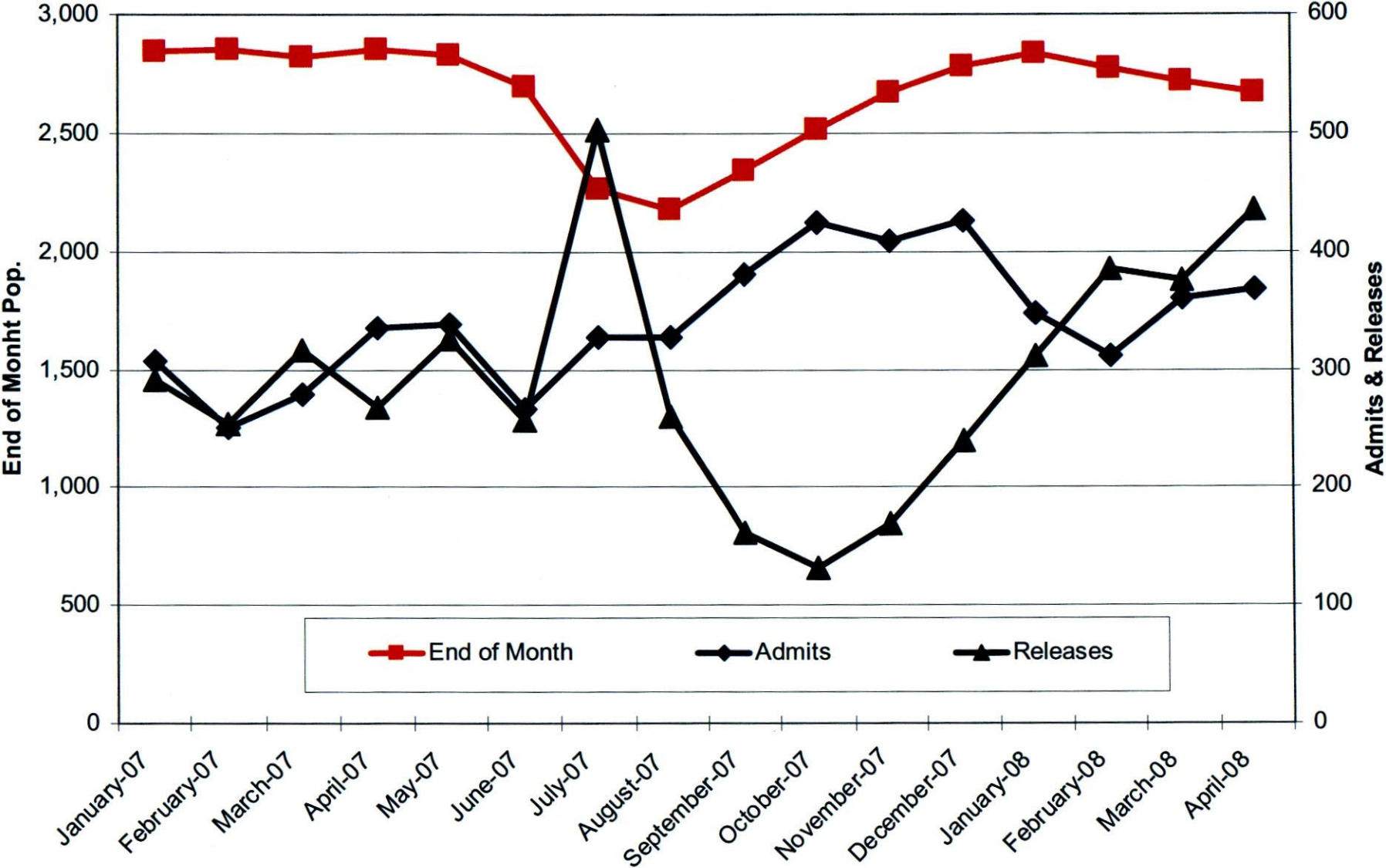
**Nevada End of Month Prison Population vs. Budgeted Projections:
July 2007 thru Dec. 2008**



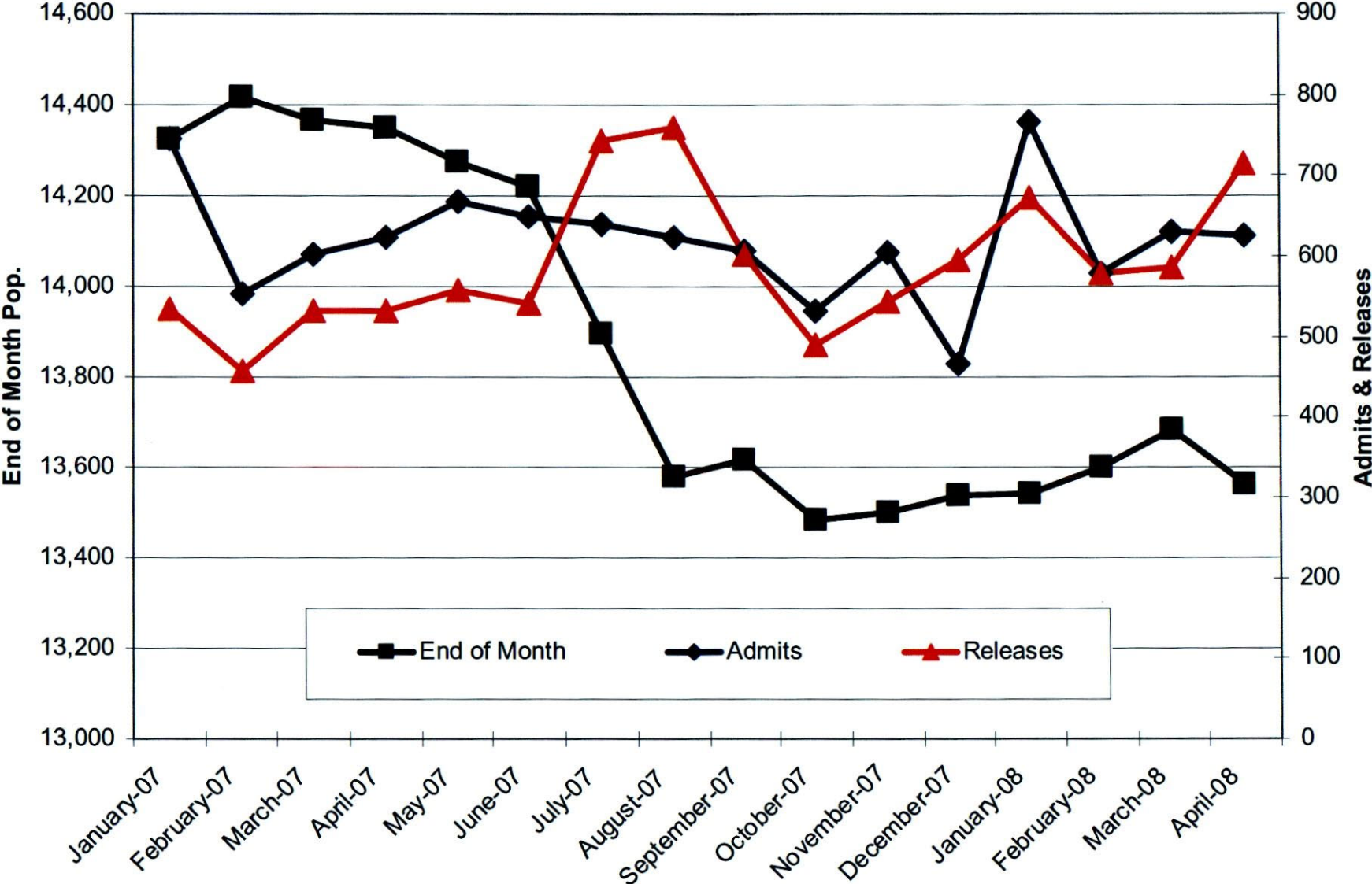
Nevada State Prison Admissions & Releases: Jan. 2007 - Apr. 2008



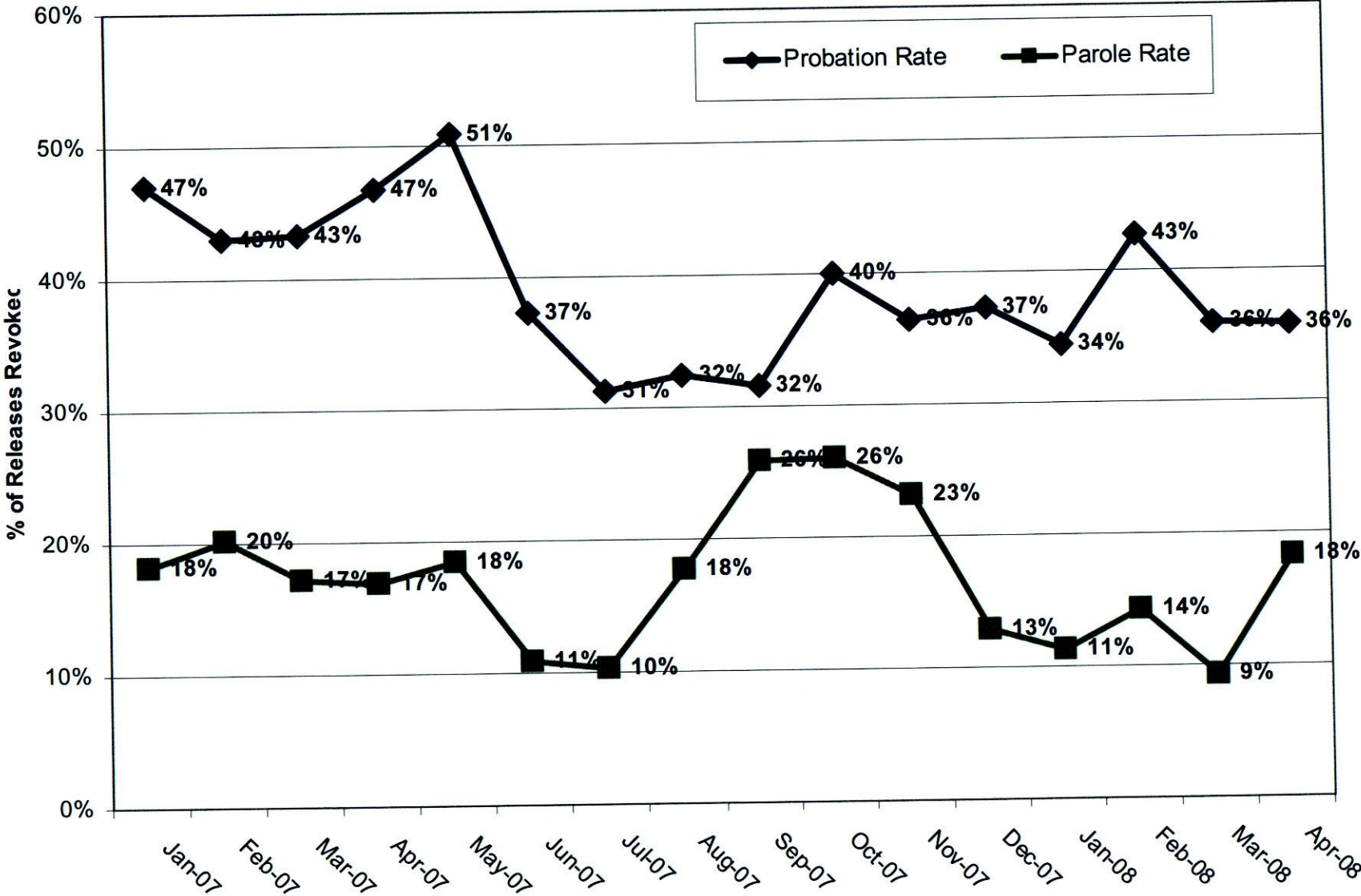
Nevada Parole Population Trends: Jan. 2007 - Apr. 2008



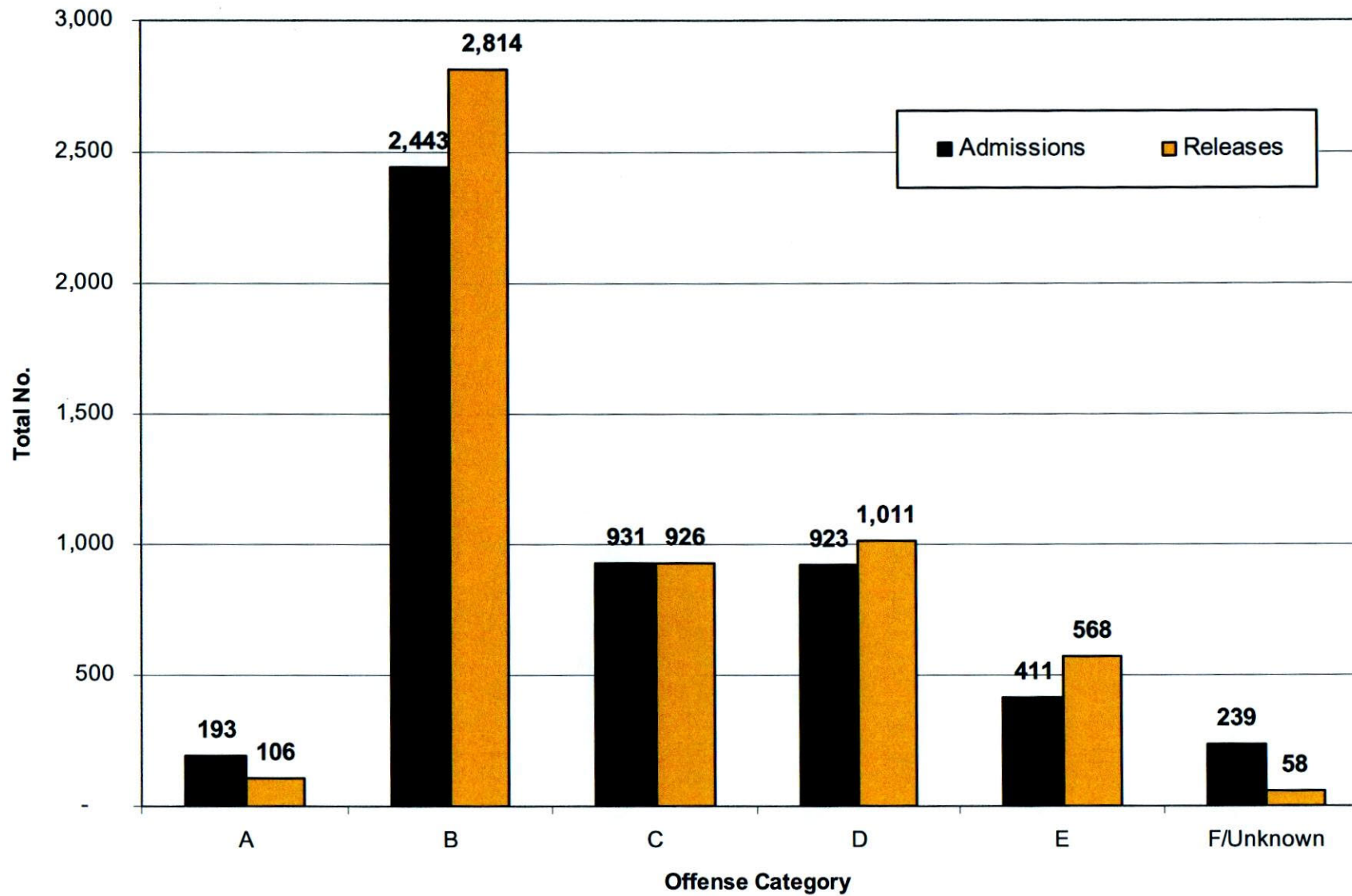
Probation Population Trends: Jan. 2007 - Apr. 2008



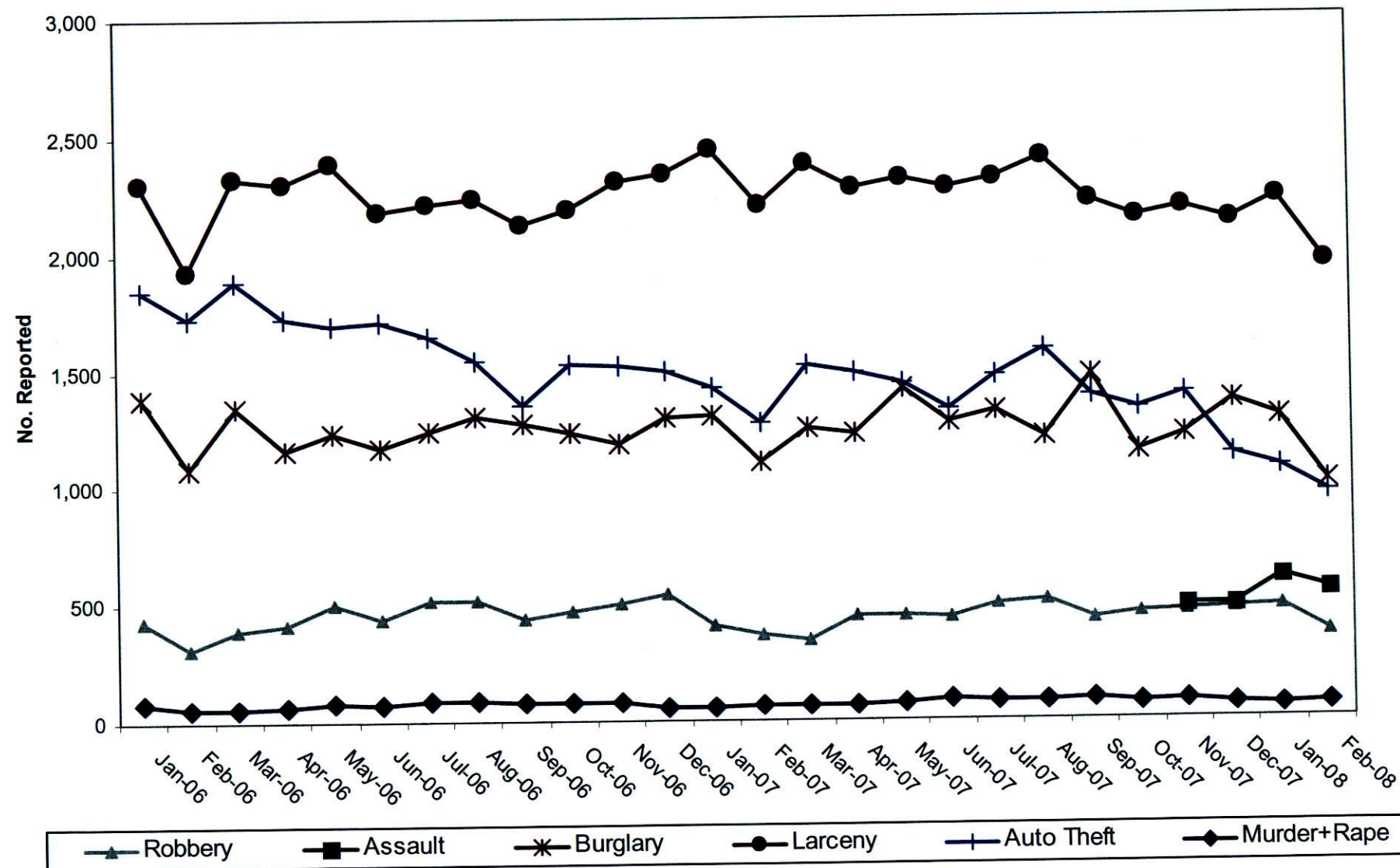
Parole & Probation Revocation Rates: Jan. 2007 - Apr. 2008



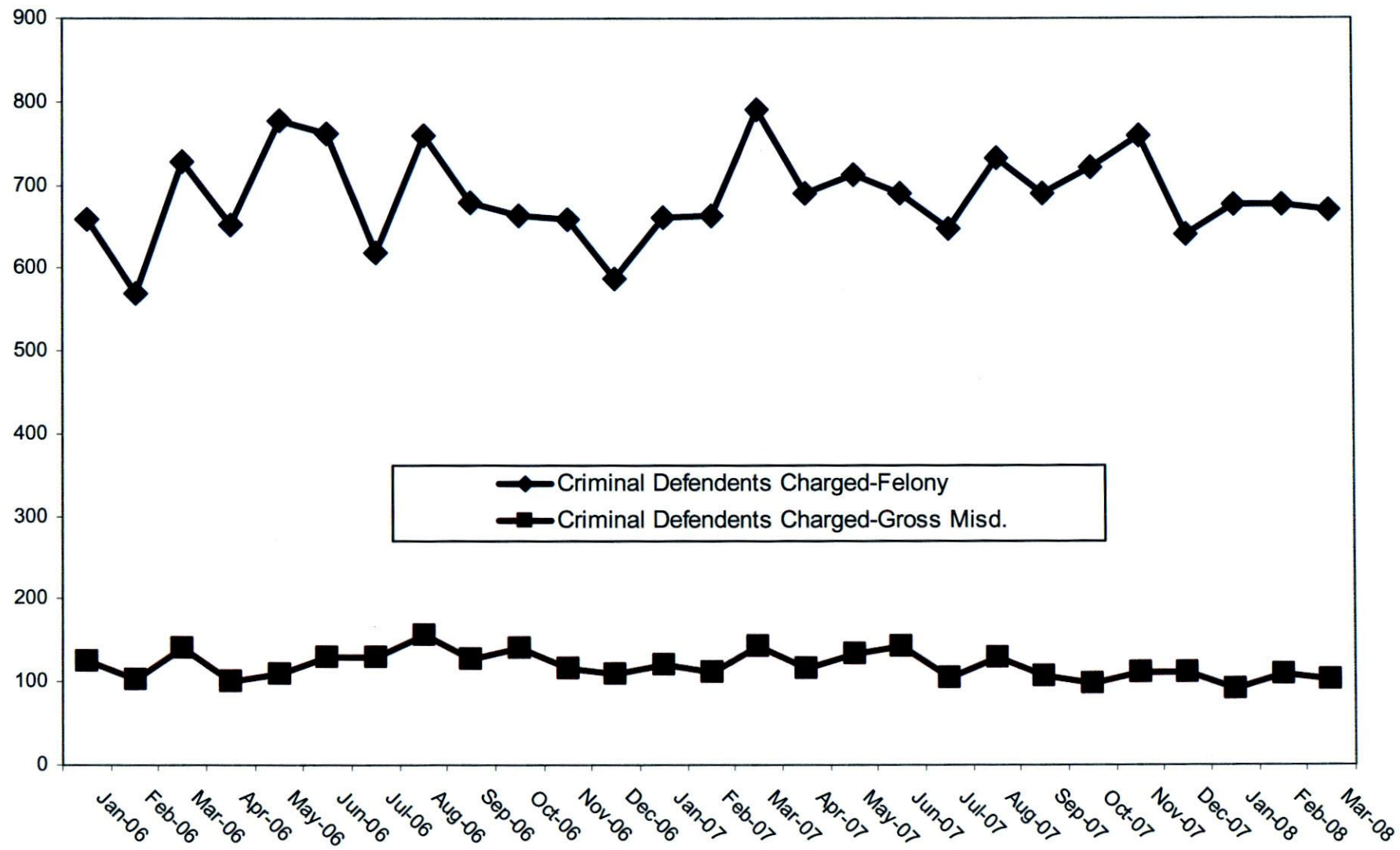
Admissions & Releases by Offense Category: June 1, 2007 thru April 30, 2008

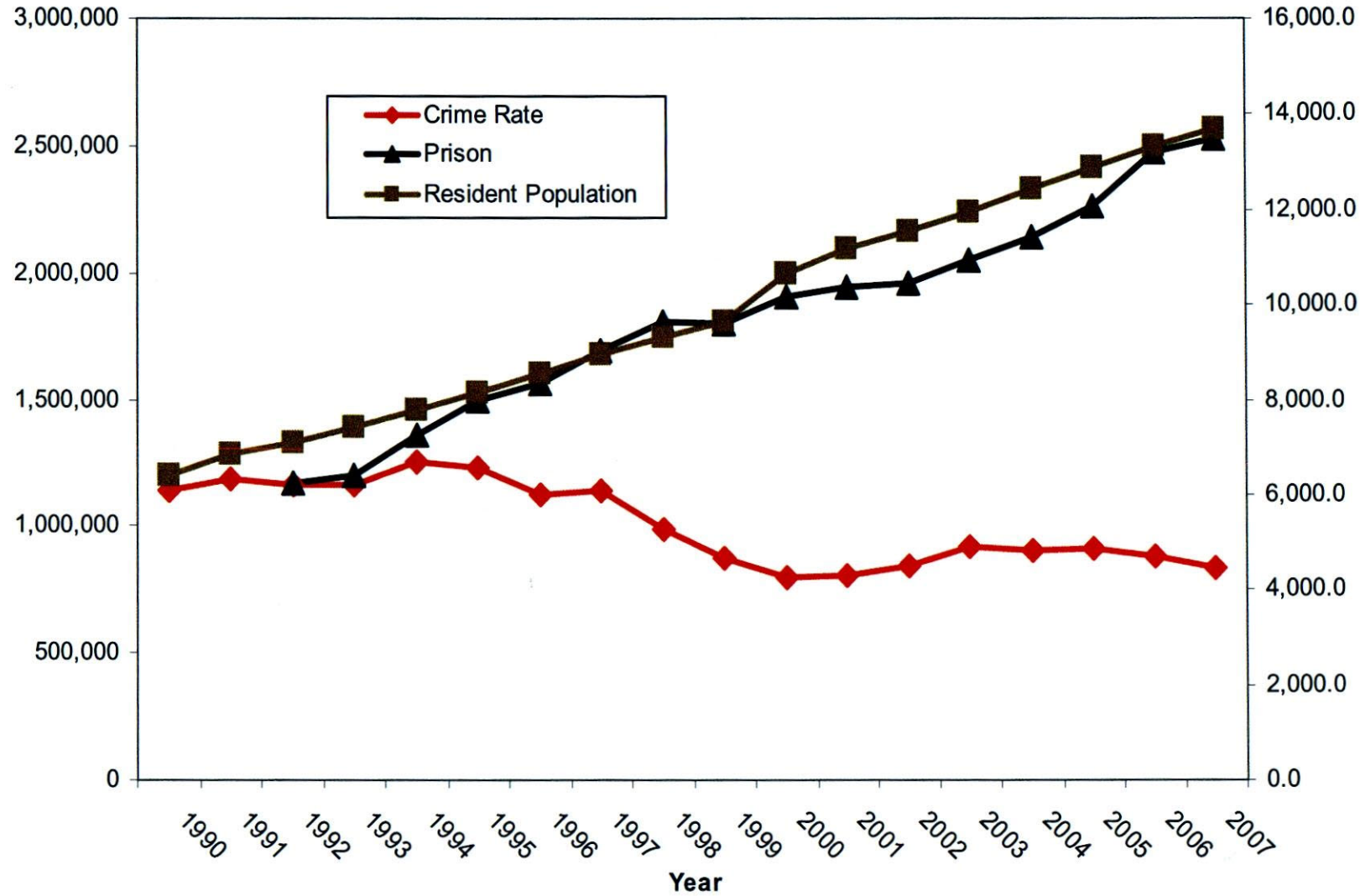
Update On TIS Study

- Need to get clear on deadlines for completion of major tasks and reports

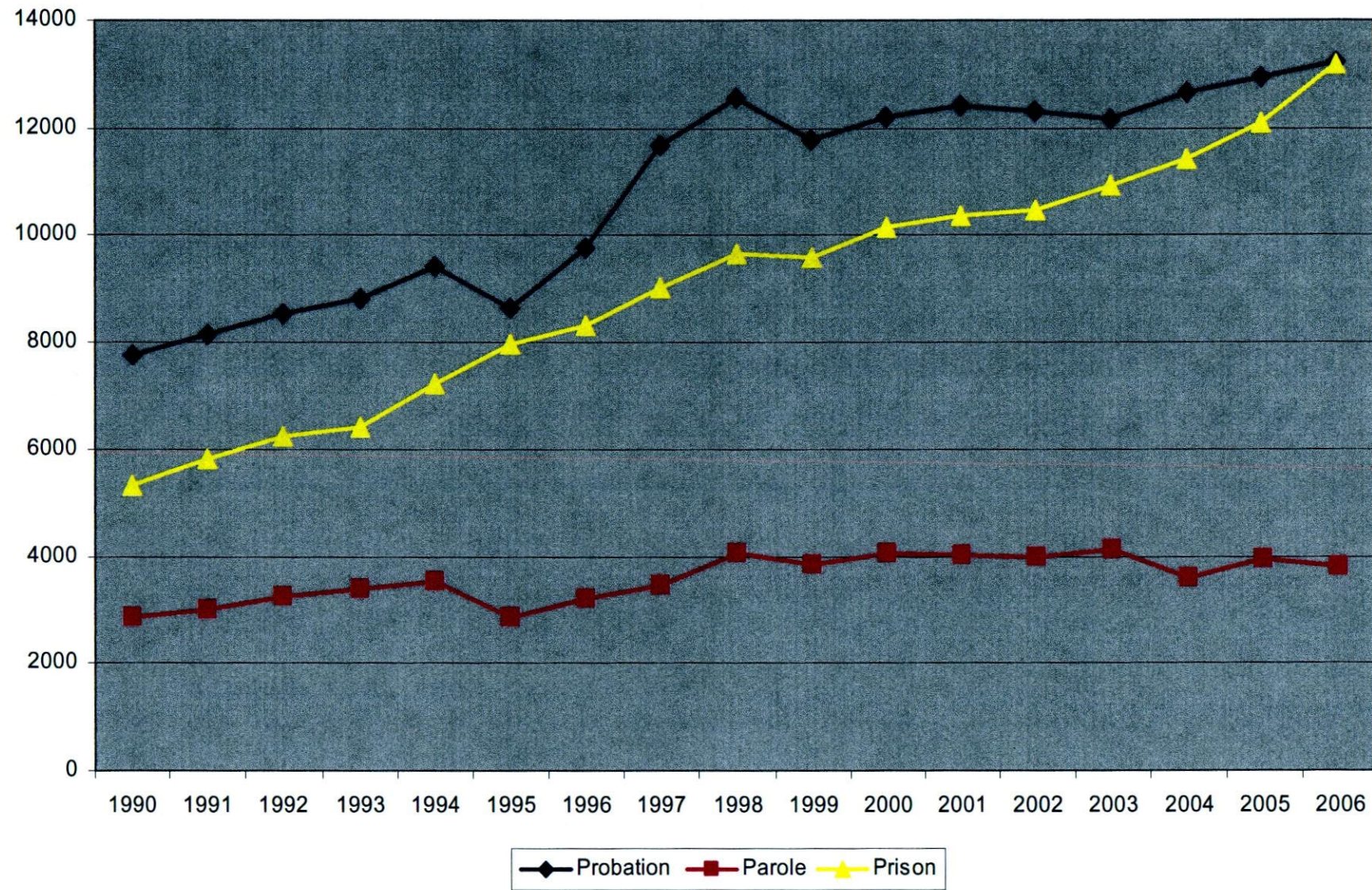
Historical Crime Rate, Prison Population & Resident Population: 1990-2007
