The Honorable Ben F. Tennille

The Honorable Ben F. Tennille, North Carolina Business Court, was appointed the first Special Superior Court Judge for Complex Business Cases in the Greensboro Business Court established in 1996, which was the first statewide business court in the nation. He has presided over the growth and development of the North Carolina Business Court, which has served as a model for many other states in the attempt to create a more business-friendly judicial system. With the addition of business court judges in 2006, Judge Tennille is now the Chief Special Superior Court Judge for Complex Business Cases, in the Business Court, now located in the Elon University School of Law, Greensboro, North Carolina.

In 2002, Judge Tennille was appointed to the sixteen member ABA Presidential Task Force on Corporate Responsibility and serves as Judicial Division Liaison to the Business Law Section of the ABA. He is also Co-Chair of the Judges Initiative Committee of the Business Law Section and serves on the Business Courts Committee and the Business Law Section Institutes and Seminars Board.
