What We've Accomplished

In 2007



- ✓ Pay raise of 3.5%
- ✓ Increased end strength
- ✓ Increased retirement point credit
- Stopped DOD attempts to increase TRICARE fees, copayments, and deductibles
- ✓ Many Guard Empowerment provisions
- Repeal of Insurrection Act changes
- ✓ Increased VA care, up to 5 years
- ✓ Just to name a few!



What We've Accomplished

In 2006



- ✓ TRICARE Reserve Select at one rate (28%) for ALL Guard members
- ✓ Maintained Army and Air Guard end strengths despite DOD push for reductions
- ✓ Restricting pay day lenders to 36% interest on loans
- Stopped DOD attempts to increase TRICARE fees, co-payments, and deductibles
- Stopped DOD attempt to mandate use of mail order pharmacy for all medications
- ✓ Federal retirement credit for state active duty for four counties in NJ after 9/1/2001
