

The Medical Marijuana Program

- Patient Cardholder Registry
- Cardholder/Caregiver Registry: enables approved individuals to enroll in the medical marijuana program
- Medical Marijuana Establishments
- Establishment Program: certifies, inspects, audits, coordinates and guides the MM establishments



Patient Cardholder Registry




Nevada MM Patient Demographics February, 2016

- Patients 65 and older with cards: 2,875




Patient Card Count 2014-Current

Division Fees for a MM Card

- Purchase an application packet: \$25.00
- Have an application processed: \$75.00
- Have DMV print the card: \$13.25
- Total cost



\$113.25



New Online Cardholder Registry

- Now Allows Applicants to
 - Register and create their profile
 - Scan and upload their driver's license
 - Download and print the medical marijuana card application
 - Save a lot of back-and-forth mail time



New Online Cardholder Registry

- Will Soon Allow Applicants to
 - Make registration or renewal payments online
 - Upload application documents
 - Check on the status of their card application
 - Renew online
 - View history of their dispensary purchases


