# OVERVIEW OF ACTIVE PLATE COUNTS, REVENUE GENERATED, AND APPROVED PLATES AWAITING PRODUCTION

- Jennifer Ruedy, Senior Research Analyst, Research Division, reviewed the license plates that are awaiting approval, revenue generated, and active license plate counts (Exhibit B).
- Ms. Ruedy reported that the Lake Tahoe and the Las Vegas Commemorative special plates are collecting the most revenue. Of the 19 special license plates that have been approved, 6 have not been produced yet. The Atomic Testing special plate is still awaiting design approval.

# REPORT ON THE STATUS OF THE DIGITIZED TECHNOLOGY FOR THE PRODUCTION OF LICENSE PLATES

- Ginny Lewis, Director, Department of Motor Vehicles, testified regarding the status of digitized technology for the production of license plates. She commented the Request for Proposal went out November 2003. The Evaluation Committee selected 3M Corporation for the contract.
- Bob Ostrovsky, 3M Corporation, Las Vegas, Nevada, explained the tag plant will have sufficient space for the equipment required to produce the license plates.

# **Hot August Nights**

• David D. Saville, Hot August Nights, Inc., Sparks, Nevada, stated the funds collected for the Hot August Nights special license plate will benefit high school children in the Reno, Nevada, area (Exhibit C1).

# **Nevada Airport Managers Association**

Raymond "Skip" Lawrence Polak, President, Nevada Airport Managers Association, Reno, explained that membership in the Nevada Airport Managers Association is voluntary. He explained the funds collected for the Nevada Airport Managers special license plate will be used to educate the general public regarding airports and build airports in Nevada. # **Reno Air Race Foundation**

Susan L. Fisher, Fisher Consulting, LLC, National Championship Air Races, Reno Air Race Foundation, and Tom Gribben, Vice Chairman of the Board, Reno Air Race Foundation introduced other members present at this meeting who represent the Reno Air Race Foundation which included: Tom Robinson, Chairman of the Board, National Championship Air Races; and Michael J. Houghton, CEO, National Championship Air Races. Ms. Fisher presented a copy of the proposed Reno Air Race Foundation special license plate to the commission members (Exhibit C3).
