OPENING REMARKS

Chairman Rhoads opened the meeting and asked the Committee and staff to introduce themselves.

APPROVAL OF THE "SUMMARY MINUTES AND ACTION REPORT" OF THE MEETING HELD ON JANUARY 22, 2004, IN CALIENTE, NEVADA

The Committee **APPROVED THE FOLLOWING ACTION**:

ASSEMBLYMAN MARVEL MOVED TO APPROVE THE "SUMMARY MINUTES AND ACTION REPORT" OF THE JANUARY 22, 2004, MEETING HELD IN CALIENTE, NEVADA. THE MOTION WAS SECONDED BY ASSEMBLYMAN CLABORN AND PASSED UNANIMOUSLY.

REPORTS TO COMMITTEE

Update of Public Lands Issues in Washoe County and Western Nevada

Review of Public Lands and Natural Resource Issues in Washoe County

- Jim Shaw, Chairman, Board of County Commissioners, Washoe County, Reno, discussed three important strategies relevant to Washoe County's management of its natural resources and public lands: (1) economic benefits; (2) leverage funding; and (3) partnerships. Please see Exhibit B.
- Michelle Poché, Assistant County Manger, Washoe County, Reno, testified about balancing access to public lands while protecting significant resources. Ms. Poché indicated that the county is interested in acquiring select parcels for preservation and recreational access through the use of funding from state and local bonds as well as the Southern Nevada Public Lands Management Act (SNPLMA). Please see Exhibit B.

Update of Bureau of Land Management (BLM) Planning Efforts in the Carson City Field District

- Elayn Briggs, Acting Carson City Field Manager, BLM, United States Department of the Interior (DOI), Carson City, Nevada, reported on the following projects of the Carson City Field District: (1) Churchill County's resource management plan amendment; (2) proposed interbasin water transfers; (3) Sand Mountain recreation area; (4) the Denton Rawhide mine closure and its possible transformation into a municipal landfill; (5) the Yerington abandoned copper mine; and (6) wild horse gathers. Please see Exhibit C.
 - Chairman Rhoads directed staff to confirm the approving authority for such land uses as landfills.

Update of National Forest Issues on the Sierra Front

- Robert L. Vaught, Forest Supervisor, Humboldt-Toiyabe National Forest, U.S. Forest Service (USFS), United States Department of Agriculture (USDA), Sparks, Nevada, reported on the management of approximately three-quarters of a million acres of national forest land in the eastern Sierra Nevada mountain range and western Nevada, calling particular attention to efforts to reduce hazardous fuels on national forest lands as required by the Healthy Forests Restoration Act of 2003.
- David Loomis, Sierra Zone Planner, Carson Ranger District, Humboldt-Toiyabe National Forest, USFS, USDA, Carson City, testified about management actions and high-priority issues for the District such as: (1) fire and fuels; (2) invasive species; (3) loss of open space; and (4) unmanaged recreation. Please see Exhibit D.
- Kathleen Lucich, District Ranger, Bridgeport Ranger District, Humboldt-Toiyabe National Forest, USFS, USDA, Bridgeport, California, reported on the following issues the Bridgeport Ranger District is addressing: (1) fire and fuels; (2) grazing analysis; (3) mining; (4) Rosaschi Ranch restoration; (5) sensitive species; and (6) unmanaged off-highway vehicles. Please see Exhibit E.

Overview of Programs and Activities of the Truckee Meadows Water Authority (TMWA)

- Lori Williams, General Manager, TMWA, Reno, reported that TMWA's presentation complies with Senate Bill 216 (Chapter 408, *Statutes of Nevada 2003*), which, among other things, requires the Legislative Committee on Public Lands to review the programs and activities of all public water authorities in the State of Nevada. Ms. Williams testified about the formation of TMWA and its Board, and she addressed the various acquisitions of the Authority such as: (1) distribution systems; (2) groundwater rights; (3) hydroelectric plants; (4) storage rights; and (5) treatment plants. She noted that \$452 million in bonds were issued to finance the acquisitions.
- John Erwin, Director of Resource Planning and Development, TMWA, Reno, addressed technical data

relative to TMWA's operations, which include: (1) monitoring conservation compliance; (2) drought planning; (3) analysis of water resources; (4) evaluating water flow through the Truckee River system; (5) assessing water quality; (6) maintaining distribution systems; and (7) evaluating water use statistics. Please see Exhibit F.

• Steve Walker, Contract Lobbyist, TMWA, Minden, Nevada, noted that during a drought, a ratepayer typically uses less water. Please see the chart in Exhibit F titled "Gallons per Capita per Day."

Review of Activities and Programs of the Nevada Fire Safe Council

- Elwood Miller, Professor of Forestry-Emeritus, University of Nevada, Reno (UNR), provided an overview and presentation about the Nevada Fire Safe Council, noting it was formed in 1999 by 120 Nevadans representing local fire services, federal and state fire suppression officials, developers, the insurance industry, and individual citizens. Its mission is to assist at-risk communities by reducing the threat of fire and increasing protection. Please see Exhibit G and Exhibit H.
- Ed Smith, Natural Resource Management Specialist, UNR Cooperative Extension, Minden, reported on a program created by the UNR Cooperative Extension titled "Living With Fire," which educates property owners about reducing the risk of catastrophic fires in their communities. Please see Exhibit H and Exhibit I.

Overview of Activities and Programs of Nevada's Division of State Lands

• Pamela B. Wilcox, Administrator, Nevada's Division of State Lands, State Department of Conservation and Natural Resources (SDCNR), Carson City, reported on the Division's activities and programs. She testified its lands planning program works on federal land issues to enhance cooperation between federal agencies and local governments.

Status Report on the Southern Nevada Public Land Management Act of 1998

- Robert V. Abbey, State Director, BLM, Nevada, Reno, testified that the SNPLMA provides for an orderly disposal of federal lands in Clark County to meet the demands for community expansion and development while using the proceeds from the sale of those lands to address critical environmental issues in the county and other areas in the state. Mr. Abbey reported that Nevada leads the nation in growth and that Clark County anticipates opening 14 new schools during 2004. He added that Nevada's taxpayers benefit from the sale of public lands, the funds from which are often used for recreation purposes and schools. Mr. Abbey explained that local governments can acquire public lands for new schools and other similar facilities under the Recreation and Public Purposes Act for as little as \$5 per acre. This compares to \$200,000 to \$300,000 per acre for private property in the Las Vegas Valley. Please see Exhibit J.
- Pamela B. Wilcox, Administrator, Nevada's Division of State Lands, SDCNR, Carson City, stated that Nevada's Division of State Lands participated in the original working groups that developed the SNPLMA legislation, and she reported on rural county issues and socioeconomic data relative to the SNPLMA.

Discussion of Certain Scientific Research and Findings Relating to Rangeland Health and the Potential Harvesting of Pinion Juniper in Nevada

- Barry Perryman, Rangeland Ecologist, Department of Animal Biotechnology, UNR, Reno, presented scientific data regarding the ecological consequences of not managing the state's natural resources. Please see Exhibit K.
- Sherman Swanson, Ph.D., Associate Professor, Department of Environmental and Resource Sciences, UNR, Reno, testified about range management to achieve sustainable rangelands. Please see Exhibit L.
- William Morrill, Science Coordinator, Eastern Nevada Landscape Coalition, Verdi, Nevada, reported on the Eastern Nevada Landscape Coalition's restoration project. His presentation focused on three general

problem areas: (1) different vegetative types through successional processes are being dominated by woody plants such as pinion and juniper; (2) invasive plants are changing vegetation; and (3) catastrophic fires threaten human and vegetative communities. Please see Exhibit M.

Discussion of USFS Policies and Procedures Regarding the Monitoring and Use of Grazing Allotments

- Robert L. Vaught, Forest Supervisor, Humboldt-Toiyabe National Forest, USFS, USDA, Sparks, addressed the concerns of ranchers that monitoring trends and use of grazing allotments are based on a small percentage of acreage rather than using key areas as the USFS plan stipulates. Mr. Vaught noted that each spring permittees and the USFS range monitoring staff reach written agreement for managing each permittee's summer allotment. He said if the permittee cannot reach agreement there are procedures to follow, but if concerns remain, Mr. Vaught requested that he be notified.
- Mike Lattin, Lattin Livestock LLC, Elko, Nevada, testified about his difficulties with the USFS administration practices regarding grazing permits. He expressed concern for the future of the ranching industry in Nevada unless the USFS's approach to grazing monitoring changes. Mr. Lattin proposed the formation of a five-member review board to work with the USFS and permitees in preventing and resolving conflicts. Please see Exhibit O.
- Al Steninger, Range and Ranch Management Consultant, Elko, focused his testimony on the accountability of the USFS's policies and procedures regarding monitoring and use of grazing allotments. Mr. Steninger also advocated the use of a local board that would better serve the forest service, its employees, and the permitees for impartial review of decisions and conflicts. Please see Exhibit O.
- Quinton J. Barr, Range and Ranch Management Consultant, Western Range Service, Elko, focused his testimony on utilization standards and the misuse of terms and definitions in the forest management plan by the USFS staff in district offices. Please see Exhibit N and Exhibit O.
 - o Chairman Rhoads requested that Mr. Vaught review the issues raised by Messrs. Lattin, Steninger, and Barr and report at the next meeting of the Legislative Committee on Public Lands, which is scheduled for Thursday, May 6, 2004, in Lovelock, Nevada. Senator Rhoads also requested that Messrs. Lattin, Steninger, and Barr be in attendance at the May 6 meeting.

Review of Activities and Operations of the Washoe County Department of Water Resources

• Steve Bradhurst, Director, Washoe County Department of Water Resources, Reno, reported on the responsibilities of various organizations in the Truckee Meadows that provide water services. Mr. Bradhurst also provided an overview of the duties of Washoe County's Department of Water Resources. Please see Exhibit P1, Exhibit P2, and Exhibit P3.

Overview of the Programs and Activities of the Washoe County Regional Water Planning Commission

• Susan Lynn, Chairman, Washoe County Regional Water Planning Commission (RWPC), Reno, reported on regional water planning issues and the responsibilities of the RWPC as addressed in Chapter 540A of NRS ("Regional Planning and Management") such as: (1) flooding; (2) storm drainage; (3) wastewater; (4) water quality; and (5) watershed management. Please see Exhibit Q.

Overview of General Water Issues in Western Nevada

• R. Michael Turnipseed, P.E., Director, SDCNR, Carson City, reported on general water issues in western Nevada relating to domestic wells, the proposed Gerlach coal-fired power plant, Honey Lake Valley, stockwater, Walker River negotiations, and workshops to address complaints regarding the lowering of the water table.

Discussion of the Activities of the Legislative Committee on Public Lands in Washington, D.C., Occurring

During Its Informational Tour Conducted on February 25 and 26, 2004

• Senator Rhoads provided a brief report on the Committee's Washington, D.C., informational tour conducted on February 25 and 26, 2004, and noted that Kathleen Clark, Director, BLM, offered to participate in a conference call with the Committee to discuss issues of concern.

PUBLIC COMMENTS

- Floyd W. Rathbun, Certified Range Management Consultant, Fallon, Nevada, expressed concern regarding potential impacts to local economies if domestic sheep grazing is eliminated on BLM and USFS lands. He requested that the Committee support the removal of the Sierra Nevada Bighorn Sheep from the endangered species list, as well as support encouraging the USFS and the U.S. Fish and Wildlife Service to document the detrimental economic effects on Mono County, California, and Lyon County, Nevada, if domestic sheep grazing is not allowed on public lands. Mr. Rathbun also asked for the Committee's support in encouraging the Division of State Lands to incorporate material from the Local Environment and Resource Network into Nevada counties' revised public land use plans. Please see Exhibit R.
- O.Q. Chris Johnson, Chairman of the Nevada Committee for Full Statehood, Elko, addressed water issues in the western states and his concerns over publicly-held lands in Nevada. Please see Exhibit S.
- David K. Schumann, Vice Chairman, the Nevada Committee for Full Statehood, Sparks, testified about his concerns over federally-owned lands in Nevada. Please see Exhibit T.
- Jo Simpson, Chief, Office of Communications, Nevada Office, BLM, USDOI, Reno, commented about stockwater rights relative to Mr. Turnipseed's testimony.
