OPENING REMARKS

Chairman Rhoads opened the meeting with Committee and staff introductions.

REPORTS TO COMMITTEE

Update of Public Lands Issues in Clark County and Southern Nevada

Review of Air Quality Issues in Clark County

• John Koswan, Assistant Planning Manager, Clark County Department of Air Quality and Environmental Management, Las Vegas, testified about the status of Clark County's implementation plans for carbon monoxide and PM₁₀ particulate reductions. Please see Exhibit B1 and Exhibit B2.

Update of Bureau of Land Management (BLM) Activities and Planning Efforts in the Las Vegas Field District

• Mark Morse, Las Vegas Field Manager, BLM, United States Department of the Interior (DOI), Las Vegas, focused his testimony on the management of off-highway vehicles (OHV) on BLM lands in Clark County. Mr. Morse also provided an update on the Clark County shooting range, BLM land sales through the Southern Nevada Public Lands Management Act (SNPLMA), and the status of a burro containment fence in the Red Rock National Conservation Area (NRA).

Update of National Forest Issues and Activities in Southern Nevada

• Steve Holdsambeck, District Ranger, Spring Mountains National Recreation Area, U.S. Forest Service (USFS), United States Department of Agriculture (USDA), Las Vegas, discussed the following challenges to the Spring Mountain NRA: (1) impact of over one million visitors each year; (2) fire and fuels management; (3) invasive species; (4) unmanaged recreation; (5) open space; (6) the SNPLMA; and (7) conservation initiatives. Overview of Programs and Activities of the Southern Nevada Water Authority (SNWA)

- Kay Brothers, Deputy General Manager, Engineering/Operations, SNWA, Las Vegas, provided a briefing on the following areas: (1) water resources; (2) the drought and conservation efforts; (2) SNWA's 2004 water resource plan; (3) in-state resources; (4) past legislation relative to the status of the quarter cent sales tax and groundwater management; and (5) the integrated water planning process. Please see Exhibit D2.
 - Senator Amodei requested that SNWA provide to the Committee the list of consultants and contracts that was referenced at the Authority's April 2004 meeting.
 - o Senator Amodei requested that a copy of the executed contract and billing invoices between SNWA and Joele Frank, Wilkinson Brimmer Katcher be provided to the Committee.

Review of Activities and Programs of the Colorado River Commission

- James H. Davenport, Chief, Water Division, Colorado River Commission (CRC) of Nevada, Las Vegas, testified on the following matters associated with the activities and programs of the Colorado River Commission: (1) Colorado River resources; (2) past developments in Colorado River Administration; and (3) ongoing and developing issues of Colorado River Administration. Please see Exhibit E.
 - Senator Amodei requested that the CRC provide a written explanation to the Committee of the rules that guide the CRC in conducting its meetings.
- James D. Salo, Special Assistant to the Executive Director, Colorado River Commission of Nevada, Las Vegas, explained the pending power-related litigation involving the Colorado River Commission and Nevada Power Company, as well as other related matters and parties to this issue.

Report by the State Engineer Concerning General Water Issues in Southern Nevada

• Hugh Ricci, State Engineer, Division of Water Resources, State Department of Conservation and Natural Resources, Carson City, reported on the following water issues in southern Nevada: (1) water right statistics; (2) groundwater pumpage and artificial recharge; (3) water consumption and groundwater recharge; (4) consumptive use from the Colorado River; (5) in-state groundwater for the Las Vegas Valley Water District; (6) criteria for approving a water right application; and (7) interbasin transfers. Please see Exhibit F.

Discussion and Review of the Development of the Draft Environmental Impact Statement for the Yucca Mountain – Caliente Railroad Corridor

- Robin Sweeney, EIS Document Manager, Office of National Transportation, Office of Civilian Radioactive Waste Management, United States Department of Energy (DOE), Las Vegas, addressed the following areas pertaining to the Yucca Mountain Caliente Railroad Corridor: (1) Nevada transportation analysis in the Repository Environmental Impact Statement (EIS); (2) administrative land withdrawal application; (3) mode and corridor record of decision and notice of intent to prepare a rail alignment EIS; and (4) the next steps in the process. Please see Exhibit G.
- Jo Simpson, Chief, Office of Communications, BLM, DOI, Reno, Nevada, called attention to a question and answer handout and reported that the Ely BLM field office will be the lead office for the Yucca Mountain Nuclear Repository and Transportation Corridor project since the corridor involves three different BLM districts. Please see Exhibit H.

Review of Invasive Species and Discussion of Programs and Activities of the Southern Nevada Office of the State Department of Agriculture (SDA)

• Thomas Smigel, Regional Manager, Las Vegas Office, SDA, Las Vegas, called attention a brochure that lists the services provided by the State Department of Agriculture and identified the various divisions within the SDA. Mr. Smigel then began his presentation of invasive species and the programs and activities of the southern Nevada office of the SDA. Please see Exhibit I and Exhibit J.

PUBLIC COMMENTS

• Peggy Maze Johnson, Executive Director, Citizen Alert, Las Vegas, expressed concern that insufficient public input has been obtained and evaluated regarding bringing nuclear waste into the State of Nevada.
