## **OPENING REMARKS**

Chairman Rhoads opened the meeting and reported that Nevada's Congressional Delegation will support county-by-county wilderness bills, but not a statewide measure.

At the request of Senator Rhoads, Scott Young, Principal Policy and Special Projects Analyst, Research Division, LCB, Carson City, Nevada, provided a brief background on the Wilderness Act of 1964, which established the national wilderness preservation system of federal public lands designated by Congress as wilderness areas. Mr. Young explained the Subcommittee's statutory purview with the passage of S.C.R. 7 of the 2003 Session, and he stated the Subcommittee will submit a report with recommendations for consideration during the 2005 Session to the Legislative Committee on Public Lands at its final meeting, which is scheduled for August 27, 2004.

### REPORTS TO SUBCOMMITTEE

Historical Overview of Wilderness Legislation, Including Measures Addressing Nevada Wilderness Areas and Current Issues Involving Nevada Wilderness Areas

• Kevin Kirkeby, Rural Coordinator, Office of United States Senator John Ensign, Carson City, addressed the following areas during his presentation: (1) pre-wilderness history; (2) historical highlights of the Wilderness Act of 1964; (3) modifications and clarifications to the Wilderness Act; (4) national and Nevada wilderness statistics; (5) wilderness and WSAs in the Ely District Bureau of Land Management (BLM) office; and (6) public lands legislation. # Presentation of Native American Perspectives on Wilderness Issues

• Richard Harjo, Chairman, Nevada Indian Commission, Carson City, after reciting a poem by Native American Luther Standing Bear (Chief of the Oglala, Lakota Tribe), reported on the Nevada Indian Commission's position on land management in Nevada and presented six recommendations to encourage that Native American cultural, traditional, and spiritual perspectives are considered in the study of wilderness areas and wilderness study areas as provided by S.C.R. 7. ### Presentation on Wilderness Issues Relevant to Nevada

• Shaaron Netherton, Executive Director, Friends of Nevada Wilderness, Reno, testified on wilderness issues relevant to Nevada and drew particular attention to the detrimental impact on Nevada's wilderness of illegally-created roads and all-terrain vehicle (ATV) use during the hunting season. Ms. Netherton also commented on the Citizens' Wilderness Proposal for Lincoln and White Pine Counties. Please see Exhibit D and Exhibit E.

# Presentation on Wilderness Issues from the Perspective of the Nevada Cattlemen's Association

- Joseph Guild, Board Member, Nevada Cattlemen's Association, Reno, offered brief remarks regarding Nevada ranchers and the constraints on grazing operations in national parks and wilderness areas.
- Preston T. Wright, President, Nevada Cattlemen's Association, Elko, Nevada, noted that Nevada ranchers are not as vocal about wilderness issues as in years past for such reasons as: (1) there are fewer ranchers and cattle in Nevada; (2) many of the regulatory restrictions have not had the negative impact as once thought; and (3) the ranchers find themselves as allies with agencies trying to protect public lands from overuse by ATVs. Mr. Wright made the following requests on behalf of the Nevada Cattlemen's Association: (1) protection for prior existing rights and legal access to traditional lands for range improvements and maintenance; (2) disallow federally-reserved water rights in wilderness areas; and (3) ensure that any public lands released for federal, state, local, or private ownership and development include lands suitable for ranchers to acquire, not just low-value lands.

# **PUBLIC COMMENT**

- Senator Rhoads introduced two letters into the record from concerned citizens. The first letter (Exhibit F) regarding designation of wilderness areas in the state was received from Greg Loptien, Sparks, Nevada. The second letter (Exhibit G) concerning wilderness issues and historic markers in Nevada was received from John Johnson, Chico, California.
- Les Thrasher, resident, Las Vegas, Nevada, addressed concern about land acquisition through the "Biodiversity Treaty and the Wildlands Project." He urged the Committee to review his handout on this matter and convey its opinion to Nevada's Congressional Delegation. Please see Exhibit H.
- Jonathan Brown, Director of Environmental and Regulatory Affairs, Nevada Mining Association (NMA),

Reno, presented wilderness and public land statistics relevant to Nevada. Please see Exhibit I.

- Marjorie Sill, resident, Reno, noted that 2004 is the 40<sup>th</sup> anniversary of the enactment of the Wilderness Act of 1964 and voiced support for preserving wilderness areas in Nevada.
- Christina Stover, resident, Reno, discussed marketing and promoting Nevada's outdoor recreation resources. Please see Exhibit J.
- Valerie Anderson, resident, Reno, spoke in support of wilderness areas.
- Ann S. Carpenter, resident, Reno, supports minimizing wilderness designations to ensure access to the state's mineral resources. Please see Exhibit K.
