OPENING REMARKS

Senator Townsend welcomed the audience and introduced the Commission members.

OVERVIEW OF THE JULY 2003 FINAL REPORT OF THE PRESIDENT'S NEW FREEDOM COMMISSION ON MENTAL HEALTH, ACHIEVING THE PROMISE: TRANSFORMING MENTAL HEALTH CARE IN AMERICA

ELECTION OF CHAIRMAN AND VICE CHAIRMAN

SENATOR COFFIN MOVED THAT SENATOR TOWNSEND SERVE AS THE COMMISSION'S CHAIRMAN. THE MOTION WAS SECONDED BY ASSEMBLYWOMAN LESLIE AND PASSED.

ASSEMBLYMAN HORNE MOVED THAT ASSEMBLYWOMAN LESLIE SERVE AS THE COMMISSION'S VICE CHAIRWOMAN. THE MOTION WAS SECONDED BY ASSEMBLYMAN HARDY AND PASSED.

OVERVIEW OF CURRENT STATUS OF THE MENTAL HEALTH DELIVERY SYSTEM IN NEVADA

Carlos E. Brandenburg, Ph.D., Administrator, Division of Mental Health and Developmental Services, Department of Human Resources, Carson City, provided an overview of the current status of Nevada's mental health delivery system. He noted that in developing a comprehensive state mental health plan, it is important the Commission review the plan established by the Mental Health Plan Advisory Council, which provides oversight to Nevada's mental health block grant. The members shared their visions regarding the Commission's goals and priorities.

SCHEDULING OF FUTURE MEETINGS AND DISCUSSION OF FUTURE TOPICS

The Commission identified potential topics for consideration at future meetings. In addition, the Commission set its next meeting for October 9, 2003, beginning at 8:30 a.m.

PUBLIC COMMENT

- At the request of the Honorable John S. McGroarty, District Judge, Eighth Judicial District Court, Las Vegas, Chairman Townsend read into the record a news release regarding the creation of a mental health court within the Eighth Judicial District Court. Please see Exhibit E.
- Richard Siegel, Ph.D., President, Northern Nevada Chapter, ACLU, Reno, Nevada, identified certain issues for potential review by the Commission, including triage priorities, appropriate representation of minorities, the provision of care to individuals residing in rural areas, and the role of public and private institutions in providing mental health services.
- James Osti, M.P.H., Southern Nevada Mental Health Task Force, Las Vegas, reported he was promoting the establishment of a tracking mechanism to monitor the number of patients placed on hold, commonly known as a "legal 2000," while awaiting bed availability at a mental health facility. Please see Exhibit F for details of Mr. Osti's remarks.
- Brian Burke, an attorney for the Nevada Disability Advocacy & Law Center, Las Vegas, indicated he specializes in mental health issues and
 offered his assistance to the Commission.
- Tom Bolan, Chief Executive Officer, Step 2, Reno, appeared on behalf of the Nevada Alliance for Addictive Disorders—Advocacy, Prevention and Treatment Services (AADAPTS). Mr. Bolan stressed the importance of integrating services to avoid duplication and maximize the potential for recovery.
- Referencing Senate Bill 557 (Chapter 576, Statutes of Nevada 1999), which "requires certain policies of health insurance to include coverage for treatment of conditions relating to severe mental illness," Jeanette Belz reported she had inquired into the status of the measure on behalf of the Nevada Psychiatric Association. Ms. Belz was advised by staff that the legislation provided the mental health parity provisions would expire by May 1, 2004, if the Commissioner of Insurance issued a determination that the cumulative effect of those provisions had resulted in a premium increase greater than 6 percent as of January 1, 2003. Continuing, Ms. Belz indicated it was her understanding the Commissioner did not issue such a determination.
