In reply to your request for information pertaining to individuals certified or licensed by the Board of Examiners for Alcohol, Drug and Gambling Counselors, the following are the statistics and answers as of April 7, 2004.

1. Current licensed supply. (This is just the total number of persons licensed by your board). Currently the Board of Examiners for Alcohol, Drug and Gambling Counselors licenses or certifies the following:

Also, UNLV, UNR, Truckee Meadows Community College, Southern Nevada Community College and the University of Phoenix offer courses in addictions.

- 11. Does your agency experience any difficulty in obtaining information from licensees and prospective licensees? (If so, please discuss these issues.)

 None from individuals currently licensed or certified. Some prospective licensees/certified individuals complain that Nevada's standards are to high. Also, they are surprised that Nevada requires licenses or certificates to provide alcohol and drug abuse and problem gambling counseling services. They also express the same comments in regards to any type of mental health counseling or services.

In response to your fax of April 1, 2004, the Board of Examiners for Audiology and Speech Pathology has provided you the answers listed below:

- 1. Currently, we have licensed 371 speech pathologists and 70 audiologists.
- 2. Currently, we have 401 Nevada residents licensed, 212 in Clark County, 164 in Washoe County, 13 in Carson City and 12 in the rural areas.
- 3. Currently, we have 40 non-Nevada residents who hold licenses.
- 4. We don't keep records of retirees; most retirees simply just do not renew their license.
- 5. We don't have any recruitment issues, as we don't recruit licensees. This is mainly done by facilities or businesses that use audiologists and/or speech pathologists.
- 6. Retention is not a part of board issues, although we do have many licensecs who have maintained their licenses for over 20 years. Since this is such a mobile state we have no knowledge as to when or if a licensee will move.

- 7. We are currently working on updating our regulations. We do address issues with the regulations as they are brought to our attention and we continuously strive to keep them current, concise and to the point.
- 8. To our knowledge there are no practice environment issues. You would probably have to poll the licensees to obtain their input.
- 9. To our knowledge there are no training issues. You would also probably have to poll the licensees to obtain their input.

Every time a license is issued the licensure list is updated, this could be daily or monthly but certainly no longer than that. We don't have any difficulty obtaining information from licensure applicants, as we don't issue licenses until the board receives all required documents.

With respect to your April 1, 2004 letter requesting participation in your study of Nevada's health care delivery system, we offer the following as of April 8, 2004:

Current Licensed Supply - Actively licensed chiropractors	553
Number of Nevada residents with an active license - (We are unable to provide the number by county)	517
Number of non-Nevada residents with an active license -	36
Retired Personnel -	22

Recruitment Issues

The chiropractic colleges have indicated a drop in enrollments for the past several years, however, the number of applicants for Nevada license has remained steady since 2001, and there has been a marked increase since the first of this year. The CPBN has not felt the need to actively recruit due to the attractiveness of the growth throughout the state. In 2002 the CPBN changed its statutory requirements by accepting the examination results of the National Board of Chiropractic Examiners, thereby eliminating all but the Nevada Jurisprudence test. The Jurisprudence test is now offered more frequently than the prior examinations. Both of these changes have facilitated applicants in attaining licensure.

Retention Issues

We have experienced a 33% increase in actively licensed practitioners since 2000 and do not feel that retention is a concern at this time.

Regulatory Issues

HIPAA, Medicare reporting/compliance.

Practice Environment Issues

There continues to be a selective bias against chiropractors by managed care, HMOs, PPOs, etc., and the insurance community at large. It is very difficult for chiropractors, and especially new licensees, to get accepted on provider panels.

Training Issues

The current curricula of the chiropractic colleges is adequate for preparing chiropractors in the successful treatment of their patients. There does appear to be a need for more training in the business aspects of conducting a chiropractic practice, i.e., billing, insurance, etc.

With respect to ongoing training, Nevada licensees are required to attend 12 hours of continuing education on clinical subjects each year and on-line study is approved if it conforms to our attendance monitoring requirements. There is a plethora of courses being offered on the subject of the practice of chiropractic which are carefully screened by the CPBN Continuing Education Committee.

- 7. There are no barriers known; however full disclosure of all license history of applicants is required including malpractice judgments and legal discipline.
- 8. The number of licensees coming to Nevada and either taking the license exam or licensing by credential is continuing to increase which may be a strong indication that the environment in Nevada is favorable. Any barriers would likely be external to the licensing process---cost of living, tax structure, insurance issues, etc.
- 9. Training does not appear to be a barrier; however, it can affect proficiency on the exam.

- 11. Tardiness with information occurs but rarely do licensees defy an information request from the board.

Following is the information you requested in your letter of April 1, 2004:

1. Current licensed supply:

This Board issues 2-year licenses certifying administrators for Residential Care/Assisted Living Facilities (RFA's) and 2-year licenses certifying administrators for Nursing Home Facilities (NFA's) on a daily basis as required;

2. Number of Nevada residents with an active license (by county, if possible);

As of April 6, 2004 our records indicate the following Nevada residents with active licenses:

4. Retired personnel:

We do not track retired personnel.

5. Recruitment issues:

Because of the continued growth of the elderly population in Nevada, we have a constant flow of applicants for administrator licenses for the long-term care facilities. Thus, we do not actively recruit applicants.

6. Retention issues:

There has been a slight increase in licensees allowing their licenses to expire due, in part to increased costs of licensing and operating a facility. Also aging licensees who have been in the industry for many years are retiring and allowing their licenses to expire or to become inactive for no longer than 2 years. At the conclusion of 2 years, either the licensee renews his/her license or it expires. Most allow their licenses to expire.

7. Regulatory issues:

As a result of constant surveillance by the Division of Health (the Bureau of Licensure and Certification) of nursing homes and assisted living and group homes, perhaps three or four times a year, we are advised of a problem. An investigation is implemented to determine the extent of the administrator's culpability or other issues are involved. The problem is dealt with as deemed appropriate by the extent of the complaint and in accordance with NRS 654.190 and NAC 654.220.

8. Practice environment issues;

None at this time.

9. Training issues:

The Board has determined that its present requirements for training are adequate. However, it feels that a more concentrated training should be implemented in addition and is exploring other training sources to assure that administrators of Residential Care/Assisted Living Facilities are providing the best possible care to our elderly population.

- 8. Practice environment issues are not within the purview of the Nevada State Board of Medical Examiners.
- 9. Nevada has some of the most stringent requirements for licensure in the United States. Among these, applicants must graduate from an accredited medical school and complete a minimum of 36 months Accreditation Council for Graduate Medical Education training or a minimum of 36 months in the Licentiate of the Medical Council of Canada program. Additionally, licensees must complete 40 hours AMA Category 1 continuing medical education each biennium.

The Nevada State Board of Medical Examiners licensure list is updated on a daily basis.

Licensees and prospective licensees are generally cooperative in providing information requested by the Nevada State Board of Medical Examiners, although Board staff has encountered difficulty at times when third parties, i.e., some credentialing agencies, is involved in the licensure application process.

How often is your licensure list updated? The Board's licensure and certification database is updated daily. Verification of an individual's licensure or certification is available through the Board's web site at www.nursingboard.state.nv.us, or by calling the Board offices.

Do you have any difficulties in obtaining information from licensees and prospective licensees? The Board requires all applicants for initial licensure and certification to submit fingerprints for a criminal background check. The Board has difficulty in obtaining prompt fingerprinting results from the Criminal History Repository, which often causes delays in granting licensure and certification to new applicants.

4. Retired personnel.

The Board does not have the category "retired nurse."

5. Recruitment issues.

The Board supports the multi-state Nurse Licensure Compact which would allow nurses to have one license in their state of residency and practice in any state that has signed an interstate compact. Enabling legislation was introduced and failed in the last two legislative sessions due to opposition from organized labor.

The Board adopted a policy allowing the executive director to waive the instructor to student (1:8) ratio in leadership classes. The waiver is time-limited and may only occur in cases where each student has a formal, 1:1 relationship with an individual preceptor at each clinical site. This policy has helped increase the number of courses the schools can offer, and therefore, the number of students they can admit.

The Board streamlined the application form for all licensure/certification applicants.

The Board removed its requirement for social security numbers before processing licensure applications for examination. The former requirement posed an unnecessary barrier for international nurse graduates applying to be licensed in Nevada. (A social security number is still required before a license is issued.)

The Board's executive director is a founding member of the Nursing Institute of Nevada, which addresses recruitment and retention issues for nursing in Nevada. The executive director has been very active in this organization.

6. Retention issues.

Nurses can now renew their licenses on-line. This new service is part of the Board's ongoing effort to make it easier for nurses to maintain their active licensure and continue practicing in Nevada.

The majority of disciplinary actions the Board takes are focused on remediation and/or rehabilitation, keeping nurses and nursing assistants working while helping them improve their practice.

The Board believes that nurses and nursing assistants who are involved in the ongoing development and regulation of their practice in their home state are more likely to feel more positive about their nursing practice and remain practicing in Nevada. Therefore:

1) The Board provides opportunities for nurses and nursing assistants to be involved in shaping their practice in Nevada through appointment of dozens of nurses and nursing assistants to the Board's five standing advisory committees. Questions about nursing regulation, practice, and education are brought to these committees for research, discussion, and policy development. The Board considers the recommendations of its advisory committees during its regular meetings. Virtually every law, regulation and practice decision issued by the Board has been based on the recommendation of one of its advisory committees.

2) Every day, Board staff answers questions from nurses and nursing assistants regarding questions about their practice. Last year, Board staff gave 84 formal educational presentations to the nursing community to foster a better understanding of practice issues in Nevada.

The executive director supports the Nevada Nurses Association by attendance at their annual conferences, ongoing collaboration with its members, and the frequent provision of educational presentations. A working relationship between the nursing association and the regulatory board in states provides support to the nursing profession and encourages growth among its members.

7. Regulatory issues.

As is evident by the Board's actions in the other categories, it continues its efforts to identify and remove unnecessary regulatory barriers, as long as such action does not lower standards or compromise patient safety.

8. Practice environment issues.

The field of nursing, which has always been challenging, is today facing even more complex challenges. These include more acutely ill patients, shorter hospital stays, redesigned work, changes in the deployment of nursing personnel to provide nursing care, frequent patient turnover, continuous increases in knowledge and technology, frequent interruptions, long hours, increased demands on nurses' time, and in Nevada, the worst nursing shortage in the nation. The Board supports the efforts of nurses and nursing assistants to protect patient safety in today's environment by conducting education for nurses, nursing assistants and their employers regarding their rights and obligations under the Nurse Practice Act.

When investigating a complaint against a licensee or certificate holder, the Board always takes the practice environment into account. For example, when conducting investigations, the Board reviews staffing numbers and assignments, and always takes these circumstances into consideration as mitigating or aggravating conditions. The Board has never disciplined a nurse or nursing assistant for mistakes made solely due to working in an understaffed environment.

9. Training/Education issues.

The Board actively supports the doubling of the UCCSN nursing school enrollment.

The Board recently adopted concept and wording to revise regulations to allow nursing schools to hire qualified nursing faculty. The Board recognizes the need to be flexible in adopting faculty requirements without sacrificing quality nursing education or jeopardizing patient safety.

During the 2003 session, the Board sponsored legislation that removed a "Catch-22" situation for students who graduate from a nursing program that is approved by the Board, but "in the process of being accredited." The passage of AB22 allows those students to take the national nursing examination, and if they pass, to be licensed in Nevada.

The Board recently formed an Education Advisory Committee to address challenges in nursing education. Representatives from all nursing schools and other key stakeholders have been appointed to this committee. Among its accomplishments is a complete revision and update of the Board's education regulations. The Board has accepted the newly proposed regulations in concept and wording, is scheduling public workshops and a public hearing, and hopes to finalize these regulation changes before the fall semester.

By the time they graduate, all nursing students in Nevada will have met at least one representative from the Board. That is because Board staff members make educational presentations to Nevada nursing students based on invitations from all nursing programs in the state. Topics include the licensure and the application process, the role of the nurse, administrative law and the discipline process, addressing the impaired nurse, and regulation of nursing practice in Nevada. The Board believes that a better-informed new nurse will be able to provide safer care and be more satisfied in the profession in general.

In response to your fax of April 1, 2004, the Board of Occupational Therapy has provided you the answers listed below:

- 1. Currently, we have licensed 403 occupational therapists and 143 occupational therapy assistants.
- 2. Currently, we have 491 Nevada residents licensed, 340 in Clark County, 122 in Washoe County, 13 in Carson City and 16 in the rural areas.
- 3. Currently, we have 55 non-Nevada residents who hold licenses.
- 4. We don't keep records of retirees; most retirees simply just do not renew their license.
- 5. We don't have any recruitment issues, as we don't recruit licensees. This is mainly done by facilities or businesses that use occupational therapy practitioners.
- 6. Retention is not a part of board issues, although we do have many licensees who have maintained their licenses for over 10 years. Since this is such a mobile state we have no knowledge as to when or if a licensee will move.

- 7. We last updated our regulations in 2002. We do address issues with the regulations as they are brought to our attention and we continuously strive to keep them current, concise and to the point.
- 8. To our knowledge there are no practice environment issues. You would probably have to poll the licensees to obtain their input.
- 9. To our knowledge there are no training issues. You would also probably have to poll the licensees to obtain their input.

Every time a license is issued the licensure list is updated, this could be daily or monthly but certainly no longer than that. We don't have any difficulty obtaining information from licensure applicants, as we don't issue licenses until the board receives all required documents.

Following are the responses to your remaining questions:

5. Recruitment issues: Most of Nevada's pharmacists must still be recruited from sources outside of Nevada. The Nevada School of Pharmacy has recently received its national ACPE accreditation, so its graduates now qualify to serve as pharmacists in Nevada. Of the School of Pharmacy's first class of 35 students (who graduated in December 2003), 33 have applied with the Board and 25 have already received their licenses. Our understanding is that most of the licensed graduates had jobs immediately upon receiving their licenses. Though the School of Pharmacy will graduate a class in June 2004 of approximately 70 graduates with subsequent classes being approximately 115 graduates per year, the state will still require more than the School of Pharmacy's graduates to fill all of the pharmacist positions, especially the positions in the Las Vegas/Clark County region.

The Board has taken active steps to make licensure of pharmacists by reciprocity or from foreign countries as expeditious as can safely be done. The Board also issues temporary licenses to qualified applicants to allow them to begin working in Nevada pharmacies while they complete some of the routine necessities for full licensure. The Board was one of the first in the country to recognize graduates of Canadian pharmacy schools to be equivalent to graduates of American pharmacy schools, thus facilitating easier licensure for Canadians desiring to relocate to Nevada. The Board can license most applicants in less than two weeks. Nonetheless, Nevada is experiencing a deficit of pharmacists as a result of the doubling of the number of pharmacies in Nevada over the last seven years.

- 6. Retention issues: Annually, Nevada gains more pharmacists than it loses to other states, and this net gain has been the trend for a decade. Nevada's wages and lifestyle have kept its pharmacies competitive, even though pharmacists in Nevada make less than pharmacists in California (for example). Because of the pharmacist deficit, Nevada's retention issues revolve around pharmacist's staying at a particular pharmacy because competitor pharmacies can lure good pharmacists from one pharmacy to another with various incentives.
- 7. Regulatory issues: The Board enjoys good working relationships with the Retail Association of Nevada (RAN), the National Association of Chain Drug Stores (NACDS), and various representatives of other concerned groups. Nevada does not have a pharmacists' association, although one is presently attempting to get started. Because the Board works well with other organizations, it is constantly writing and refining its regulations to assure the

best possible environment in Nevada for pharmacies and their employees to thrive.

The only group of licensees with which the Board has experienced some disagreement is a small number (less than ten) of Nevada's pharmaceutical wholesalers. The Board has been engaged in an ongoing effort to create better transparency and accountability for all pharmaceutical wholesalers. Though the Board's efforts were commenced before the recent and highly publicized incidents of drug counterfeiting that are and continue to be a public health concern, the counterfeiting and concerns with potential terrorist and national security regarding the drug supply have added urgency to the Board's efforts. Unfortunately, a small subset of pharmaceutical wholesalers believe that the Board's efforts will harm their mode and method of doing business, and this small subset have cost the Board hundreds of thousands of dollars in legal and administrative fees and costs in protracted litigation.

- 8. Practice environment issues: Approximately 90% of Nevada's retail pharmacies are owned by national corporations. Because of Nevada's rapid growth and the pharmacist deficit, Nevada's retail pharmacies are constantly recruiting new pharmacists and are also constantly upgrading their technology and practice environments to achieve better efficiencies and safety. The Board has remained on the forefront of all available technology that will increase pharmacy safety and efficiency such as electronic prescribing, internet pharmacy practice, facsimile transfers of prescriptions, central filling and central processing, automated dispensing, and other similar innovations.
 - 9. Training issues: There are no real training issues.

In response to your final inquiry, the Board's licensee information is updated daily. Our licensing management system is current immediately upon the entry of new data (such as new licensing information, address changes, etc.), and this current information is available to the public through personal telephonic communication during normal business hours or through the Board's website 24 hours a day. Some licensees can change their addresses online and verify the change just seconds later.

The only difficulties the Board experiences in getting information from licensees involve the small group of pharmaceutical wholesalers who disagree with the Board's regulatory and disciplinary efforts. This small group of licensees always resists production of business records and turns every request for records, even the simplest and most routine types, into drawn out administrative and litigative matters.
