Programs

Program:

The distribution of USDA commodity food in Nevada is carried out under the following programs. The National School Lunch Program, the Child and Adult Care Food Program, and the Summer Food Service Program provide food to eligible agencies under the Child Nutrition Program. The Nutrition Services Incentive Program provides food to eligible Senior Centers that provide meals to the elderly. The Food Distribution Program on Indian Reservations involves the distribution of food to needy households residing on rural Indian reservations. The Emergency Food Assistance Program distributes food to food banks for redistribution to low income households statewide. The Commodity Supplemental Food Program distributes food packages to low income seniors, women, infants and children. The Senior Farmers Market Nutrition Program provides low income seniors with coupons to buy fresh fruits and vegetables from local farmers markets. The Food Distribution Program serves approximately 210 agencies and 10 Indian reservations throughout the State.

Eligibility:

The eligibility criteria for the commodity food programs are set by federal regulation that govern each program. The criteria differs from program to program. The underlying goal, however, is to provide food to low income participants.


