

# 1.) ARPA OVERVIEW

 H.R. 1319: American Rescue Plan Act ("ARP") signed by President Biden on March 11, 2021.

 Package includes nearly \$2T in national aid through hundreds of separate programs & initiatives.

#### TYPES OF AID

- Direct aid: Funding flowing directly to Nevadans, like stimulus payments, Federal Pandemic Unemployment Compensation (FPUC), and the Child Tax Credit.
- Non-discretionary aid: Funding to existing or new programs for which recipient has no/limited discretion in how funds can be spent.
- Quasi-discretionary aid: Funding to existing or new programs for which recipient has some discretion in how funds can be spent.
- **Discretionary aid**: Funding to existing or new programs for which recipient has discretion in how funds can be spent.

- 106 known buckets of funding to the State of Nevada
  - Does not include programs such as Economic Impact Payments sent directly to residents, or the expansion of the Child Tax Credit program
- 72 buckets with known or anticipated State allocation amounts
- 34 buckets for which anticipated state allocation amounts remain outstanding



- Total: \$2.74B (State) | \$1.04B (Local)\*
- Interim Final Rule / Guidance published May 2021
- Four allowable uses under guidance:
  - Public Health and Economic Impacts
  - O Premium Pay
  - Investments in Infrastructure
  - O Provision of Government Services\*\*

\*Two tranches

\*\*To the extent of revenue loss

## **Capital Projects Fund**

- Total: \$135MM
- Guidance published September 2021
- Projects must meet three criterion to be eligible:
  - Capital project invests in capital assets designed to directly enable work, education, and health monitoring;
  - Capital project is designed to address a critical need resulting from, made apparent, or exacerbated by the COVID-19 Pandemic; and
  - Capital project designed to address a critical need of the community served by it

# **Economic Development**

Total: \$92.1MM

# **ARPA Funds Managed by the State**

- 25 Work Programs have gone before IFC since June 2021 to receive ARPA funds; 2 allocations approved during the 81st Session
- Funds are being managed by various agencies like NDE, DHHS, B&I,
   Veteran's, Tourism & Cultural Affairs, and GFO
- Federal partners include Treasury, DOE, HHS, CDC, SAMHSA, USDA
- Programs vary in duration and uses
- Many allowances overlap

# Coronavirus State and Local Fiscal Recovery Fund

- Largest ARPA allocations Local Government aid (\$1.04B), State
  Government aid (\$2.74B) from the Coronavirus State and Local Fiscal
  Recovery Fund (CSLFRF)
- CSLFRF has two parts the Coronavirus Local Fiscal Recovery Fund (CLFRF) and the Coronavirus State Fiscal Recovery Fund (CSFRF)
- Focus shifts from emergency aid to recovery aid while still allowing for pandemic response

# Coronavirus Local Fiscal Recovery Fund – Direct Payments

- Nevada counties (\$1.04B) & metropolitan cities (\$292M)
- Metro: Carson City, Henderson, Las Vegas, North Las Vegas, Reno, Sparks
- 2 payment tranches direct from Treasury
  - (1) May/June 2021 counties \$520M; metro \$146M
  - (2) Next summer second half of allocation will be available
- Reporting/oversight is direct to Treasury
- Funds have same allowances & reporting requirements as the State Fiscal Recovery Fund

# Coronavirus Local Fiscal Recovery Fund – Payments through State

- Nevada NEUs maximum payments = \$150.7M
- NEUs: Nevada local governments with populations less than 50K
- State received half of funds on June 16, 2021 as pass-through; 30 days to disburse to NEUs (reporting/oversight direct to Treasury)
- Payments to NEUs could not surpass 75% of their State Fiscal Year
   2019-2020 annual expenditure budget
  - 2 NEU payments reduced per this requirement; excess funds will be returned to Treasury
- 2 payment tranches from Treasury: (1) July 2021 \$71MM to NEUs
   (2) Summer of 2022 second half will be available

# Coronavirus State Fiscal Recovery Fund

- State of Nevada received \$2.739 billion payment from U.S. Department of the Treasury on June 4, 2021
- Nevada received full payment rather than 2 tranches due to high unemployment (22 States qualified for full payment)
- Reporting/oversight is direct to Treasury and unallowable expenses can be recouped by Treasury
- State and Local FRF allocations follow same allowances & most reporting requirements

#### ARPA Funding Goes Through Framework Process

- 1.Collect stakeholder input & community feedback on what programs & services would best aid in recovery
- 2.Use the "Every Nevadan Recovery Framework" as a guide to organize ideas, input, and potential uses
- 3. Map all eligible ARPA funding sources
- 4. Pair eligible programs & services with potential funding
- Create a comprehensive Recovery Roadmap which will serve as a compilation of new and existing priorities, programs, and services for funding consideration
