

Dear Sir,

I vehemently urge the commission to reject all vaccine mandates because there is no legitimate reason for them and because, more importantly, these shots are dangerous.

First, the vaccine mandates are unnecessary. As of today (December 21, 2021), the publicly available data on Covid cases, deaths, and population in Nevada reveals that only about 15.2% of Nevadans have gotten Covid since this pandemic began; of those, only about 1.71% have died. To put that number in another perspective, 98.29% of those who get Covid in our state survive! Altogether, only about 0.26% of Nevadans have died of Covid, and 99.74% of Nevadans have survived!

Naturally, these statistics assume the accuracy of the publicly available numbers. However, the publicly available numbers are likely exaggerated considering their basis on notoriously faulty PCR tests and considering the fact that the government has been known to count obviously non-Covid deaths (such as car accident fatalities) as Covid deaths.

Also, realize that there are effectual treatments for Covid like Ivermectin. (This is not merely a “horse-dewormer” as the media likes to portray. Yes, it has veterinary uses for horses and for dogs (it’s in Heartguard); however, people *commonly* use this drug, too—especially people traveling abroad.)

Now, I will address how this “vaccine” is dangerous. All vaccines have side-effects; not one is a one-size-fits-all drug. For me, I experienced severe reactions to vaccination in my youth including seizures. However, this “vaccine” is even worse than all those before it *combined* based on the VAERS data. VAERS is an early warning system; it’s purpose was NOT to be ignored as so many would like us to do. If we ignore what VAERS is screaming at us with data, we defeat the entire purpose of the VAERS system. Note also that VAERS typically only shows a small percentage of the deaths and adverse reactions connected to drugs in total, meaning that the truth about these Covid “vaccinations” is far worse than what you have seen by following the link provided.

And what are adverse reactions? For one Las Vegas teen, adverse reactions meant blood clots which left her needing *three* brain surgeries! A Washington mother died due to her Covid injection. What about her right to life, liberty, and the pursuit of happiness?

And for all these risks, the “vaccines” you propose to mandate don’t even work! They do not provide immunity and they do not “stop the spread”. Is this not what vaccines are supposed to do? So, the government altered the definition of “vaccines” to try to fit their Covid shots. (How is that action not shady?) These non-vaccines also been evidenced to be ineffective by their boosters. First, people needed one vaccine; that did not work; then, people needed two vaccines; that did not work; now people need boosters?! These shots do NOT work!

If you mandate these ineffective shots on people, you ignore the fact that they are completely unnecessary and you coerce people into taking severe risks to their life and well-being. If today, any of

you vote in favor of these mandates, I demand that you accept FULL liability for ALL deaths and adverse reactions which result from the Covid shots you have forced on Nevadans.
