Subject: Nevadans Count - Implementation of AB450

Dear Chairwoman Miller and Committee Members:

My name is Noé Orosco and I am the Census and Redistricting Coordinator at Silver State Voices. I am writing to you on behalf of the *Nevadans Count*<sup>1</sup> coalition.

During the 80th Legislative Session, Silver State Voices co-presented AB450, which would reallocate incarcerated people from where they are incarcerated to their home communities. The Legislature approved this measure, and at the time made Nevada one of only nine states to get rid of this practice known as “prison gerrymandering.”

Since January, I have been in communication with our state demographers and the Legislative Council Bureau (LCB) to better understand how the Legislature would implement AB450. Both the state demographers and the LCB have been very helpful, and I’d like to commend them for all their help.

Unfortunately, that’s where the help ends. Since March, with the help of the ACLU of Nevada, I’ve been asking the state demographer, LCB, and the Nevada Department of Corrections (NDOC) for:

- The process by which the NDOC compiles the last known residential address of each incarcerated person, including the timeline for compiling the data.
- The process NDOC follows if it cannot find the last known residential address of an inmate.
- The process NDOC follows to verify the accuracy of this data.

At the beginning of September, the LCB was able to provide me with a summary of how many incarcerated people are out of state, have an in-state address, or do not have an address on file. The summary confirmed what I feared. The NDOC does not have the address for one-third of incarcerated records they provided. Further, of the 12,214, NDOC provided, only 6,275 individuals (or 51.4%) would be reallocated. I’d like to reiterate that this is not the entire incarcerated population, rather it is what NDOC was able to provide the demographer.

This is deeply concerning to the Nevadans Count coalition, because we have been trying to find out how NDOC would collect information since March. And to date, we have not received a response from NDOC.

I understand we are in a shortened timeline for redistricting, however, there is still time to ensure the intent of AB450 is fully implemented. I no longer am asking, or encouraging, I'm imploring you to look into this. If we don't get it right now, we will not have another opportunity for another decade.

Below are 13 letters highlighting the growth and diversity of our great state, and the need to consider this when developing and approving redistricting maps.
