# POWERS AND DUTIES OF THE COMMITTEE

Assembly Bill 443 (2021) created the Joint Interim Standing Committee on Government Affairs, and set its membership; duties and powers; and jurisdiction. Pursuant to Section 6 of Assembly Bill 443, the Joint Interim Standing Committee on Government Affairs may do the following: (a) evaluate and review issues within the jurisdiction of the corresponding standing committee or committees from the preceding regular session of the Legislature; (b) exercise any of the investigative powers set forth in Nevada Revised Statutes (NRS) 218E.105 to 218E.140, inclusive; and (c) within the limits of the Committee's budget, conduct studies directed by the Legislature or the Legislative Commission. Finally, the Committee may request up to ten bill drafts requests related to government affairs issues.

# PROPOSED WORK PLAN

The budget approved by the Legislative Commission allows the Committee to conduct up to six hearings throughout the interim. The Committee must conclude its work by August 31, 2022. The following are a list of tentative and confirmed meeting dates.

## COMMITTEE JURISDICTION

The Committee generally has jurisdiction over a wide range of issues affecting state and local government. The Joint Interim Standing Committee on Government Affairs may consider topics related to the following:

- Cities, counties, and general improvement and special districts;
- Cooperative agreements;
- Homeland security and emergency management;
- Housing authorities;
- Libraries and museums;
- · Military and veterans;
- Planning, zoning, regional planning entities, and redevelopment;
- Public officers and employees (e.g., benefits, collective bargaining, and retirement);
- Public property and purchasing;
- Public records and the Open Meeting Law;
- Public works;
- State and local government financial administration;
- State executive departments; and
- Tourism and cultural affairs.
