

# MEMBERSHIP HISTORY OF THE SUNSET SUBCOMMITTEE OF THE LEGISLATIVE COMMISSION

The Sunset Subcommittee is a permanent subcommittee of the Legislative Commission; its authorization and duties are set forth in Chapter 232B ("Legislative Review of Public Agencies") of *Nevada Revised Statutes*. Created in 2011 with the enactment of [Senate Bill 251](#), the Subcommittee is responsible for conducting reviews of all boards and commissions in Nevada that are not provided for in the *Nevada Constitution* or established by an executive order of the governor.

In 2013, the Legislature enacted [Assembly Bill 383](#) to provide that in any interim the Subcommittee, with the approval of the Legislative Commission, may request up to four audits of boards or commissions to be performed by the legislative auditor. Statutory provisions were amended to provide that the three members from the general public would be nonvoting.

The Senate members are appointed by the majority leader of the Senate, and the Assembly members are appointed by the speaker of the Assembly. The nonlegislative members are nominated by the governor and appointed by the chair of the Legislative Commission.
