

NEVADA STATE BOARD OF MEDICAL EXAMINERS

The Nevada State Board of Medical Examiners (NSBME) is a Title 54 licensing board, consisting of nine members appointed by the Governor. Six members are physicians licensed in this State, and the remaining three members are public members. The NSBME was created on March 15, 1899 and is the oldest licensing board in the State. The NSBME is governed by the Nevada Medical Practice Act, which is codified in NRS and NAC Chapters 630. The Board has two Investigative Committees. Each Committee is comprised of two physician Board members and one public Board member. The NSBME also has a Physician Assistant Advisory Committee created by NAC 630.415, a Practitioners of Respiratory Care Advisory Committee created by NAC 630.560, and a Perfusionists Advisory Committee created by NAC 630.790. The NSBME's main office in Reno houses thirty-five employees, and it also has an office with six employees in Las Vegas.

Mission Statement: The NSBME protects the public and serves the State of Nevada by ensuring that only well-qualified, competent physicians, physician assistants, practitioners of respiratory care and perfusionists receive licenses to practice in Nevada. The Board responds with expediency to complaints against our licensees by conducting fair, complete investigations that result in appropriate action. In all Board activities, the Board shall place the interests of the public before the interests of the medical profession and encourage public input and involvement to help educate the public as we improve the quality of medical practice in Nevada.
