The \$108 Million total figure is inclusive of the \$29.1 Million in State funding provided to Clark County (\$20M), the Reno Housing Authority (\$5M) and the Nevada Rural Housing Authority (\$4.1M).

The Nevada Rural Housing Authority continued to use CRF funding through April of 2021 while both Clark and Reno obligated their funding by December 30, 2020.

This funding preceded the passage of specific Federal Emergency Rental Assistance Funds.

Clark County provided bulk payments to landlords with CHAP funds and did not provide a breakdown of how many individuals have been assisted in each of those bulk payments.

per the NV Independent- May 3, 2021- Between July of last year and April, CHAP assisted more than 24,000 households with rent, mortgage payments (when available) or utility bill assistance, distributing more than \$97 million, county officials told The Nevada Independent on Monday.
