NDVS Annual Report

Purpose:

- Informs the veterans and families we support about earned benefits and services
- Informs the Governor and Legislators of NDVS operational activities / financial position
- Serves as a resource when applying for grants supporting Nevada veterans
- Sparks ideas among potential partners regarding mutually beneficial collaborations

Reflects two major efforts:

- Improving our efforts to help veterans and their families during life's transitions
- Recovering from the disruptions associated with the COVID-19 Pandemic



Status of Transition Services

- ***Transition services support those:***
- Starting a new career
- Becoming homeowners
- Recovering from medical and mental health injuries and illness
- Reentering society after incarceration
- Entering a care facility
- Losing a loved one
- Leaving military service

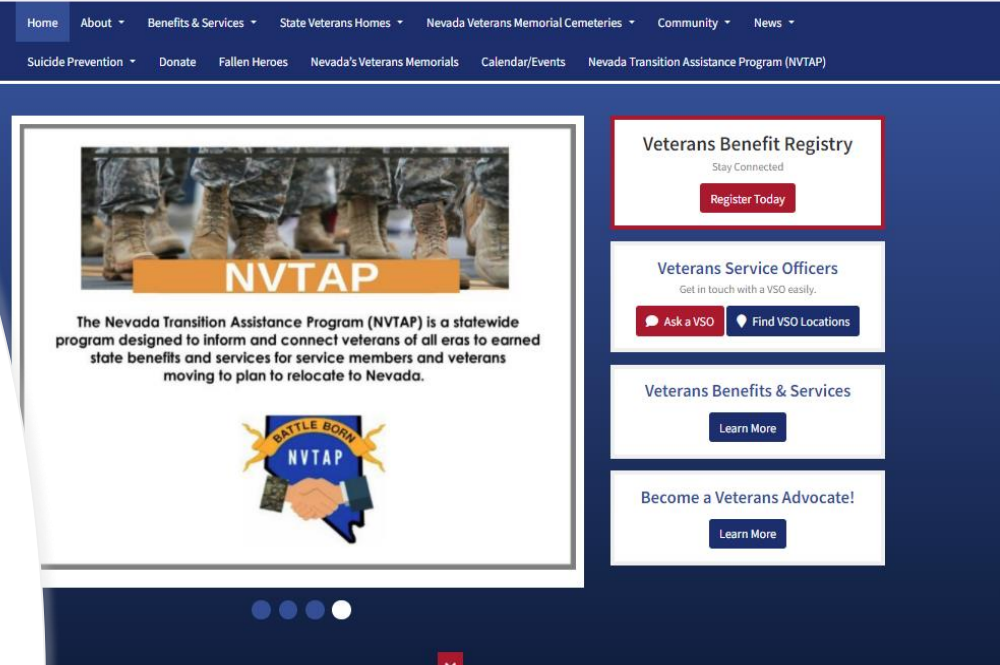


Transition Challenges

- Identifying transitioning servicemembers/families
- DoD/VA/DOL Transition Assistance Program (TAP) does not cover state benefits
- There is not a single "Transition Services" center or portal for veterans, although several nonprofit organizations have tried
- Veterans moving to Nevada years after leaving military service still need transitional services
- Three-in-four veterans do not have a civilian job lined up after leaving the military
- Transitioning servicemembers (SM) have limited professional and social networks to support transition

NDVS Transition Support

- Welcome Home Letters
- Informative Website
- NV Transition Assistance Program
- Outreach to transition centers at active-duty locations with high number of SM moving to Nevada
- Veterans Benefit Registry
- Joint Military Affairs (JMAC) and NASDVA Partnerships

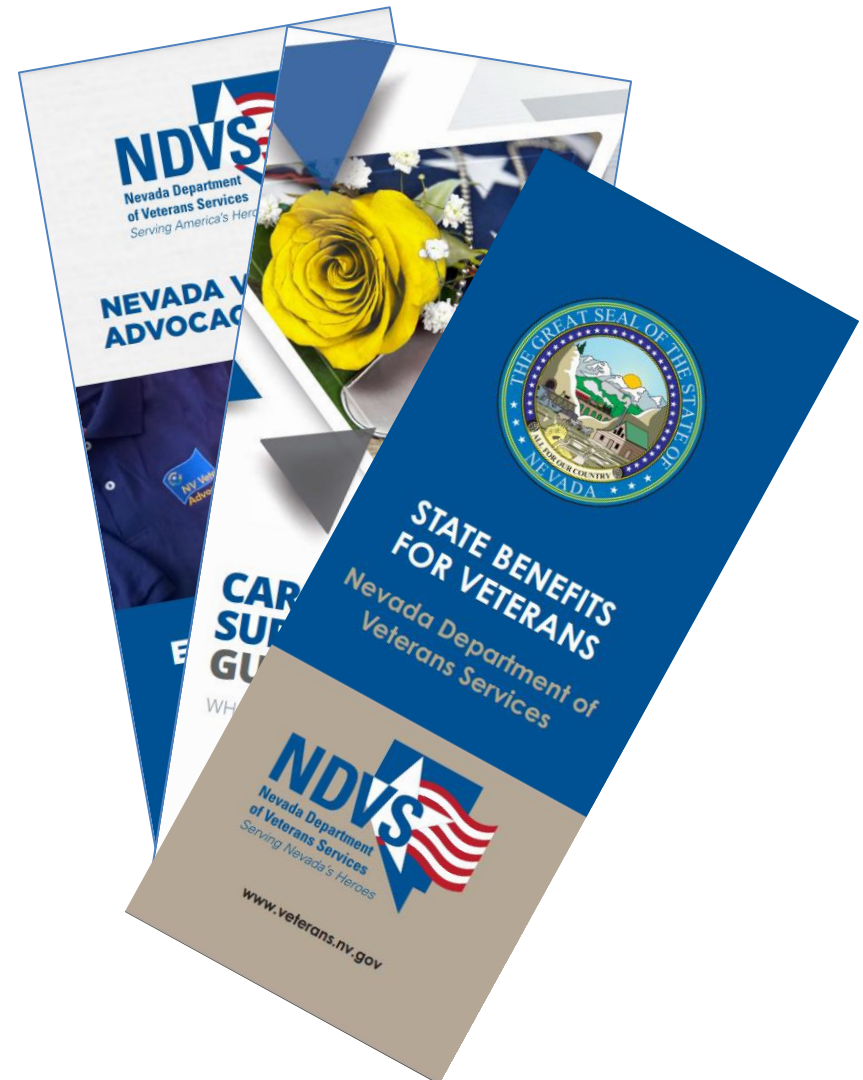

81st Session Veterans Legislation (1)

- **AB 22:** NV TAP. **Status:** Launched 1 Nov 2021. In-person TAP programs begin in 2022
- **AB 28:** Inverse preference on state purchasing contracts. **Status:** implemented
- **AB 76:** Authorizes NDVS to establish / operate adult day health care facilities. **Status:** Needs/affordability study underway
- **AB 77:** Adds veterans suicide prevention and homelessness programs to NDVS statutory duties. **Status:** Hired two contracted program managers
- **AB 102:** Expands disability requirements for the issuance of annual parks permits. **Status:** Implemented
- **AB 121:** Revises the military overseas voting deadlines. **Status:** Implemented
- **AB 156:** Allows NNG members to transfer NSHE tuition waiver to a spouse or child. **Status:** Implemented

81st Session Veterans Legislation (2)

- **AB 165:** Removes 5-year limit on assessing certain tuition charges against honorably discharged veterans. **Status:** Implemented
- **AB 316:** Requires the disclosure of certain information concerning veterans' benefits events. **Status:** Implemented
- **SB 185:** \$500,000 to the Department of Veterans Services to provide financial assistance and support for the Adopt a Vet Dental Program. **Status:** Funds distributed quarterly
- **SB 193:** Veterans admissions preference. **Status:** Implemented.
- **SB 390:** Establishment of mental health crisis hotline. **Status:** Nevada 988 is scheduled to launch July 16, 2022.
- **SB 440:** Created a NNG sales tax holiday on Nevada Day. **Status:** Implemented by the Department of Taxation

82nd Legislative Symposia Results



- March 2022: Legislative Symposia held in Las Vegas and Reno. 161 Participants representing 16 state-wide veterans' organizations.
- Identified / prioritized 70 State issues (33 in LV, 37 in Reno); includes duplicates. **47 Unique State Issues**
- Identified / prioritized 17 Federal issues (9 in LV, 8 in Reno); includes duplicates. **14 Unique Federal Issues**
- **Themes:**
 1. Improve medical and mental health care programs, especially those associated with dental health and suicide prevention.
 2. Require service providers to implement the, “Ask the Question” Program to improve veterans' health care outcomes.
 3. Honor veteran's service by reducing certain state fees, offering preferences, and providing medical time off veterans
 4. Improve occupational licensure for veterans and military spouses
 5. Improve programing for veterans in / transitioning from justice system

Homelessness Among Nevada Veterans

3 Nevada Continuum of Care's (CoC). Purpose: organize efforts of local governments, nonprofits, and stakeholder groups to end homelessness in their region. *Annual state-wide coordination/no centralized oversight.*

- Clark County
- Northern Nevada
- Rural Nevada

Point in Time (PIT) Counts:

- 2020 – Total: 7072. Veteran: 920/13% (SN: 734, NN: 148, RN: 38)
- 2021 – Total: 7090. Veteran: 832*/12% (SN: 644, NN: 188 (RN: Unknown))

NDVS Strategic Objectives

- Convene CoC state-wide workgroups focusing on veteran homelessness
- Determine service gaps, work with partners to develop solutions
- Connect veterans who are homeless, or at risk of homelessness, with supportive services
- Provide veterans with affordable rental and home ownership information
- Identify and publish resources for Nevada's homeless veterans

* According to the RNCoc, Report Volunteers conducted an observation-only count within 14 of 15 counties
