

## **Bullying Prevention and Response**



- Per Assembly Bill (AB) 371 (2021), bullying brochures for parents/caregivers have been updated to reflect the new language which includes discrimination based on race.
  - The new brochures are currently being distributed to schools to share with parents/caregivers in English and Spanish.
- NDE has received feedback from stakeholders including district and school administrators regarding statutory requirements around bullying investigations and reporting. Their requests include action to:
  - Clarify statutory language to clearly distinguish between conflict and bullying. This is an important clarification in restorative practices work for schools (NRS 388.122)
  - Extend the number of days allowed for a bullying investigation from 2 to 5 to allow for a thorough and accurate, yet still timely, investigation. This will allow administrators to prioritize immediate parental consent and safety plans; then allow the schools to move to investigation (NRS 388.1351 (5))
  - Remove duplicative reporting requirements (NRS 388.1351 (13)) 0

## **School Safety Updates**



- Nevada districts/charter schools are currently refreshing their training around Threat Assessment protocols and procedures in the 2021-22 school year.
- The Statewide Committee on School Safety continues to meet and is working on recommendations regarding school safety (including addressing concerns around the safety of school staff) to send to the Governor.
- 2022 Statewide School Safety Conference is scheduled for September 23-24.
- In June NDE will host the first Statewide school bus transportation meeting since the pandemic and will provide updates on driver's training manuals and bus standards.
- Funding has been released for districts/charter schools to provide bullying prevention training and education. More funding will be available in Fiscal Year 23-24.
- As required in NRS 388.253 all district/charter/private schools are required to submit their Emergency Operations Plans by July 1.
- Districts should implement site-based safety inventories and use federal relief funding for upgrades to buildings and grounds if needed.




## **School Discipline by Race/Ethnicity**






## **School Discipline by Gender**






## **School Discipline by Special Populations**






## **Suspensions by Incident Type**

## The Importance of School Climate



To address school violence, prevention efforts implemented at universal, primary levels should include:

- Creating a climate with a low tolerance for bullying (Laursen, 2011)
- Educating students and all school employed personnel about the warning signs and risks associated with violent behaviors, in an effort to reduce the acceptance or downplaying of pathological behaviors (Cowell, 2013; Flannery, et al, 2012)
- Zero tolerance policies have not been found to be effective, and may even escalate problems with violence in schools (Flannery, et al, 2012; Laursen, 2011; Johnson, et al, 2011)

## **School Climate Survey**



NRS 385A.650 requires school principals to submit a plan to improve the achievement of pupils

- The plan must include "methods for evaluating and improving the school climate"
- School climate: "means the basis of which to measure the:
  - relationships between pupils and the parents or legal guardians of pupils and educational personnel,
  - the cultural and linguistic competence of instructional materials and educational personnel,
  - the emotional and physical safety of pupils and educational personnel and the
  - social, emotional and academic development of pupils and educational personnel"

## 2021 School Climate Survey Results



#### Impacts of COVID-19 on School Climate Results:

- Participation rates decreased, which increases the potential of selection bias on the applicability survey results
- Statewide results for the 2020-21 school year became more favorable across all four school climate constructs
- Results for the Physical Safety construct had the largest shift toward more favorable scores
  - Fall 2019: Index Score of 367
  - Spring 2021: Index Score of 408
- The results for all three school climate surveys are expected to return to results more in line with previous school years for the 2021-22 school year



All Nevada Students by Race/Ethnicity



67% response rate for students in 5th-12th grades



All Nevada Students by Race/Ethnicity




## **School Climate Emotional Safety**



# Physical Safety All Nevada Students by Race/Ethnicity




## **School Climate and Gender Identity**

(NV-SCSEL Survey: Grades 9 - 12 only)




## **Gender Identity**





## School Climate Constructs NV Students by Grade






## **School Safety Next Steps**



- Governor's Committee on School Safety will publish recommendations by August 2022 that will address both student and staff safety
- Progress monitor staff and student climate survey results for improvement
- Continue to strengthen SafeVoice response features for threat assessment and student well checks
- Continue to embed climate strategies into district and school improvement planning practices to strengthen preventative efforts
- Continue to monitor school discipline data to ensure student and staff safety while also reducing discipline disparities
- Continue and enhance communication with districts for training and resource needs around school safety
- Clarify bullying and conflict in NAC or NRS to assist LEAs in implementation and reporting
