

## Nevada Sentence Credit Guide

Information used from the Judgment of Conviction (JOC) to calculate the offender’s sentence is the sentence date, the jail credits if applicable, and the term of imprisonment.

- Retro** – Sentence date minus any jail credits if credited in the JOC
- Flat** – Each day served is a credit day earned/calendar day
- Stat** – Statutory Good Time credits allowed by NRS for good behavior (NRS 209.4465)
- Work** – Credits for diligence in work/school (NRS 209.4465)
- Meritorious (MERIT)** – Credits for the completion of programming (NRS 209.449)
- Minimum (MIN)** – Minimum sentence ordered by a judge
- Maximum (MAX)** – Maximum sentence ordered by a judge
- Parole Eligibility Date (PED)** – Minimum sentence with credits applied, as applicable if granted parole
- Projected Expiration Date (PEXD)** – Maximum sentence with credits applied, as applicable

### Sentence Credits Guide without Programming

Offenders are sentenced by the court to a prescribed time frame. The sentence prescribed is documented in the JOC received with the offender by the Nevada Department of Corrections (NDOC).

The JOC sets forth the prison sentence, or the **MAX** days owed by the offender. The **MAX** days owed are entered into the computer system as written by the court. **The offenders’ credits are then projected with all the FLAT, STAT and WORK days until the days remaining counts down to zero (0).**

The example below shows when an offender is expected to be released if only **FLAT** credits were applied. With only the **FLAT** credits applied, the **Parole Eligibility Date (PED)** would be January 1<sup>st</sup>, 2021, and the **Projected Expiration Date (PEXD)** would be December 31<sup>st</sup>, 2022.

Per NRS chapter 209, the felony category, offense type, and sentence structure will determine how credits are distributed to the **MIN** and **MAX**, as applicable. For the example below, the guide is based on a non-violent category C felony.

If only **FLAT** credits were applied:

## Sentence Credits Guide with Programming

When **FLAT**, **STAT**, and **WORK** credits are applied to this offender's **MAX** days owed, the **PED** is adjusted to July 3<sup>rd</sup>, 2020, and the **PEXD** is adjusted to July 5<sup>th</sup>, 2021. Because this offender will not be present the full month of July, the **STAT**, and **WORK** credits are prorated.

**NOTE:** Credits and days are equivalent; one credit equals one day.

With **FLAT**, **STAT**, and **WORK** credits:

Possible release dates are **projected** using credits not yet earned to give estimated benchmark dates i.e., **PED**, Mandatory Parole Review (MPR), and **PEXD** to an offender upon arrival. The dates given to an offender are best case scenario and are subject to change. If an offender does not remain assigned to work/programs or if they have **STAT** time forfeited (NRS 209.451), the estimated date previously given will adjust to reflect an offender's most recent activities. Conversely, if additional **Meritorious** credit beyond the **FLAT**, **STAT**, and **WORK** credits are earned, the estimated dates can reflect a date sooner than previously **projected**.

## Sentence Credits Adjusted After Additional Programming Is Recorded

When an offender receives additional credits beyond the **FLAT**, **STAT**, & **WORK** due to **MERIT** credits, the **MERIT** credits are subtracted from the **MAX** days owed ordered in the original JOC. The **MERIT** credits are not subtracted from the **PED** or the **PEXD** that were previously estimated, they are subtracted from the **MAX** days owed, it may affect the **PED** and **PEXD**, if applicable.

With **FLAT**, **STAT**, **WORK**, and **MERIT** credits:

When **MERIT** credits are applied to this offender, the **PED** is adjusted to June 2<sup>nd</sup>, 2020, and the **PEXD** is adjusted to June 5<sup>th</sup>, 2021.
