
Primary Division Functions

The Division of Parole and Probation fulfills a critical public safety need through the thorough investigation and effective supervision of offenders by:

- Conducting pre-sentence investigations for the District Courts of Nevada
- Conducting pardon investigations and making recommendations to the Board of Pardons Commissioners
- Conducting pre-parole, conditional release and incoming Interstate Compact investigations to ensure appropriate community placement and supervision for offenders
- Monitoring and enforcing offender compliance with conditions of their community supervision while on parole, probation or as an inmate on residential confinement
- Reporting behavioral misconduct and supervision violations to the sentencing courts and the Parole Board
- Collecting restitution payments and disbursing monies received to victims of crime
- Re-entry planning using indigent funding to support our most difficult to place parolees



Current Supervision Population








Current Supervision Population by Gender

Probation






Staffing and Vacancies

The Department and Division are working diligently to fill both sworn and non-sworn vacancies.

Parole and Probation continues to experience a significant attrition rate due to other job opportunities, resignations and retirements.


The Division has a total of 586 positions with an overall vacancy rate of 21.8% (128 vacant positions).





Staffing and Vacancies


- Statewide the Division currently has 312 Sworn Positions 73 of which are vacant.






Staffing and Vacancies

- Statewide the Division currently has 274 Non-Sworn Positions 55 of which are vacant.






Staffing and Vacancies Historical

Records Management System (RMS)

- Current RMS was deployed in 1999 and has remained largely unchanged.
- 20Teens multi-year long project with EITS did not result in a new RMS.
- August 2020, contracted with Tyler Technologies. Contract was terminated in December 2021 upon mutual agreement.
- March 2022, engaged with cFive to configure a largely off the shelf RMS; scheduled for full deployment in the 4th Quarter of 2023.





Application of Earned Compliance Credit

- Parole 209.4475
 - 10 days of credit for meeting financial obligations.
 - 10 days of credit for employment, education or rehabilitation.
- Probation 176a.500(6)*
 - 10 days deducted from expiration date for meeting financial obligations.
 - 10 days deducted from expiration date for employment, education or rehabilitation.

** Potential BDR as 176a.500(1) allows for a court to order a fixed term of probation, however 176a.500(6) says a person on probation must be allowed for the deduction of days*
