1a) CREDITS: Offender Management Division (OMD) Confusion?

A staff member answered concerning disabled prisoner credits per Sisolak/USDOJ settlement Feb 11, 2021:

"I was mistaken about the settlement pertaining exclusively to minimum custody eligible offenders. Offender Management Division has nothing to do with offering work credits. XXXXXXXXX will have to take this issue up with his unit caseworker and the medical department at the XXXXXXXXX Correctional Center.

As for the list of ADA facility managers I suggest contacting the individual institutions for that information."

Are NDOC officials honoring the Sisolak/USDOJ agreement and administering it properly?

We have reason to say, "No."

Failure to follow the USDOJ instructions is detrimental to health, and safety, and is costing us.

3) Please investigate:

With enormous profits from NDOC prison stores and telephones and message services services and charges for .mpgs, is it prudent, wise and healthful to allow expired pretzels (2010, yes,

2010, not a typo) as part of our prison diet? Did a nutritionist know that these are being served?

4) Please investigate:

Forced to shovel snow in worn out tennis shoes? Did an NDOC officer tell the prisoner who asked him for boots because his feet were freezing reply, "You're S*** out of luck!"

(See attached photo in court case.) Is this alleged officer still employed? If so, why?

5) Please require:

that NDOC make available immediately, the new suicide hotline, now available to Nevada free citizens. Is this discrimination against NV prisoners? Yes.

7) Public Info Request Lost?

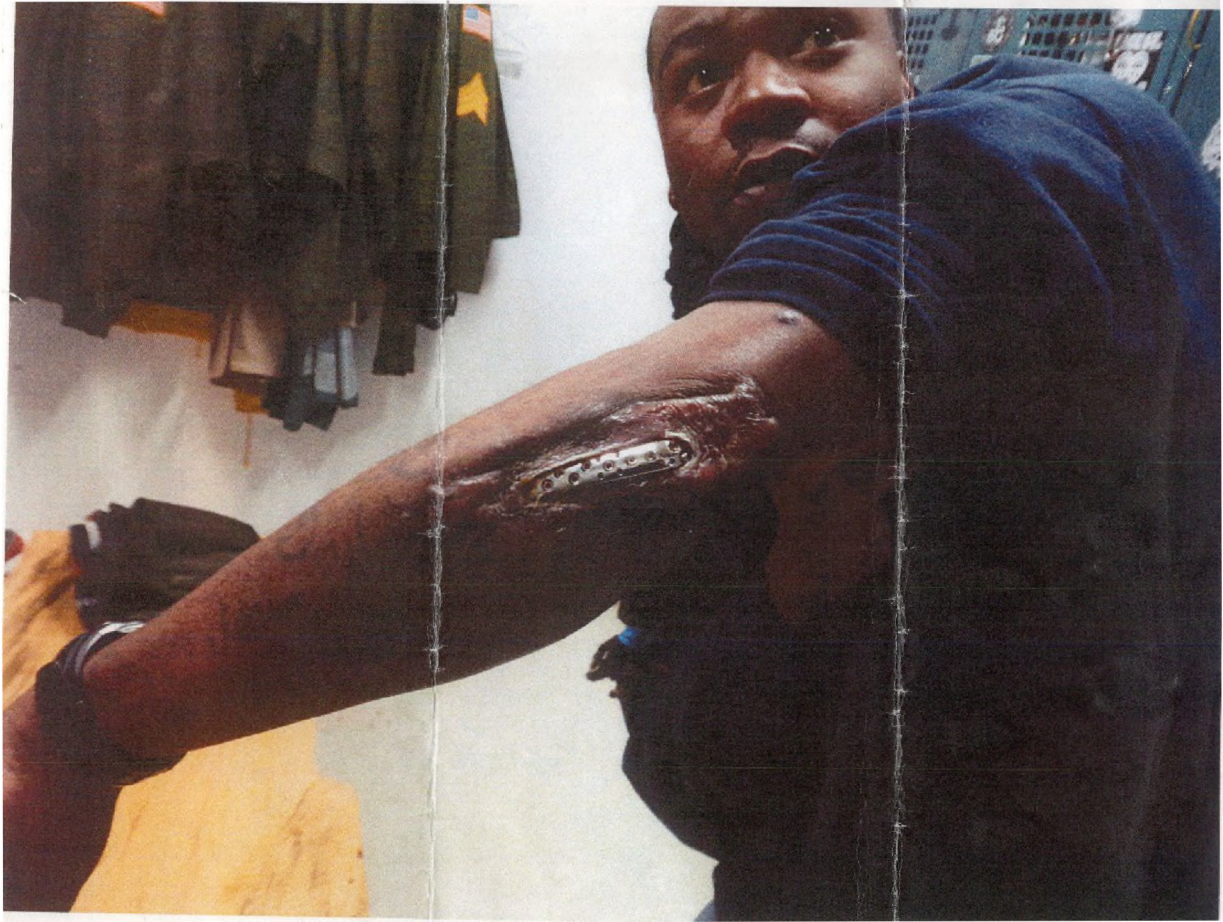
Still no acknowledgment or answer to our public info inquiry regarding NDOC suicide data. See attached.
