

## Foreign Ownership of Land 2024 State Legislation

Updated January 23, 2024

Legislation is currently pending in 16 states in 2024 regarding foreign ownership of land.

			real property to provide a signed affidavit attesting that the
			buyer is not a foreign principal.

			indirect interest if any ownership is the result of the foreign principal's ownership of registered equities in a publicly
			traded.

Wisconsin	2023 SB 264	Pending- Carryover	Prohibits a foreign adversary from acquiring agricultural or forestry land in this state. Retains the current law restriction
	2023 SB 269	Pending- Carryover	on foreign person ownership of agricultural and forestry land and adds a provision that prohibits a foreign adversary from acquiring any land for agricultural or forestry purposes.
	2023 AB 349	Pending- Carryover	Prohibits certain foreign persons from acquiring more than 50 acres of agricultural or forestry land in the state, changes
	2023 SB 348	Pending- Carryover	enforcement authority regarding foreign ownership of agricultural or forestry land from the attorney general to the Department of Agriculture, Trade and Consumer Protection, and makes other changes to state laws restricting ownership of agricultural or forestry land by foreign persons.
