## Nevada's Juvenile Justice Services Adult vs. Youth Corrections

**Adult** Youth

- 18+
- Adult Jails/Detention Facilities
- Conviction
- Determinate Sentencing
  - Time in corrections determined by law
- Punishment & Retribution
- May choose to participate in inmate work program
- Criminal record of all crimes

- Age 8-20
- Juvenile facilities
- Adjudication
- Indeterminate Sentencing
  - Time in corrections determined by youth's progress within the program
- Rehabilitation
- Required to participate in education until high school diploma or equivalency
- Some records may be sealed

# Juvenile Justice Delinquency Prevention Act (JJDPA)

- Strengthen the deinstitutionalization of status offenders
- Reduce racial and ethnic disparities
- Improve sight and sound core protections
- Impact of exposure to violence and trauma on behavior and development
- Encourage family engagement
- Utilization of evidence-based practices
- Improve conditions of confinement for all youth under the age of majority
- End certain restraints for pregnant and laboring females
- Address needs of females and Tribal youth

- Nevada Youth Training Center (NYTC)
  - Elko
  - Capacity Overall: 140, Budgeted: 64
  - Co-ed as of December 2022
  - Staff Secured
- Caliente Youth Center (CYC)
  - Caliente
  - Capacity Overall: 140, Budgeted: 80
  - Co-ed
  - Staff Secured
- Summit View Youth Center (SVYC)
  - Las Vegas
  - Capacity Overall: 96, Budgeted: 48
  - Secured

### Youth Parole Bureau

- NRS 63.710-Duties of Chief of Youth Parole Bureau
- Mental Health Team
  - Assess all committed youth
  - Refer youth to appropriate Mental Health Services and placements
- Supervision and Case Management
- Interstate Compact for Juveniles (ICJ)



# Juvenile Justice Programs Office Authority

• Juvenile Justice and Delinquency Prevention (JJDP) Act (Pub. L. No. 93-415, 42 U.S.C. § 5601 et seq.)

• The JJPO conducts its work in Nevada through a Governor's Executive Order.



## Juvenile Justice Programs Office

- Responsible for all state and federal oversight of the juvenile justice system (County and State)
- Grant Management:
- Formula Grants (Annual)
  - Title II Formula Grant (Federal)
  - Title I Education Grant (Federal)
  - Community Corrections Partnership Block Grant (State)
- Competitive Grants (One-Time)
  - Prison Rape Elimination Act (Federal)
  - Juvenile Justice Delinquency Prevention Act (Federal)



## Juvenile Justice Programs Office

- Compliance with the Juvenile Justice Delinquency Prevention Act (JJDPA)
- Compliance with the Prison Rape Elimination Act (PREA)
- Quality assurance for state facilities, youth camps, and the Youth Parole Bureau
- Collection and dissemination of juvenile justice data statewide



# Juvenile Justice Oversight Commission Background

• AB 472 (Juvenile Justice Reform Bill of 2017) was codified in several sections of NRS including 62B, 62E, and 62H.

NRS 62B.600 establishes the Juvenile Justice Oversight Commission (JJOC)



## Juvenile Justice Oversight Commission Roles

NRS 62B.615 -Develop and Implement a 5-year Strategic Plan every 5 years.

• Federal Compliance with the Juvenile Justice Delinquency Prevention Act through Executive Order.



## JJOC Strategic Plan Updates

#### **GOAL 1: Assessments & Screening:**

• Ensure risk and needs assessments and mental health screenings are completed for children prior to disposition.

#### **GOAL 2: Proven Programs:**

• Implement evidence-based programs, practices and services proven to reduce recidivism.

#### **GOAL 3: System Collaboration:**

Collaborate across systems to address youths' needs.

#### **GOAL 4: Tailored Services:**

Tailor supervision / services to youths' developmental needs.



## Legislative Bill Updates

• AB 183 – Commercial sexual exploitation screening

• AB 193 - Custodial interrogations of a child prohibitions

  - Alignment with federal requirements
