Educator Scholarships

Teach Nevada Scholarship (TNS)

- State funded scholarship established with SB 511 (2015)
- Provides funding for tuition, books, and fees
 - Awarded by the State Board of Education to both traditional and alternative route approved educator preparation programs
 - Educator preparation programs grant scholarships to students each year who are alternative route, freshmen, sophomore, or junior year students
 - Pays 75% of the cost of the preparation program
 - Pays \$1,000 to preparation programs for each student who completes the program
 - Pays 25% of the cost of the preparation program after the educator completes five years of teaching in a Nevada public school



Nevada Teacher Advancement Scholarship (NTAS)

- State funded scholarship established with AB 400 (2023)
- Provides funding for tuition, books, and fees
 - Awarded by the State Board of Education to traditional route approved educator preparation programs
 - Educator preparation programs grant scholarships to students each year who have completed at least two years of teaching in a Nevada public school and are seeking a master's degree in education or a related field
 - Pays 75% of the cost of the preparation program
 - Pays \$1,000 to preparation programs for each student who completes the program
 - Pays 25% of the cost of the preparation program after the educator completes three years of teaching in a Nevada public school



Incentivizing Pathways to Teaching (IPT)

- Federally funded scholarship with ESSER II during FY22 & FY23
- State funded scholarship established with AB 515 (2023)
- Provides funding for tuition and paid clinical experience
 - Awarded by the State Board to traditional route approved educator preparation programs
 - Educator preparation programs grant scholarships to students each year who are finishing their final year of coursework and clinical experience
 - Pays 100% tuition cost during the final year of the preparation program
 - Pays stipends during the clinical experience

^{*}Amount of tuition and stipends are determined by each preparation program considering the unique circumstances of each student's financial aid needs and their federal cost of attendance limit.



Assembly Bill 428 Section 9 (2023)

- The Nevada Legislature has implemented a series of measures to address barriers into the teacher workforce.
- It intends to increase and retain licensed Nevada educators.
- The Nevada Department of Education (NDE) engaged WestEd to examine the barriers to scholarship opportunities and identify considerations for expanding access to them.
