Innovation: We are a continuously learning and improving organization that grows through experience, feedback, and evidence-informed practices.



Agency Improvements

- Forensic Mental Health
 - The forensic admission list has seen a 39% reduction in the past 12 months following the addition of forensic beds and implementation of numerous initiatives, including:
 - Establishing a jail liaison for the purpose of diverting forensic clients to a more appropriate level of care.
 - Continued support for the recruitment of specialized clinical staff.
 - Expansion of community-based placements for long-term clients while remaining under the supervision of DPBH.

Public Health

- Active participation in the first Academic Health Department with the University of Nevada, Reno and DHHS.
- DPBH submitted the application for accreditation with the Public Health Accreditation Board
- DPBH became one of only a few states that have received Advanced Recognition as an <u>Age-Friendly Public Health System</u> (AFPHS) from the Trust for America's Health and the John A. Hartford Foundation.



Division of Public and Behavioral Health Budget Priorities

DPBH Nevada's Crisis Response System

Governor's Priority Plan 3.3.2, 3.5.2, and 5.3.2

- Carelon Behavioral Health to provide Nevada a second 988 Suicide and Crisis Lifeline call center.
 - Main objective: increase in state answer rates to 90% and provide Nevadans with appropriate connections to services.
- Co-Location
 - Nevadan Crisis Counselors in the same room as 911 dispatchers at Las Vegas Metro dispatch; potential for Washoe County co-location, too.
 - Creates seamless transition between 988 and 911 calls, as needed
- Additional components of the Crisis Response System
 - Mobile Crisis: Direct dispatch of mobile crisis team from 988 center to the person in crisis
 - Crisis Stabilization: Person in crisis can be transported to a crisis stabilization center (CSC).
 - STATUS:
 - Northern Nevada: Renown CSC to open in 2025
 - Southern Nevada: Clark County University Medical Center planned to open in 2025



DPBH Budget Priorities, continued

Public Health

Governor's Priority Plan 2.1.3, 5.3.2, and 5.3.3

- Transfer of Environmental Health Services overseeing inspection and regulation of food establishments, shellfish distributors and bottled water to the Nevada Department of Agriculture. Governor's Priority Plan 2.1.3, 5.3.2, and 5.3.3
 - Decrease duplicative processes between agencies and allow the Department of Agriculture the ability for program implementation and regulatory authority.
- Proposed move of Health Care Quality and Compliance to the newly forming Nevada Health Authority.
 - Enhance and streamline services.




