Dr. Mr. Anthony,

During the May 2016 ACAJ meeting, the Division of Parole and Probation was tasked with the preparation of several follow up topics. Included in this packet you will find for your review the following items:

- Names of category E felony probationers whose probation was revoked delineated by county
- Copy of Sentence Recommendation Selection Scale
- Copy of current risk and needs assessment tool

In addition to the above attachments, the Division was also requested to specify how many Pre-Sentence Investigation reports were completed between February 2015 and February 2016 (see PSI PowerPoint presentation slide #11). According to our records the Southern Command completed 7616 reports and the Northern Command completed 3441 reports for a total of 11,057 reports. Additionally the committee inquired if the Division records reflected the concurrency deviations. The Division records only reflect whether or not the court agreed with the recommendation for probation or prison not if the specific prison term or probation terms deviated in any way from the initial recommendation.
