RE: AB267 Update

Please find attached a report outlining the actions that have been taken by the Board in reference to those inmates currently qualified for parole consideration under AB267.

## AB267 Action/Status Report

The number of eligible inmates seen as of May 26, 2016 is thirty-five. As the result of those thirty-five hearings, three have been rescheduled to the July agenda for various reasons. Of the thirty-two hearings that resulted in a decision, sixteen were granted parole and sixteen were denied parole. I have asked the Board to review four of the denials for possible re-hearing. There are an additional forty-six inmates who are eligible for AB267 consideration once they have met the minimum time served requirements. Those forty-six will be scheduled from later in 2016 to as far out as 2034.

Some of the reasons noted for denial:

Recent Disciplinary offenses to include; fighting, drug use (methamphetamine, opioids), alcohol production and consumption, recent gang activity, high risk sex offender

Also note that those inmates committing their crime under the age of 16 may also have been heard under NRS 213.1215 (2) and if they meet the requirements are mandatorily paroled whether or not that would have been the decision of the Board.
