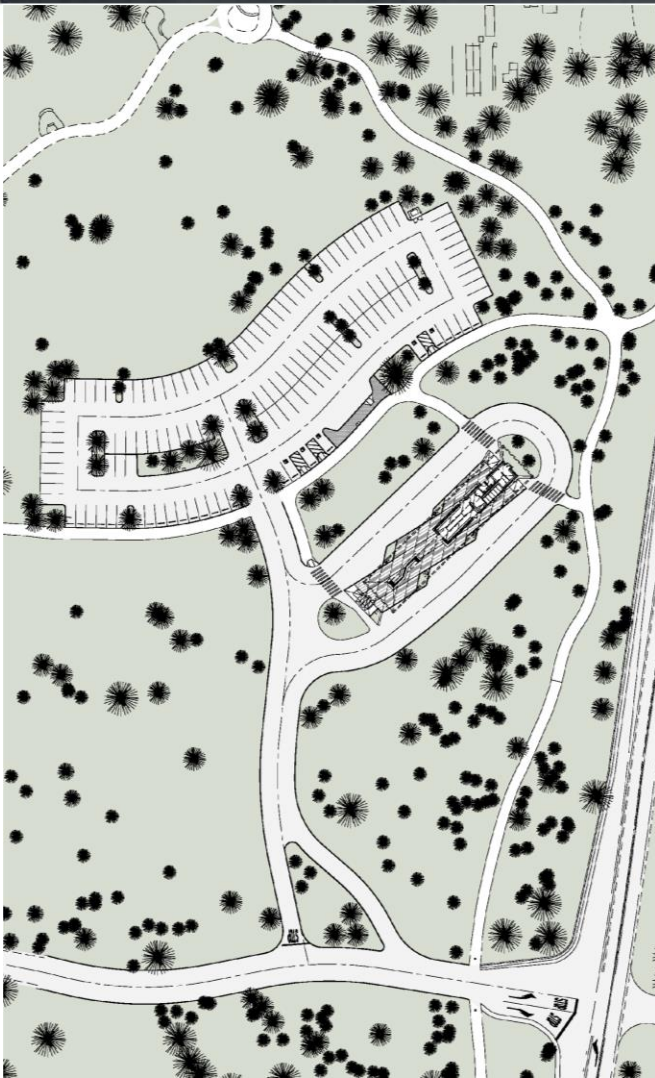

- Entrance/exit including turn pockets onto US 89 to reduce traffic delays.

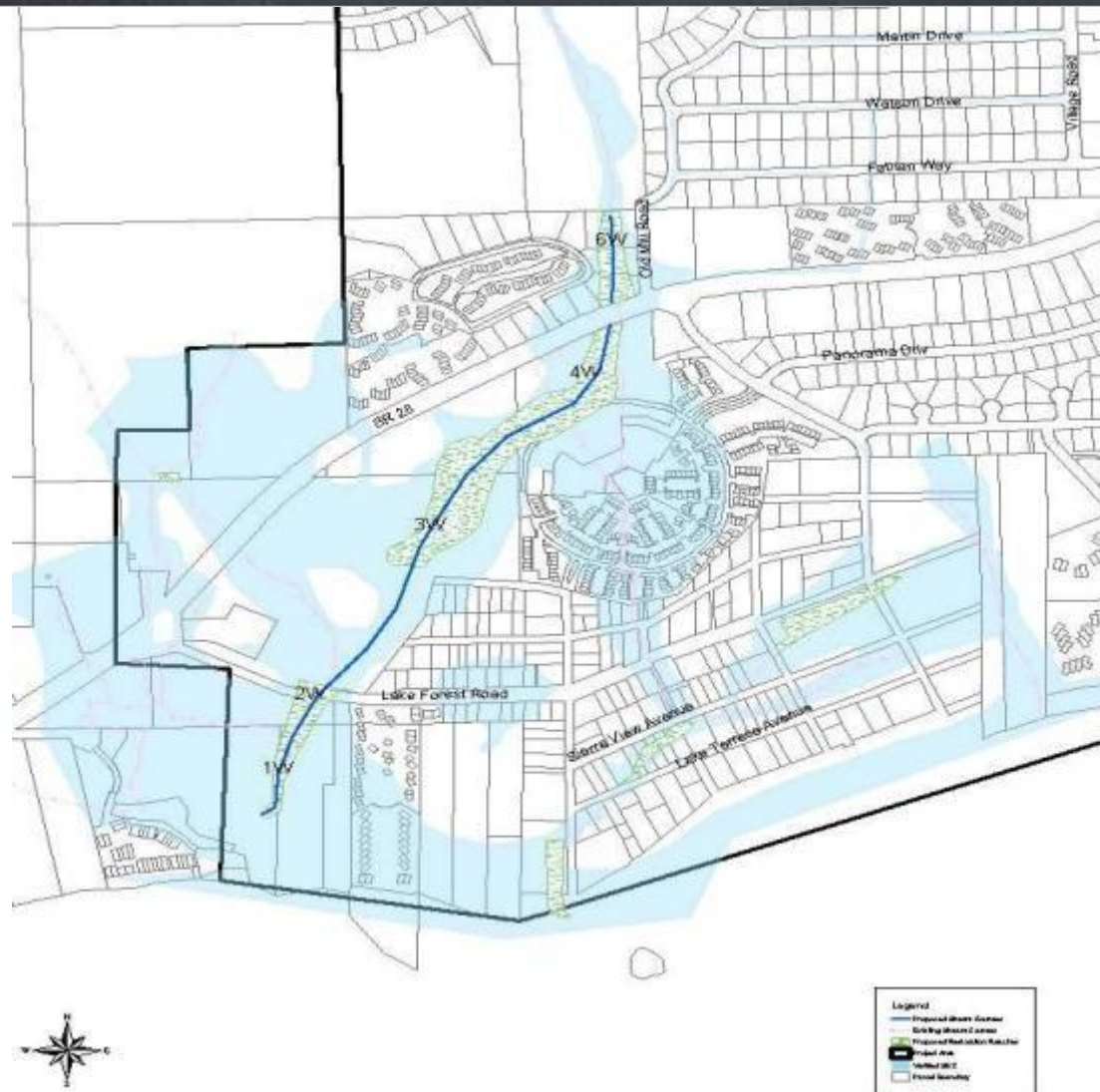

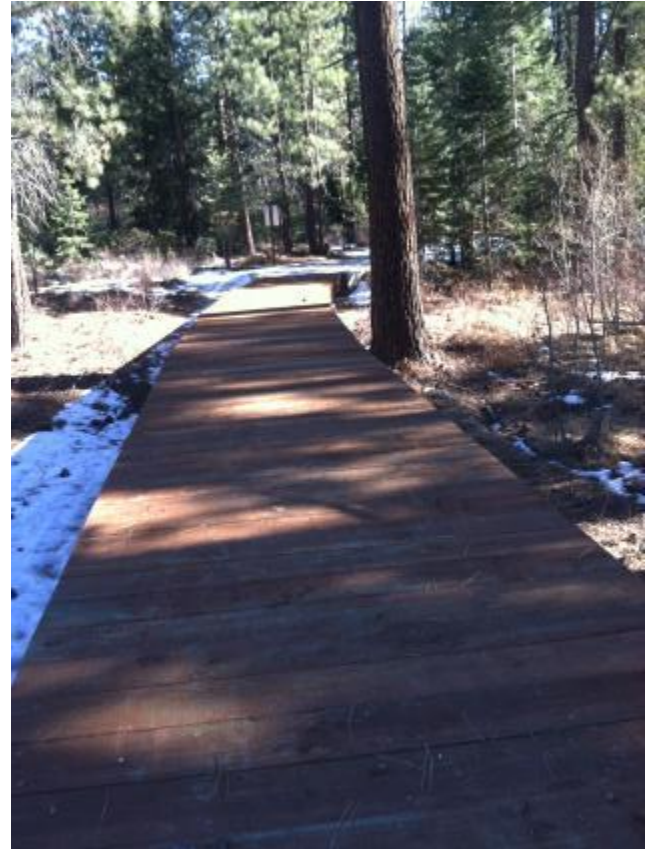
