Eligibility Criteria

- To enroll in a qualified health plan (QHP) must be:
 - Legal resident of Nevada
 - Not incarcerated
 - To be eligible for a tax credit must:
 - File taxes (if married, file jointly)
 - Be enrolled in a QHP
 - Income below 400% FPL


Statistics – October 1 - March 31

- Website: 20.9 million hits; 2 million unique visitors
- Eligibility Determinations – 382,874*
 - QHP w/ APTC – 86,324
 - QHP w/o APTC – 44,710
- Confirmed Plan Selections
 - QHP – 41,823 (25,899 paid)
 - Dental Plans – 45,961 (23,553 paid)



Carrier Enrollment Amount




Carrier Enrollment Percentage




Service Area Enrollment Amount

Statistics – Special Enrollment Period

Special Enrollment Period:

April 1, 2014 to May 30, 2014

- Confirmed Plan Selections (as of 5/25)
 - QHP – 48, 711 (35,715 paid)
 - Dental Plans – 50,900 (30,094 paid)

* Includes Medicaid/CHIP and ineligible

Exchange Funding Mechanisms

- The Exchange will be funded by a Per Person Per Month (PMPM) charged to the participating insurance carriers.
- Original enrollment goal of 118,000 cut to 50,000
- In April of 2014 the Board increased the PMPM from \$4.95 to \$13.00, budgeting for 60,000 members enrolled by 2/15/15.

Moving Forward

- On May 20, 2014 the Board voted to become a Supported State Based Exchange and use the Federal IT architecture for the 2015 plan year open enrollment.
 - The Board has requested a full Request for Proposal on new alternate systems.
 - The Board voted to end the relationship with Xerox.

Supported State Based Marketplace

Nevada will retain:

- Plan certification, rate review and network adequacy monitoring.
- Medicaid eligibility and enrollment.
- Marketing and Advertising
- Exchange Enrollment Facilitator program oversight.
