What We Do

- Our Mission:
 - To protect the rights of Nevada consumers in their experiences with the insurance industry and to ensure the financial solvency of insurers. In order to fulfill its mission, the division will advance a sound regulatory environment that is responsive to the insurance needs of Nevada.
- Regulate Nevada's \$11.5 billion insurance industry.
 - Protect Consumers:
 - Respond to more than 21,000 consumer contacts per year.
 - Investigate more than 2,300 consumer complaints per year.
 - In calendar year 2013, the Division recovered \$4.4 million for consumers in Nevada.
 - Ensure solvency of insurance industry.
 - License companies and producers.

Impact of the Insurance Industry

- Generates more than \$240 million in premium tax for the General Fund.
- The Division collected \$27 million in additional General Fund revenue from assessments, fines, and license and registration fees.
- There are 2,173 admitted carriers in Nevada.
 - Of these 200 companies are domestic.
- Total of 11,077 firms and 102,987 individual licensed producers.
