On May 23, 2011, Assemblywoman Debbie Smith entered a resolution to create a State Plan for Alzheimer's in Nevada.

As the plan worked its way through the legislative process, the Alzheimer's Association provided testimony to the work, and helped gather volunteers to speak to legislators.

On June 21, 2011, with the help of many legislators and especially Assemblywoman Debbie Smith, it passed through the Senate Legislative Operations and Elections unanimously and was soon after passed into law.

In July, we worked in partnership with HHS, lobbyists, staff from the Alzheimer's Association in northern and southern Nevada and volunteers to shape the make up of a Task Force, possible sub-committees and the recommendations for potential work areas. These were made knowing we would attempt to generate funding for the project.

Current Reality

- Our recommendations at that time were based on applying for and receiving funding to hire a project director and allow for broad community input.
- However, funding was not received.
- Several States have developed a State Plan in the absence of funding; Kentucky, Arizona and Alabama are currently in process.

Task Force Development

It is with great appreciation of Assemblywoman Debbie Smith, the Support of the Nevada State Legislature and this Committee that we make formal recommendations to begin the State of Nevada Alzheimer's Plan.

We believe that a capable, working Task Force will be the first step and will need to be ready to begin meeting nearly immediately in order to accomplish the directives of ACR-10.

Recommendations -

Provided is a list of our formal recommendations. It is our hope that a member of this Committee will Chair the Task force. We hope this will allow us to accessspace and teleconference capabilities to enhance meeting options.

- We are considering that the work of the Clark County Alzheimer's Action Network (CCAAN) will provide critical information to enhance the Task Force's preparations.
- CCAAN continues to meet, has a core committee, and two members of our proposed task force serve on CCAAN.

Structure

Work groups (as designated) for the Task Force should be headed by one Task Force member, who may draw in community members for specialty expertise.

 These meetings can be held by phone in between the regular Task Force meetings so as to provide input for the Task Force meeting agenda.

Preliminary discussions are underway to identify a graduate student who might work to provide administrative support, produce the documents and recommendations that come from the Task Force.

Process

- The skeleton outline should be available by summer – July or August– for review of the Legislative Committee on Health Care.
- It would be beneficial if the Task Force could continue its work during this time and through 2012.
- This will make it possible to develop the more comprehensive, formal recommendations for the next legislative session of 2013.

With appreciation

- We believe it is possible to meet the demands of ACR-10 without funding.
- It is with sincere appreciation that we recommend moving forward without direct funds, but with the support of you, the Legislative Committee on Health Care and the recommended working Task Force.
