The intent of the HAF assessments is to include a full HAF assessment (worksheets and summary report) with a Land Health Assessment. This is to be performed on some landscape scale level, which may be a watershed, or allotments or some other polygon. The HAF IM has not been issued from the WO and when it is released, there will further written guidance and policy on this. For now, you will not be required to complete a HAF worksheet on a project scale, such as an oil well. But, if you currently have the data needed and have the time, it may be a good idea to complete the 4th Order worksheet and save it for when the landscape scale HAF assessment is scheduled to be completed. This may save you time later on."
