TRUSTEE'S STATUS REPORT 12 13 COMES NOW Chapter Seven Trustee, Allen Dutra, by and through undersigned 14 counsel and files the following Status Report with respect to the Court's August 29, 2016 15 hearing on the Trustee's motion to approve compromise of the estate's claim with the 16 Department of Justice. 17 After the August 1, 2016 status hearing, counsel for the Trustee and counsel for North 18 Lake Tahoe Fire Protection District, Tahoe Douglas Fire Protection District, Meeks Bay Fire 19 Protection District, Lake Valley Fire Protection District and North Tahoe Fire Protection 20 District's (collectively the Fire Districts) entered into settlement negotiations. 21 Prior to filing bankruptcy, the Debtor acquired a Non-Profit Organization and 22 Management Liability Insurance Policy from Old Republic Insurance. The policy has an 23 aggregate limit of \$1,000,000. On January 4, 2012 the United States Department of 24 Agriculture, Office of the Inspector General issued an audit report, 08703-5-SF(10). The 25 Report found that the Debtor did not properly account for the grant funds awarded by the Forest 26 Service, including the \$3.6 million Recovery Act grant and also a \$6.2 million non-Recovery 27

Act grant. The OIG also found that funds from the Recovery grant and non-Recovery grant were commingled with the Debtor's own funds and used to pay unauthorized expenses.

On February 3, 2012 the Debtor sent their Insurance Agent, Menicucci Insurance Associates, notice of the January 4 Report. On February 13, 2012 Karen Faust of Menicucci Insurance Associates forwarded the Debtor's claim to the claim notice department. Old Republic has refused payment upon the Debtor's claims.

An action to reach policy proceeds must name the tortfeasor or the tortfeasor's personal representative as the party defendant rather than proceeding as a direct action against the insurance carrier, commenced by the injured party as a creditor beneficiary. *Reid v. Scheffler*, 95 Nev. 265, 592 P.2d 948, (Nev. 1979).

On August 26, 2015 the Bankruptcy Court entered an order assigning the Debtor's rights against Old Republic to Cross Check wherein the Estate would retain 10% of the amounts recovered by Cross Check. Cross Check filed a claim for \$249,954.52.

The Trustee has agreed to assign the estate's remaining insurance benefits to the Fire Districts. In turn, the Fire Districts will withdraw their opposition to the Trustee's motion to compromise the estate's claim with the Department of Justice.
