AGENDA ITEM I—OPENING REMARKS

Chair Goicoechea welcomed members and the public to the Subcommittee's sixth and final meeting and work session.

AGENDA ITEM II—PUBLIC COMMENT

Chair Goicoechea called for public comment. ([Agenda Item II](#))

AGENDA ITEM III—APPROVAL OF MINUTES OF THE MEETING HELD ON JULY 11, 2016, IN PAHRUMP, NEVADA

MOTION: Senator Hardy moved to approve the minutes of the meeting held on July 11, 2016, in Pahrump, Nevada. The motion was seconded by Assemblyman Oscarson and passed unanimously.

AGENDA ITEM IV—WORK SESSION—DISCUSSION AND POSSIBLE ACTION ON RECOMMENDATIONS

([Agenda Item IV](#))

A. *Cloud Seeding*

1. **A. Request the drafting of a bill** to appropriate \$740,250 per year (\$1,480,000 for the fiscal year 2017–2018 Biennium) to cover 75 percent of the estimated cost for cloud-seeding activities in Nevada during the 2017 and 2018 winters utilizing fully automated generators, as proposed by Desert Research Institute (DRI), within the following areas in Nevada: Upper Walker River watershed; Upper Truckee River/Lake Tahoe watershed; Mount Charleston; and cloud seeding by aircraft in the Upper Walker River Basin, the Upper Carson River Basin, and the Upper Truckee River and Lake Tahoe basins; and cloud-seeding activities in the Humboldt River Basin during the 2017 and 2018 winters utilizing manually operated ground-based generators, as proposed by North American Weather Consultants, within the following areas of the Humboldt River Basin: Independence Range; Ruby Mountains; Toiyabe Range; Santa Rosa Range; Sonoma Range; Humboldt Range; and Diamond Mountains (just outside of the Humboldt River Basin); and direct the State Department of Conservation and Natural Resources (SDCNR) to develop and operate a matching grant program (requiring at least a 25 percent match) to which local stakeholders could apply for funds to undertake cloud-seeding programs. (*Humboldt River Basin Water Authority [HRBWA]*, see Work Session Document [WSD] Tab A.) ([Agenda Item IV](#))

B. Alternatively, **request the drafting of a bill** to amend the statutes to expand the allowable uses of the existing grant program for water projects (NRS 349.980 et seq.), otherwise known as the “AB 198 Grant Program,” (Assembly Bill 198, Chapter 559, [Statutes of Nevada 1991]) to include a cloud-seeding program as an allowable use of grant funds. (HRBWA, see WSD, Tab A.) ([Agenda Item IV](#))

Alysa Keller, previously identified, reviewed Recommendation Nos. 1-A and 1-B. ([Agenda Item IV](#))

Assemblywoman Carlton expressed concern over approving funding for cloud seeding through the AB 198 Grant Program.

Steve Walker, representing Truckee Meadows Water Authority, Carson City, Douglas County, and Eureka County, discussed the status of the grant program.

Several members and Heidi Chlarsen, previously identified, discussed the Recommendation.

MOTION: Senator Hardy moved to approve Recommendation Nos. 1-A and 1-B and any other gifts, grants, and donations.

Senator Ford and Assemblywoman Carlton supported a motion for Recommendation 1-B.

Senator Hardy withdrew his motion to approve Recommendation Nos. 1-A and 1-B.

MOTION: Senator Ford moved to approve Recommendation No. 1-B and any other gifts, grants, or donations in addition to A.B. 198. The motion was seconded by Assemblyman Oscarson and passed unanimously.

B. Domestic Use (Recommendation Nos. 2 through 4 were heard together at the direction of the Chair.)

2. **A. Request the drafting of a bill** to provide that at times of curtailment by priority by the Office of the State Engineer, Division of Water Resources (DWR), SDCNR, only outdoor use withdrawals from domestic wells are curtailed and indoor use remains authorized. (See NRS 534.110.) (*Jason King, P.E., State Engineer, DWR, SDCNR, see WSD, Tab B.*) ([Agenda Item IV](#))

B. Alternatively, **request the drafting of a bill** to provide that at times of curtailment by the Office of the State Engineer, only withdrawals from domestic wells for outdoor water use are curtailed, with an excepted allowance for outdoor watering of pets and livestock. (*Nye County Water District, see Tab C; Utilities Inc. of Central Nevada, Pahrump Utility Co. Inc., and Desert Utilities Inc., see WSD, Tab D.*) ([Agenda Item IV](#))

3. **A. Request the drafting of a bill** to provide that in severely over-appropriated basins and designated critical management areas (CMAs), the Office of the State Engineer may

limit withdrawals from new domestic wells to 0.5 acre-feet annually. According to proponent, this restriction would be applicable to “new” domestic wells on parcels that do not currently have a domestic well. This restriction would not be applicable to currently existing domestic wells. (*Nye County Water District*, see WSD, Tab C.) ([Agenda Item IV](#))

B. Alternatively, **request the drafting of a bill** to provide that no new domestic wells may be drilled in severely over-appropriated basins and designated CMAs. (*Discussion at July 11, 2016, meeting in Pahrump.*)

C. Request the drafting of a bill to provide that in severely over-appropriated basins and designated CMAs, the Office of the State Engineer may require meters on all new domestic wells. (*Nye County Water District*, see WSD, Tab C.) ([Agenda Item IV](#))

4. **Request the drafting of a bill** to provide that the priority date of a domestic well is the date of land possession and remove the provision in statute that provides that the priority date of a domestic well is the date of completion of the domestic well. See Subsection 4 of NRS 534.080. (*Private Well Owners Cooperative of Nye County*, see WSD, Tab E.) ([Agenda Item IV](#))

Discussion was held between members regarding the Recommendation.

Jason King, P.E., State Engineer, Division of Water Resources, State Department of Conservation and Natural Resources, discussed over-appropriated water basins in Pahrump and noted a definition for an over-appropriated basin is not provided in NRS. He voiced support for Recommendation No. 2-B.

Assemblyman Oscarson supported Recommendation Nos. 3-A and 3-B, emphasizing the inclusion of “new” and excluding “0.5-acre-feet annually” and “metering” in a bill draft request (BDR).

Several members and Mr. King held discussion the Recommendation.

Oscar “Oz” Wichman, General Manager, Nye County Water District, in response to Senator Ford’s inquiry, reported how limiting withdrawals from new domestic wells to 0.5 acre-feet annually was determined.

Senator Hardy and Mr. King discussed curtailment associated with domestic wells.

Chair Goicoechea and Assemblywoman Carlton clarified that domestic wells do not have a permitted water right, but noted a property owner is allocated a water duty of up to 2 acre-feet annually.

Mr. Wichman conveyed a preliminary study was performed on domestic wells in Pahrump in an effort to determine withdrawals and sustainability.

Ms. Keller reviewed Recommendation No. 4.

Chair Goicoechea and Assemblywoman Carlton discussed the Recommendation; however, no action was taken on Recommendation No. 4.

Revisiting Recommendation Nos. 2 and 3, Subcommittee members and Mr. King discussed defining “severely over-appropriated basins” in a BDR. Mr. King noted the Office of the State Engineer considers 300 percent to be a severely over-appropriated basin.

Discussion between members and Mr. King continued regarding curtailment on existing wells taking place retroactively and the purchase of additional acre-feet of water.

There was further discussion between members regarding Recommendation Nos. 2-B and 3-A, and upon the request of the Chair, Ms. Keller recited the Nye County definition for new domestic wells.

MOTION: Assemblywoman Carlton moved to approve a BDR for Recommendation No. 2-B to provide that when a basin is designated either severely over-appropriated or as a CMA, and the State Engineer has ordered a curtailment by priority, only withdrawals from domestic wells for outdoor use would be curtailed with the exemption of allowing for the outdoor watering of pets and livestock. The motion was seconded by Senator Ford and passed unanimously.

MOTION: Assemblywoman Carlton moved for approval of Recommendation No. 3-A. The motion was seconded by Senator Ford and passed unanimously.

5. **Request the drafting of a bill** to allow for de minimus rainwater collection for domestic use or wildlife guzzlers (*Discussion with Jason King, P.E., State Engineer, DWR, SDCNR, at July 11, 2016, meeting in Pahrump.*)

MOTION: Assemblywoman Carlton moved for approval of Recommendation No. 5. The motion was seconded by Senator Hardy and passed unanimously.

MOTION: Assemblywoman Carlton moved to withdraw her previous motion for approval of Recommendation No. 5, noting she will bring the recommendation forward under a personal BDR. The motion was seconded by Senator Hardy and passed unanimously.

C. Basin Management

6. **Request the drafting of a bill** to provide that metering is required on all users in the State. (*Southern Nevada Water Authority [SNWA]; Utilities Inc. Subcommittee discussion with Jason King, P.E., State Engineer, DWR, SDCNR, at July 11, 2016, meeting in Pahrump [and others].*)

Chair Goicoechea commented meters may be required by the State Engineer on any permitted water application and declared no action would be taken on the recommendation.

7. **A. Request the drafting of a bill** to clarify that the Office of the State Engineer is authorized to utilize adaptive management approaches to mitigate potential conflicts. According to proponents, current law (NRS 533.3705) allows the Office of the State Engineer to limit the initial use of water under a permit to a quantity that is less than the total amount approved under the application and provides that the use of an additional amount of water may be authorized by the Office of the State Engineer at a later date if additional evidence demonstrates to the satisfaction of the Office of the State Engineer that the additional amount of water is available and may be appropriated in accordance with Nevada water law.

This proposed revision to the water law would expand that authority to include adaptive resource management, which provides for additional monitoring and management in the use of water, and provides for augmentation or mitigation to avoid conflicts with existing rights in order to maximize the beneficial use of a shared and limited resource. (See NRS 533.3705) (SNWA; *Jason King, P.E., State Engineer, DWR, SDCNR*, see WSD, Tab F.) ([Agenda Item IV](#))

B. Alternatively, request the drafting of a bill to provide that the Office of the State Engineer may not utilize adaptive management approaches to mitigate potential conflicts. According to proponents, the Office of the State Engineer's proposed amendment to Subsection 2 of NRS 533.370 should be opposed for a number of reasons, including that the existing "no conflict" requirement in Subsection 2 of NRS 533.370 protects a senior water right holder from potential destruction of an already existing water right, and there is no guarantee a promised mitigation plan will keep a senior water rights holder whole. (This recommendation combines concepts received by Eureka County, see WSD, Tab H; *Central Nevada Regional Water Authority [CNRWA]*; see WSD, Tab G, *HRWBA*; see WSD, Tab A; *Great Basin Water Network [GBWN]*, see WSD, Tab I.) ([Agenda Item IV](#))

MOTION: Senator Ford moved approval of Recommendation No. 7-A. The motion was seconded by Senator Hardy.

Prior to a vote, Mr. King divulged this recommendation is tied to a Monitoring, Mitigation, and Management (3M) Plan previously approved and subsequently reversed by the Nevada Supreme Court.

Discussion was held between several members, Jake Tibbitts, Natural Resources Manager, Department of Natural Resources, Eureka County, and Steve Bradhurst, Executive Director, Central Nevada Regional Water Authority, who both noted support for the 3M Plans.

MOTION: Senator Ford retracted his previous motion to approve Recommendation No. 7-A, noting a personal BDR will be brought forward.

8. **Include a position statement** in the final report to acknowledge surface-groundwater connectivity and the need for the Office of the State Engineer to utilize conjunctive

management of surface water and groundwater resources where connected. (*This recommendation combines concepts in recommendations received by the Office of the State Engineer, CNRWA, The Nature Conservancy, GBWN, Pershing County Water Authority, and others.*)

MOTION: Senator Hardy moved to approve Recommendation No. 8. The motion was seconded by Assemblyman Oscarson, and Chair Goicoechea directed a position statement be included in the Subcommittee's final report.

9. **Request the drafting of a bill** to require the claimant of a prestatutory water right to submit proof of the claim to the Office of the State Engineer on or before December 31, 2025, regardless of whether an adjudication has been ordered for a water source. If the claimant fails to submit such proof, the claim is deemed to be abandoned. According to proponents, the intent is to ensure that the Office of the State Engineer will have a correct accounting of groundwater and surface water rights in a basin, including vested water rights. (CNRWA, see WSD, Tab G.) ([Agenda Item IV](#))

MOTION: Senator Hardy moved to approve Recommendation No. 9. The motion was seconded by Assemblywoman Carlton and passed unanimously.

10. **Include a position statement** in the final report recommending a statewide Nevada water future discussion and strategy. Include a statement in the Subcommittee's final report encouraging the executive branch of the State government, the Nevada Legislature, Nevada's local governments, Nevada's business community, the environmental community, and the public to come together in a partnership to discuss Nevada's water future, develop a Nevada water future strategy, and utilize the work of the Legislative Commission's Subcommittee to Study Water, the Governor's Drought Summit, and the Nevada Drought Forum as a foundation for a meaningful statewide water future discussion and strategy. (CNRWA, see WSD, Tab G.) ([Agenda Item IV](#))

MOTION: Assemblywoman Carlton moved to approve Recommendation No. 10. The motion was seconded by Assemblyman Oscarson and passed unanimously.

11. **Include a position statement** in the final report calling for local government land-use plans to be based on identified sustainable water resources. According to proponents, many local government land-use plans have been developed without consideration of the amount and source of water needed to implement the plans. Such plans create property owner expectations that cannot be supported by available water resources. (CNRWA, see WSD, Tab G.) ([Agenda Item IV](#))

MOTION: Senator Hardy moved approval of Recommendation No. 11. The motion was seconded by Assemblyman Oscarson and passed. Assemblywoman Carlton voted no.

12. **Send a letter** to the Office of the State Engineer recommending the use of the independent and peer-reviewed United States Geological Survey (USGS), U.S. Department of the Interior, estimates of a basin's groundwater resources (sustainable water resources or perennial yield) instead of using a water right applicant's estimate of a basin's groundwater resources. Where an updated estimate of a basin's groundwater resources is required, as a result of an application or applications to transfer a substantial amount of groundwater from one basin to another basin, the applicant should provide funds to the Office of the State Engineer to pay for the update, and the update should be performed by the USGS. (CNRWA, see WSD, Tab G.) ([Agenda Item IV](#))

Chair Goicoechea declared no action would be taken on the recommendation.

13. **Include a position statement** in the final report recommending the Office of the State Engineer replace the perennial yield concept of groundwater availability with a sustainability concept for groundwater development and management. According to proponents, a sustainability concept would provide a determination of acceptable capture of groundwater discharge, as opposed to maximum capture of all groundwater discharge. (*This recommendation combines concepts received in recommendations from CNRWA, see Tab G; The Nature Conservancy, see Tab J; and GBWN, see WSD, Tab I.*) ([Agenda Item IV](#))

Chair Goicoechea declared no action would be taken on the recommendation.

14. **Request the drafting of a bill** to authorize the Office of the State Engineer to suspend cancellation and forfeiture of water rights under the "use it or lose it" doctrine during times of drought in severely over-appropriated basins or designated CMAs. According to proponents, the "use it or lose it" doctrine provides a disincentive for the conservation of water. (*This recommendation combines concepts in recommendations received by UICN, Pahrump Utility Co. Inc., and Desert Utilities Inc., see WSD, Tab D; Jason King, P.E., State Engineer, DWR, SDCNR, Winnemucca Farms; and Joe Ratliff.*) ([Agenda Item IV](#))

MOTION: Senator Hardy moved to approve Recommendation No. 14.

Assemblyman Oscarson acknowledged a similar personal BDR and his willingness to work with the appropriate entities.

MOTION: Senator Hardy retracted his previous motion for approval.

Chair Goicoechea declared no action would be taken on the recommendation.

15. **Include a position statement** in the final report supporting the Office of the State Engineer's use of flexible and innovative tools for managing over-appropriated basins and in approving Groundwater Management Plans (GMPs). (*This recommendation combines concepts in recommendations received by Jason King, P.E., State Engineer, DWR, SDCNR, SNWA, the Diamond Valley Groundwater Management*

Plan Advisory Board (DVGMPAB), The Nature Conservancy, Walt Kuver, Board Member, Basin 162 Groundwater Management Advisory Committee, and others.

Chair Goicoechea declared no action would be taken on the recommendation.

16. **Request the drafting of a bill** to authorize the implementation of a GMP that converts existing water rights to a credit system. According to proponents, the system would have priority built in to provide senior rights that would receive more water than junior rights. (See Subsection 7 of NRS 534.110, NRS 534.037, and NRS 534.120). Background: Diamond Valley, Basin 153, is the only basin in the State to be designated as a CMA. A GMP is being developed for the Diamond Valley and stakeholders are considering use of a credit system. (*The DVGMPAB and the Diamond Natural Resources Protection and Conservation Association*, see WSD, Tab K.) ([Agenda Item IV](#)) (*Statutory authorization of “unbundled market-based pilot projects” was also recommended by The Nature Conservancy and Winnemucca Farms.*)

Jake Tibbitts, previously identified, presented language submitted by the DVGMPAB for consideration ([Agenda Item IV A](#)) which was discussed by several members, Mr. Tibbitts and Mr. King.

MOTION: Senator Hardy moved to approve Recommendation No. 16 as clarified in the recommendations by DVGMPAB ([Agenda Item IV A](#)), including striking the word “credit” from the recommendation. The motion was seconded by Assemblyman Oscarson and passed. Senator Ford and Assemblywoman Carlton voted no.

17. **Request the drafting of a bill** to clarify that an approved GMP applies to all water users in basin. (*UICN, Pahrump Utility Co. Inc., and Desert Utilities Inc.*, see WSD, Tab D.) ([Agenda Item IV](#))

Chair Goicoechea suggested merging this recommendation with Recommendation No. 16.

Senator Ford supported merging Recommendation No. 17 with Recommendation No. 16, but continued to be unsupportive of Recommendation No. 16.

MOTION: Senator Hardy moved to approve merging Recommendation No. 17 with Recommendation No. 16. The motion was seconded by Assemblyman Oscarson and passed. Assemblywoman Carlton voted no.

D. Mine Dewatering

18. **Request the drafting of a bill** to require owners of mining pit lakes to secure water rights for mining pit lake evaporative loss. (*HRBWA, Pershing County Water Conservation District [PCWCD]*.)

Alan Biaggi, Nevada Mining Association (NMA), and Dylan Shaver, Vice President, NMA, discussed collaboration efforts with the Office of the State Engineer.

Chair Goicoechea declared no action would be taken on the recommendation.

19. **Request the drafting of a bill** to require temporary rights for mine dewatering be renewed every five years, with a required assessment of water used in the past five years and projections for future use. (*This recommendation combines concepts received from Great Basin Resource Watch [GBRW], Progressive Leadership Alliance of Nevada [PLAN], and PCWCD.*)

Members, Mr. Shaver, and Mr. King discussed the recommendation.

Chair Goicoechea declared no action would be taken on the recommendation.

20. **Draft a resolution** to require a long-term analysis of the Humboldt River Basin, including effects of mine dewatering, the filling of pit lakes and pit lake evaporation, and require that mine dewatering be included in the calculation of the basin budget. (*This Recommendation combines concepts received from GBRW, PLAN, see WSD, Tab L, and PCWCD.*) ([Agenda Item IV](#))

Chair Goicoechea, Mr. Biaggi, and Mr. King discussed the recommendation.

Chair Goicoechea declared no action would be taken on the recommendation.

AGENDA ITEM V—PUBLIC COMMENT

- Elizabeth McClure, previously identified, expressed concerns for landscape care during outside curtailment and new domestic well withdrawal limitations.
- Marti Perry, previously identified, discussed residents' rights to water.
- Joshua Childs, resident, Silver Springs, Nevada, added his concerns for landscape care during outside curtailment.
- Jim Gallagher, resident, Diamond Valley, Nevada, requested provisions for GMPs.
- Michelle Austin, previously identified, questioned how the 0.5 acre-foot limitation would affect commercial and urban areas versus domestic well owners.
- Mike Young, Professor, The University of Adelaide, Australia, proposed superimposing an additional system on top of existing water rights.

- Susan Lynn, Board Member, Great Basin Water Network, discussed concerns with 53 water basins at 200 percent or more of the perennial yield (PY) along with an additional 138 water basins that are at 90 percent of the PY.
- Bevan Lister, previously identified, commented on private domestic well owners' water rights hierarchy.
- Mark Moyle, resident, Eureka, Nevada, commended the Subcommittee and requested tools for CMA designations in Diamond Valley.
- Robert Klud, private citizen, supported Mr. Moyle's comments.
- Roger Elliott, resident, Fallon, Nevada, discussed overdevelopment concerns and affects to the watersheds and domestic wells.

AGENDA ITEM VI—FINAL COMMENT AND ADJOURNMENT

Chair Goicoechea provided final comments.

There being no further business to come before the Committee, the meeting was adjourned at 4:13 p.m.
