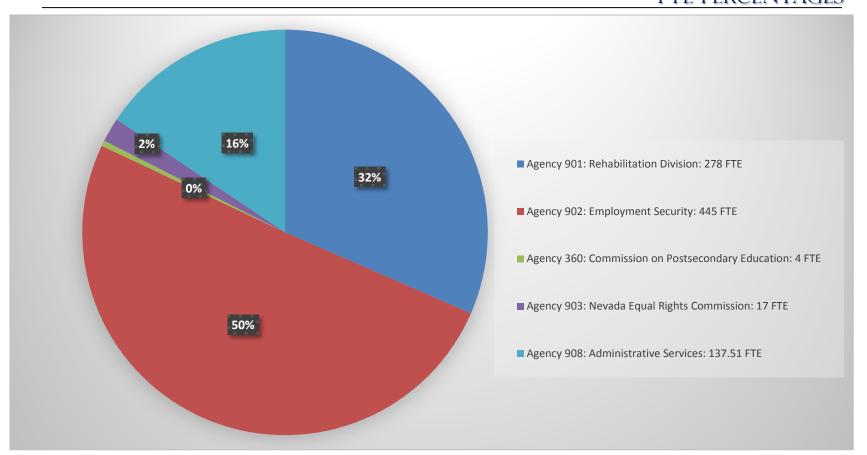
GOALS >>

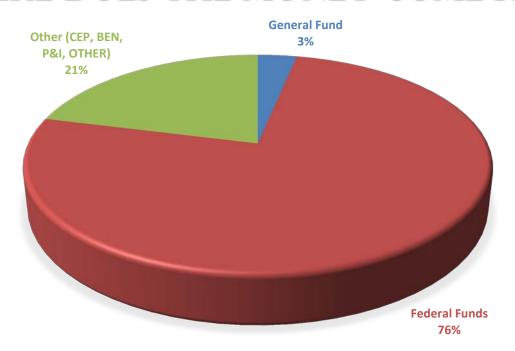

2017-2019 BIENNIUM FTE PERCENTAGES

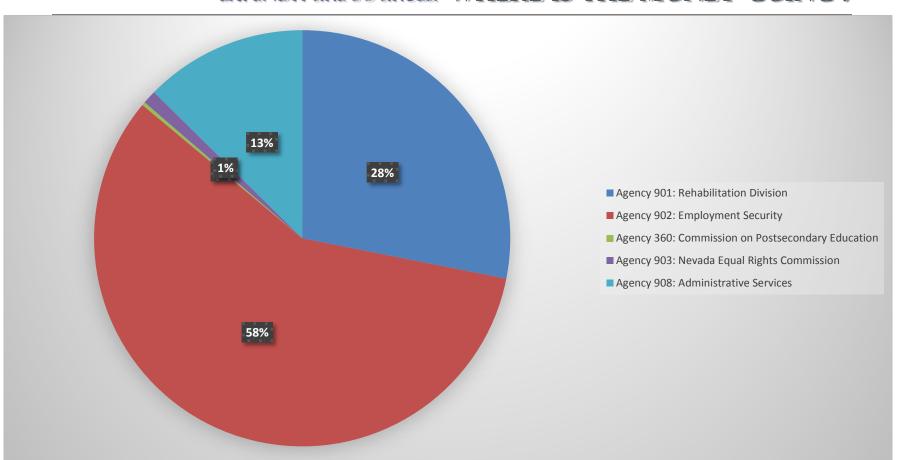


WHERE DOES THE MONEY COME FROM*?

MAJOR DEPARTMENT INITIATIVES REORGANIZATION

Employment Security will be separated into distinct budget accounts to provide transparency between Workforce Development and Unemployment Insurance. Workforce Development will be engineered to combine programs to hone their workforce development efforts.

Employment Security: Two Major Areas of Focus

Workforce Development

- ✓ **BUDGET ACCOUNT 4770:** Workforce Development will focus on employment services and workforce development:
- ✓ BUDGET ACCOUNT 4773: ABE administers adult workforce education and training programs

Unemployment Insurance

✓ BUDGET ACCOUNT 4771: Employment Security – Special Fund

✓ **BUDGET ACCOUNT 4772: UI** will focus on the **Unemployment Insurance** program

EMPLOYMENT SECURITY DIVISION

AGENCY 902

Administers programs that promptly pay unemployment benefits, promote an effective tax system, and improve the employment stability of those collecting unemployment insurance. The division operates a statewide labor exchange and provides training and re-employment services to Nevada workers, and recruitment services for Nevada employers.

WORKFORCE DEVELOPMENT

BA 4770: Workforce Development

- ✓ Integrated employment and workforce development services offered to businesses and job seekers through the *Nevada JobConnect* offices as part of the American Job Center network and expanded access to workforce development services as affiliates of the Workforce Innovation and Opportunity Act (WIOA) one-stop system.
- ✓ Provide direct labor exchange services to job seekers as partners in local area comprehensive one-stop offices.

BA 4773: Adult Basic Education

✓ Administers adult workforce education and training programs that provide English as a Second Language services and assist adults in obtaining a high school equivalency or diploma and basic skills for employment.

EMPLOYMENT SECURITY DIVISION AGENCY 902

UNEMPLOYMENT INSURANCE

BA 4772: Unemployment Insurance – New Budget Account

- ✓ Administers Unemployment Insurance (UI) Contributions and Benefits programs.
- ✓ Transfers the UI grant and related UI components to separate from Workforce Development.

BA 4771: Employment Security – Special Fund

- ✓ Special revenue fund generated from penalties, interest and forfeitures collected from employers for non/late payment of unemployment taxes, and from the recovery of penalties and interest from overpayments of benefits to claimants.
- ✓ Covers expenditures for which federal funds have been requested, but not yet received.
- ✓ Covers the cost to administer Employment Security laws that may not be charged against federal grants.
- ✓ All monies in the fund are continuously available to the division and do not lapse at any time.
- ✓ Used to support and/or maintain agency-owned buildings, and to pay for technological enhancements to programs for which federal funds are not available.
- Must be used for UI Administration.

MAJOR DEPARTMENT INITIATIVES REORGANIZATION

Employment Security Division

CHALLENGES

- 1) The **Unemployment Insurance Program** continues to face declining administrative funding overall from the federal government and must support the regular operation of the program with **Penalties and Interest** funds collected each year in order to maintain current levels of service and performance.
- As UI funding continues to contract, non-discretionary costs are increasing. Division leadership continues to look for new efficiencies and streamlining of operations. However, the use of resources has shifted since the implementation of Ulnv. For example, the ongoing expenses associated with maintaining the newly modernized and fully integrated benefits, tax and appeals system are higher than with legacy systems, and this has shifted the expenditure of resources away from staff and towards systems. Thus, the Division will have to direct benefit claimants and employers toward self-service, web-based services more and more in order to adapt to technologically dependent systems.
- 3) New **Workforce Development** programs are being transferred to DETR (e.g., Adult Education, Commission on Postsecondary Education) which will require a period of transition as DETR leadership becomes educated about the programs. Many details are yet unknown, and the organizational structure may require additional adjustment within DETR.

The UI grant continues to decline with the improved economy. It is necessary to eliminate 20 vacant FTE to address contracted funding in conjunction with the increase of non-discretionary costs.

✓ The division anticipates it will invoke the early call provision of the UI bonds and make final payment on the bonds on December 1, 2017. Beyond that date, the division will need a period of time to attempt to collect all remaining unpaid bond payments from delinquent employers and close the accounting function out for the bond collections. The number of bond FTE's will be reduced to 5 for the remainder of the biennium after payoff. Any additional funds collected will be deposited into the UI trust fund as required by statute.

REHABILITATION DIVISION AGENCY 901

Brings Nevadans together to promote barrier-free communities in which individuals with disabilities have access to opportunities for competitive, integrated employment and self-sufficiency.

BA 3268: Rehabilitation Administration

- ✓ Administers the activities of:
 - Bureau of Vocational Rehabilitation (BVR)
 - Bureau of Services to Persons who are Blind or Visually Impaired (BSBVI)
 - Blind Business Enterprise of Nevada (BEN)
 - Bureau of Disability Adjudication (BDA)
 - The overall leadership, direction, logistical support, and evaluation of the division's federal and state programs for competitive, integrated employment for individuals with disabilities

BA 3269: Bureau of Disability Adjudication (BDA)

- ✓ Provides quality, timely and professional disability benefits determinations to individuals in Nevada who claim benefits under the Social Security Disability programs.
- ✓ 100% federally funded by the Social Security Administration.
- ✓ Processes all applications for disability benefits under the Social Security Disability Insurance (SSDI) and Supplemental Security Income (SSI) programs.
- ✓ Conducts evidentiary hearings for those disability benefits applications who are appealing the denial of benefits, and those disability beneficiaries who are appealing the decision to terminate existing benefits.

REHABILITATION DIVISION

AGENCY 901 - CONTINUED

BA 3265: Bureau Vocational Rehabilitation (BVR)

- ✓ Serves individuals who have physical or mental impairments that present barriers to employment, and assists those individuals in preparing for, obtaining and retaining meaningful competitive, integrated employment.
- ✓ Approximately 78.7% federally funded.
- ✓ Administers the Supported Employment Program (Title VI of the Rehabilitation Act), which expands employment options for individuals with the most significant disabilities who may be able to engage in competitive, integrated work through the provision of intensive training, supervision and other services.

BA 3254: Bureau of Services to Persons who are Blind and Visually Impaired (BSBVI)

- ✓ Provides a full range of services to persons who are blind, deaf/blind, or severely visually impaired, which include:
 - Low vision examinations and aids, mobility evaluation and training, evaluation for and purchase of assistive technology, vocational evaluation and career exploration, vocational training, job readiness training, and assistance in obtaining competitive, integrated employment.
 - Approximately 84% federally funded.

BA 3253: Blind Business Enterprise of Nevada (BEN)

- ✓ Provides entrepreneurial opportunities for individuals who are blind or visually impaired in priority-of-right locations in public buildings, statewide, for food and beverage services, vending machines, and/or gifts and sundries.
- ✓ Administers the business enterprise account under the authority of the *Randolph-Sheppard Act* (1974, as amended).
- ✓ Fully self-funded program.

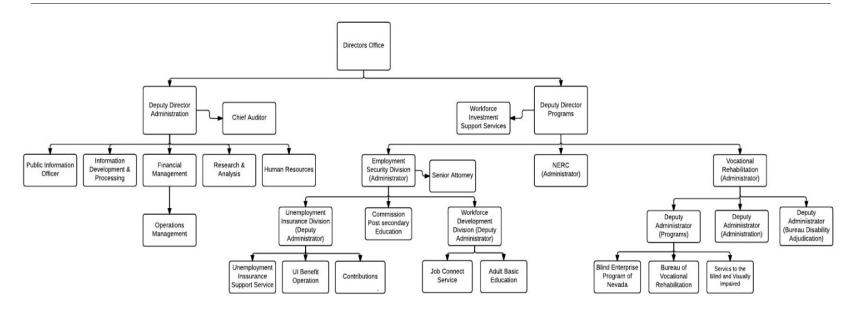

APPENDIX A NEVADA'S *CURRENT* ECONOMIC OUTLOOK

Numerous economic indicators point to the continuation of a **stable**, **broad-based** and **diversified** recovery. Because Nevada's economy remains reliant, in part, on consumer sentiment and willingness to spend disposable income, our recovery is only as strong as a national and international one.

Current projections call for job growth approximately **3%+** per year through the end of the next biennium. This should continue to put downward pressure on the unemployment rate, which is currently at **5.1%**.
