CASE SUMMARY & PANEL DECISION

NCCI Case No: 19247

<u>Meeting Information:</u> The workers compensation classification dispute of Hardy Development was heard by the Nevada Appeals Panel for Industrial Insurance (Panel) on Wednesday, August 22, 2012, at the Hilton Garden Inn, Las Vegas, Nevada.

Carrier: Liberty Mutual, Policy # WC 539S307931020, Effective 11/11/10-11

Nature of Business: Construction Contractor

Classifications under Review:

- Code 5606—CONTRACTOR—PROJECT MANAGER, CONSTRUCTION EXECUTIVE, CONSTRUCTION MANAGER OR CONSTRUCTION SUPERINTENDENT
- Code 5403—CARPENTRY NOC

<u>Issue in Dispute:</u> Liberty Mutual classified employee Eric Hardy (Eric) to the governing classification of the business, Code 5403. Hardy Development believes Eric is eligible for assignment to Code 5606.

<u>Summary of Insured's Position:</u> Agent Lloyd Cutler and business representative Merlin Hardy (Merlin) provided the following information:

- Hardy Development is a construction contractor that uses subcontractors to perform all construction work.
- Hardy Development employs three workers, a bookkeeper, Merlin and Eric.
- Eric is responsible for the construction jobsite, but does not direct the work of the subcontractors. Each subcontractor has their own jobsite foreman/supervisor.
- All subcontractors are licensed and have their own direct employees.
- Merlin advised the Panel that he reviewed his records to make sure all subcontractors had their own foreman to supervise the actual construction workers. He said he found an entry that was made by his bookkeeper that stated one of the subcontractors, First Choice Cleaning, had "No Employees sole proprietor Wayne Allen." Merlin stated that this is an incorrect statement by his bookkeeper. Wayne Allen was hired to perform construction cleanup at the jobsite. Wayne employed 4 to 5 employees of his own every time he went to the jobsite. Merlin stated that Wayne is an older gentleman who does little of the cleanup work himself. He supervises his own employees at each job site.
- Merlin confirmed to the Panel that all subcontractors had their own jobsite supervisor or foreman that directed the work of their employees and that Eric had no direct supervision of any construction worker

<u>Summary of Carrier's Position:</u> Louis Phillips represented Liberty Mutual and provided the following information:

• Code 5606 states that when a project manager exercises control through a subcontractor, each subcontractor must have a supervisor or foreman at the job site in order to permit the assignment of this classification. If any of the subcontractors do not have a job supervisor or foreman at any job site

- visited by the construction executive, the entire payroll of the construction executive for that policy year is assigned to the highest rated construction class code applicable. Based on the subcontract labor detail obtained during the audit, it appears the insured may use some sole proprietors such as Ivan Perez Ortiz, First Choice Cleaning-Wayne Allen, Robb's Concrete Pumping, etc.
- The financial records reviewed during the audit reported a number of smaller payment amounts to various subcontractors. The payment of small dollar amounts does not support the presence of a foreman/supervisor as well as direct labor employee(s) at the job site. For example, checks were written to AFC Fire Company for the amount of \$146, Security Plumbing for \$300, JL Paint for \$400, Diamond Concrete Cutting for \$167, Robb's Concrete Pumping for \$250, and Performance West Glazing for \$119.
- Eric is the only employee of Hardy Development on the job site. The audit worksheet states that Eric
 directly supervises subcontractors hired to complete the construction work. The information provided
 on the audit worksheet was provided by Merlin. The description of Code 5606 states that this code
 does not apply to any person that is directly in charge of actual construction work.
- In correspondence with Merlin, he refers to Eric as a "supervisor".
- Eric is the only individual employed by Hardy Development who is responsible for completion of all construction work.
- If Eric has no direct supervision of construction workers, Liberty Mutual would need additional records such as copies of invoices, work orders, contracts, and statements from the subcontractors that document that all subcontractors have a supervisor and a foreman overseeing the work completed by the subcontractor employee.
- Based on the information provided, it is the position of Liberty Mutual that Eric does not qualify for Code 5606 and is correctly classified to Code 5403.

Panel Discussion and Decision: The Panel discussed the following issues:

- It appears that Liberty Mutual's auditor did not pursue the issue of whether Eric qualified for Code 5606 sufficiently at the time the audit was completed. If Liberty Mutual needed additional documents to determine if Eric was eligible for Code 5606, these documents should have been requested at the time of the audit.
- Liberty Mutual did not provide convincing evidence that Hardy Development used sole proprietor subcontractors that had no employees of their own. It appears Liberty Mutual relied in part on a number of small payments made to subcontractors, stating that the small payment amounts indicate that only a single worker was on the job site. However, during the Panel meeting, Merlin stated that these small amounts were not the sum total of the amounts paid to these subcontractors. The small payments amounts were either the final payments for work performed or may have been payments for final punch list work needed to correct work after the job was completed. If the payments were for punch list work, Eric would not have been on the work site when this work was completed.

After further discussion, a motion was made, seconded and passed by majority vote and it was,

RESOLVED, That Eric Hardy is eligible for Code 5606 during the policy period in dispute.

Notice to Liberty Mutual

By copy of the Panel's decision, Liberty Mutual is notified to apply the Panel's decision to the disputed policy term of Hardy Development.

Right to Appeal

A party to the hearing who wishes to appeal a ruling of the Panel must do so pursuant to the provisions of NRSB.310. The commissioner of insurance will conduct such a hearing pursuant to the provisions of NRS 679B.310 to 679B.370 inclusive.
