JOHNSON WAS ACCEPTED INTO NDOC REHABILITATION PROGRAM "GETTING IT RIGHT" IN SEPTEMBER OF 2022.
JOHNSON WAS ACCEPTED INTO NDOC "HVAC - Vocational Program" IN SEPTEMBER OF 2022.

ON 01/17/23 JOHNSONS PEO/RELEASE DATE WAS MOVED UP TO 2/17/23

THE PAROLE BOARD ORDER GRANTING JOHNSON PAROLE WAS NOT RECEIVED BY OR ENTERED INTO NDOC COMPUTERS UNTIL MARCH 20th 2023

JOHNSONS RELEASE DATE/PEO MOVED UP TO 2/17/23 OR 3/5/23.

JOHNSON WAS GRANTED PAROLE ON FEBRUARY 16th 2023

NDOC Parole & Probation Staff did not procure the order granting JOHNSONS PAROLE (physical copy) until March 7th 2023. PER JOHN DOE

NDOC Caseworker, **DOE**, drafted JOHNSONS "Parole Board Packet" in October of 2022 for his upcoming Parole Hearing on 01/11/23. Due to JOHNSONS PEO (Parole Eligibility Date) as of October of 2022, being posted at 01/23/23

JOHNSONS PAROLE HEARING WAS HELD BY FEBRUARY 16th 2023

JOHNSONS RELEASE DATE MOVED UP TO 1/29/23 OR 2/8/23.

ON MARCH 27th 2023 **JOHN DOE** sent JOHNSONS ORDER BEING "GRANTED PAROLE" TO SOR and the "ORDER GRANTING PAROLE" WAS RECEIVED BY SOR ON MARCH 15th 2023

JOHNSON COMPLETED "GETTING IT RIGHT"

JOHNSON COMPLETED HVAC ON 12/13/22

ON 01/11/23 NDOC Parole & Probation Staff **DOE** informed JOHNSON that SOR would take anywhere from 1 to 2 1/2 months to assess him (1/11/23) - 6/11/23

JOHNSON INFORMED **DOE** IN OCTOBER OF 2022 THAT HIS PAROLE HEARING DATE SHOULD BE MOVED UP TO DECEMBER OF 2022 BECAUSE THE DAYS THAT HE WILL EARN FOR HVAC AND "GETTING IT RIGHT" WILL MOVE HIS RELEASE DATE (PEO) INTO BETWEEN JANUARY 28, 2023 - MARCH 15th 2023. **DOE** SAID HE DOESN'T CONTROL HEARING DATES.

ON 01/11/23 NDOC Parole & Probation Staff **DOE** informed JOHNSON THAT SOR COMPLETES HIS ASSESSMENT WHEN THEY WILL SEND IT TO PAROLE & PROBATION AND THEY COULD PROCESS JOHNSONS RELEASE PLAN THAT COULD TAKE UP TO 2 WEEKS TO A MONTH (1/11/23). EVEN THOUGH JOHNSONS RELEASE DATE/PEO IS 1/29/23, JANUARY 29th 2023

JOHNSONS PAROLE HEARING DATE WAS NEVER MOVED CLOSER

IN NOVEMBER OF 2022, **ANDOC PRISON OFF. DOE, (JOHN D. BEST)** GMD, Attorney General's Office, and the Northern and Southern Parole Board of the state moved my Parole Hearing Date up to December of 2022 because the days HE will earn for HVAC and "Getting it Right" will move his PEO up to Jan 2023
