**NOTICE OF WORKSHOP TO SOLICIT PUBLIC COMMENTS ON PROPOSED  
PERMANENT REGULATIONS**

The Division of State Parks will be conducting a workshop to solicit comments from interested person regarding the potential adoption of regulations that pertain to Chapter 407 of the Nevada Administrative Code.

**Thursday, May 20, 2021 at 1:00 p.m.**

**\* This meeting will be held via teleconference only. \***

**Pursuant to Governor Sisolak's March 22, 2020, Declaration of Emergency Directive 006, Directive 018 (5/7/2020), Directive 021 (5/28/2020), the requirement contained in NRS 241.023(1)(b) that there be a physical location designated for meetings of public bodies where members of the public are permitted to attend and participate is suspended in order to mitigate the possible exposure or transmission of COVID-19 (Corona Virus). Accordingly, anybody planning to participate in the meeting must participate by using the teleconference number.**

The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

1. Proposed revisions to NAC 407 related to State Parks and other recreational areas including:
  - *Replaces the term “park” with “unit” to include other areas of jurisdiction of the Division of State Parks, including Regional Offices and Division Headquarters.*
  - *Establish fees for use of Group Lodging.*
  - *Updates provisions pertaining to limitations on Annual Permits.*

- *Updates fee schedule for All Access Permit Fees, Annual Permit Fees, and establishes a non-resident entrance fee (reflected temporary regulation T005-20, adopted 2/19/2021)*
- *Clarifies that a refund policy does not apply for infractions.*

NRS 407.0475 (1) Provides authority for the Administrator of Division of State Parks to adopt regulations necessary to lawfully carryout the provisions of this chapter. A copy of the proposed regulation changes may be obtained at the workshop or by contacting the Division of State Parks, 901 S. Stewart Street #5005, Carson City, Nevada 89703.
