DISCIPLINARY ACTION REPORT

Jeffrey Fine, DC, License No. B-449 - effective March 9, 2003

Dr. Fine entered into an Agreed Settlement of Disciplinary Action in which he has stipulated to violations of NRS 634.018(10) and/or NRS 634.018(11), including the act found at NAC 634.430(1)(e)(1), by billing an insurance company for treatment not received by the patient. Dr. Fine has agreed to pay a fine in the amount of \$2,000.00 and to attend 24 hours of continuing education within 24 months, of which 12 hours during the first 12 months will be on the subject of record keeping and 12 hours during the second 12 months will be on the subject of physical therapy. These hours will not count toward his continuing education requirements for license renewal.

Michael Handelman, DC, License No. B-861 - effective March 9, 2003

Dr. Handelman entered into an Agreed Settlement of Disciplinary Action in which he has stipulated to violations of NRS 634.018(10) and/or NRS 634.018(11), including the act found at NAC 634.430(1)(e)(1), by billing an insurance company for treatment not received by the patient. Dr. Handelman has agreed to pay a fine in the amount of \$2,000.00 and to attend 24 hours of continuing education within 24 months, of which 12 hours during the first 12 months will be on the subject of record keeping and 12 hours during the second 12 months will be on the subject of physical therapy. These hours will not count toward his continuing education requirements for license renewal.

Mark Rubin, DC, License No. B-648 - effective March 9, 2003

Dr. Rubin stipulated to having been convicted of a felony for filing a false claim for insurance benefits in violation of NRS 686A.291(1)(b). The CPBN found that Dr. Rubin's conduct is a violation of NRS 634.018(6) and/or NRS 634.018(10) and/or NRS 634.140(2)(b) and ordered that Dr. Rubin be ordered to pay the Board's costs in this matter.
