Andrew C. Kidder, DC - License No. B971 - Effective March 13, 2004

Dr. Kidder entered into an Agreed Settlement of Disciplinary Action in which he has stipulated to violations of NAC 634.435(1)(a) and NAC 634.435(1)(c) for substandard record keeping and NRS 634.018(10), unprofessional conduct, for conduct unbecoming a person licensed to practice chiropractic or detrimental to the best interests of the public. Dr. Kidder was placed on probation for 2 years during which he must hire a compliance officer to monitor the licensing of staff, supervision of employees and patient record keeping and billing practices, and submit to random checks of his patient records. Dr. Kidder was assessed the board's costs in an amount not to exceed \$2,500 and he must attend 12 hours of continuing education in the subject of record keeping or office management.

Eric P. Osgood, DC - License No. B525 - Effective March 13, 2004

Dr. Osgood entered into an Agreed Settlement of Disciplinary Action in which he has stipulated to violations of NAC 634.435(1)(a) and NAC 634.435(1)(c) for substandard record keeping and NRS 634.018(10), unprofessional conduct, for conduct unbecoming a person licensed to practice chiropractic or detrimental to the best interests of the public; violation of NRS 634.018(15), unprofessional conduct, for employing and utilizing unregistered chiropractor's assistants; and violation of NAC 634.430(1)(e)(2) for authorizing other chiropractors to perform chiropractic services and bill patients and insurance carriers under his name, address and tax identification number in a manner which does not accurately state the nature of the chiropractic services that were performed and NRS 634.018(5), unprofessional conduct, for willful disobedience of the law, or of the regulations of the State Board of Health or of the Chiropractic Physicians' Board of Nevada. Dr. Osgood's license was suspended with the suspension stayed and he was placed on probation for 4 years during which he must hire a compliance officer to monitor all aspects of his chiropractic practice including, but not limited to, patient records, bills prepared and submitted to patients and insurance companies, employee pay histories, employment records and any other documentation relating to billing practices, patient care, office policy or office management. Dr. Osgood was assessed the board's costs in an amount not to exceed \$7,000 and fined \$8,000, and he is required to attend 24 hours of continuing education in the subjects of record keeping, office management, insurance billing or ethics.

Wade A. Taylor, DC - License No. B1008 - Effective March 13, 2004

Dr. Taylor entered into an Agreed Settlement of Disciplinary Action in which he has stipulated to violations of NAC 634.435(1)(a) and NAC 634.435(1)(c) for substandard record keeping and NRS 634.018(10), unprofessional conduct, for conduct unbecoming a person licensed to practice chiropractic or detrimental to the best interests of the public. Dr. Taylor was placed on probation for 2 years during which he must hire a compliance officer to monitor the licensing of staff, supervision of employees and patient record keeping and billing practices, and submit to random checks of his patient records. Dr. Taylor was assessed the board's costs in an amount not to exceed \$2,500 and he must attend 12 hours of continuing education in the subject of record keeping or office management.
