DISCIPLINARY ACTION REPORT

Disciplinary action has been taken by this Board, as follows:

Scott D. Kipling, DC - License B-382 - effective December 14, 2003

Dr. Kipling entered into an Agreed Settlement of Disciplinary Action in which he has stipulated to violations of NRS 634.140(1) for unprofessional conduct, NRS 634.018(10) for conduct unbecoming a person licensed to practice chiropractic or detrimental to the best interests of the public and NAC 634.430(1)(a) and (3)(a) by engaging in sexual relations between himself and a patient. Dr. Kipling's license was suspended for three months with the suspension stayed and his license was placed on probation for two years. Dr. Kipling was assessed the board's costs in the amount of \$2,095.49, he is required to attend and complete a continuing education course on boundary training within 90 days, his license will be marked "RESTRICTED" throughout the probationary period and he may not render any treatment to a female patient unless a female on his staff is on the premises.
