DISCIPLINARY ACTION, SECOND QUARTER 2006:

CASE NUMBER: 20050516

RESPONDENT: Lynn H. Affleck, P.E. 7676
COMPLAINANT: Ted Morhardt, Jr.
ALLEGATION/S: Alleged violation of NRS 625.
SUMMARY: Prepared incomplete plans, made errors in his engineering services that provided for a roof detail and west wall of the Morhardt residence.

STATUS: Decision and Order to 1) suspend his license for a period of two years, with the suspension stayed, and probation imposed for the same two-year period; 2) complete an engineering design that resolves the structural deficiencies affecting the residence within 90 days; 3) submit reports to the State Board setting forth the nature and scope of the work performed by him during the term of his probation; 4) work involving structures is to be reviewed by a licensed civil or structural engineer; 5) successfully complete a university level course in structural engineering which emphasizes wood or heavy timber design; 6) pay within 30 days an administrative fine in the amount of \$3,500; and 7) reimburse within 30 days the State Board its investigative costs in the amount of \$2,500.

STATUS: Accepted a stipulated agreement to surrender his Nevada Engineer Intern certificate; to accept a public reprimand; and to not apply to take any professional engineering examination in Nevada or apply for an Engineer Intern Certificate for a period of not less than five years.
