The following is disciplinary action taken by the Hearing Aid Specialist Board:

January – April 2001 - None

May - August 2001 - #00-08-001 - Hearing Aid Specialist was directed

to refund money for the hearing aids to the

consumer.

#01-01-008 - Hearing Aid Specialist was directed to refund the money for the hearing aids minus the

fitting fee to the consumer.

September – December 2001 - #01-06-023 – Hearing Aid Specialist directed to

refund money to consumer as the order was

cancelled within 5 working days.

#01-06-033 - Hearing Aid Specialist directed to refund to consumer as the refund was requested

within 30 days.

January - April 2002 - #01-11-039 - Hearing Aid Specialist directed to

refund to consumer and the consumer to not pay the

loaner fee.

May – August 2002 - None. Many complaints referred for further

investigation.

September – December 2002 - #02-05-043 – Letter sent to Hearing Aid Specialist

warning of future disciplinary action if information was not provided to the Board within five working

days.

January – April 2003 - None.

May – August 2003 - None. Complaints referred for further investigation.

September – December 2003 - #03-10-059 – Hearing Aid Specialist directed to refund to the Consumer minus the fitting fee. #01-06-033 – Hearing Aid Specialist refunded to

Consumer in a settlement agreement.

#03-09-056 - Hearing Aid Specialist refunded money to the consumer via a credit card credit.

January - April 2004 - None. The Board did not hold a meeting during this

quarter due to scheduling conflicts, but will be

meeting on April 17, 2004.
