## **Re: Nevada State Board of Landscape Architecture Quarterly Report Quarter Ending 12-31-07**

Dear Mr. Malkiewich:

The Nevada State Board of Landscape Architecture has four cases under investigation:

Case Numbers: 06-32; 07-39; 07-41; 07-42

The Board conducted an open session to review character, alleged misconduct, professional competence or physical or mental health of (07-39) Terry Sherman an alleged non-registered individual. The Board found unanimously that Mr. Sherman has practiced Landscape Architecture in the State of Nevada without being registered. The Board in seeking compliance with NRS and NAC Chapter 623.A imposed the following resolution and penalty:

1. The Plantscapes website must be removed immediately.
2. A \$2000. fine was levied. The fine was suspended for a period of 6 months pending no additional complaints of practicing Landscape Architecture during that period.
3. Mr. Sherman will provide monthly progress reports to the Board.
4. Mr. Sherman was encouraged to contact local Enforcement Field Investigation Officers for the Board for clarification of the Nevada Revised Statutes and Nevada Administrative Code as needed.

Additionally the Board has opened up cases for the enforcement of inappropriate advertising in the Telephone Book Yellow Pages for multiple parties as they are discovered.

These matters are confidential pursuant to statute until the Board approves filing an administrative complaint.
