Dear Mr. Malkewich:

Pursuant to compliance with NRS 622.100, this board has taken one disciplinary action against one Nursing Facility Administrator, Lynn Christensen, NFA License Number 307, during the past fiscal quarters – July 1, 2002 through March 31, 2004. A public hearing was conducted on August 20, 2003 for a Complaint where the licensee was found guilty of 3 counts of the Complaint by the Board and was placed on probation for 2-year period; repayment of legal costs and 16 hours of elder abuse classes through the State's Ombudsman Office. The terms of the settlement have not been finalized to date.

Additionally, enclosed is a copy of the Quarterly Summary and Comparison report of Licensee Activity for the three quarters of fiscal 2003 – 2004.

This board meets quarterly. The last meeting was held on February 26, 2004. The next meeting is scheduled for May 11, 2004.

Our next quarterly report will be sent to your office at the close of the fourth quarter of fiscal 2003 – 2004.
