
Additionally, enclosed is a copy of the Quarterly Summary and Comparison report of Licensee Activity for the second quarter of fiscal 2004 – 2005.

**SUMMARY
OF DISCIPLINARY ACTIONS**

February 1, 2005:

Peterson C. Durias, Residential Facility Administrator, License # 6083, was brought before the Board for a Complaint consisting of two (2) counts:

Count One – Mr. Durias was issued five licenses by the Nevada State Board of Examiners of Long Term Care administrators, one being the original license, number 6083, and secondary licenses numbered 6083-A, B, C and D. Mr. Durias was the administrator for eight (8) facilities concurrently in the recent past, operating more facilities than allowed by regulation, in violation of NAC 654.250(2) and was grounds for disciplinary action pursuant to NRS 654.190(e).

Count Two – NAC 654.190 provides “each person licensed a nursing facility administrator or an administrator of a residential facility for groups shall display his original license in a conspicuous place in his office or place of business or employment.”

Mr. Durias had posted copies of his license at three (3) different facilities other than the facility for which original was obtained. Mr. Durias violated NAC 654.190, providing grounds for disciplinary action.

Mr. Durias entered a Motion To Enter Into A Compromise. As a result, the Board of Directors’ decision was to fine Mr. Durias \$100.00 for each of the facilities in excess of the allowable facilities and to pay the costs of the investigation, proceedings and legal fees within 90 days.

Mr. Durias was not represented by an attorney.

February 1, 2005:

Pamela A. Smith, Residential Facility Administrator, License #5620, was brought before the Board for a Complaint consisting of two (2) counts:

Count One - Alleged that Ms. Smith operated more than five (5) facilities at the same time and had been the administrator for up to nine (9) facilities concurrently in the recent past. Pamela A. Smith had engaged in conduct that constituted a violation of NAC 654.250(2) and was grounds for disciplinary action pursuant to NRS 654.190(e). The Board of Directors found Pamela A. Smith guilty of Count One.

Count Two – Alleged that Ms. Smith had posted copies of license 5620 at six (6) and possibly seven (7) different facilities other than the facility for which the original was obtained, violating NRS 654.190(1)(e) and NAC 654.190. The Board of Directors found Pamela A. Smith guilty of Count Two.

The Board ordered that Ms. Smith be:

- Publicly reprimanded;
- Apply to the Board for appropriate secondary license;
- Pay a fine of \$700.00;
- Pay cost of investigation, proceedings and legal fees within 90 days.

Ms. Smith was not represented by an attorney.
