RE: DISCIPLINARY ACTIONS TAKEN/LICENSEE ACTIVITY REPORT

Dear Mr. Malkewich:

Pursuant to compliance with NRS 622.100, this board has taken one disciplinary action against one Nursing Facility Administrator, Lynn Christensen, NFA License Number 307, during the past fiscal quarters - July 1, 2002 through June 30, 2004. A public hearing was conducted on August 20, 2003 for a Complaint where the licensee was found guilty of 3 counts of the Complaint by the Board and was placed on probation for 2year period; repayment of legal costs and 16 hours of elder abuse classes through the State's Ombudsman Office.

Ms. Christensen and her attorney have agreed to the terms of the settlement in which Ms. Christensen's license is on probation for 2 years commencing August 20, 2003 to August 20, 2005 and the restitution of legal fees in the amount of \$11, 920.68, payable effective June 30, 2004 on a monthly basis, until paid in full and the 16 hours of elder abuse classes through the State's Ombudsman Office.

Additionally, enclosed is a copy of the Quarterly Summary and Comparison report of Licensee Activity for the four quarters of fiscal 2003 - 2004.

This board meets quarterly. The last meeting was held on May 11, 2004. The next meeting is scheduled for August 10, 2004

Our next quarterly report will be sent to your office at the close of the first quarter of fiscal 2004 - 2005.
